# Leading to a Lead-free Water Supply

adopting a labelling system similar to that for food packaging is among the many ideas suggested for avoiding a repeat of last year's high-profile lead-contamination water supply scandal.

Concerns over the safety of drinking water were raised last summer by the media's exposure of excessive levels of lead in water samples taken from several public housing estates. The ensuing scandal focused public attention on the Housing Department's supervision of construction projects, as well as placed the role of the professional staff, contractors and licensed plumber involved under scrutiny.

In late October, the Task Force on the Investigation of Excessive Lead Content in Drinking Water submitted its final investigation to the Secretary for Development, Mr Paul Chan. The report concluded that excess lead in drinking water in Kai Ching Estate and Kwai Luen Estate Phase 2 was caused by the use of leaded soldering materials in the solder joints. To prevent a recurrence of such incidents, the Task Force made a number of recommendations to prevent the use of leaded soldering materials and non-conforming pipes and fittings. It also recommended that the Water Authority explore the use of piping materials that did not use lead soldering joints in its plumbing works, that the relevant legislation be reviewed, and that the Housing Authority

(HA) consider adopting a central procurement system for soldering materials. Chan said the Development Bureau agreed with the report's findings and would actively study and follow up on the recommendations.

Another recommendation in the report was that the contractors involved in the scandal should be barred from taking part in tenders for future government projects for up to nine months. Sr Samson Wong, a past President of HKIS, building surveyor, member of the HKIS's Property and Facility Management Division, and chairman of project management committee thinks that this measure may have a serious impact on main contractors because they would not be allowed to bid for large projects initiated by the HA. "Those companies specialising in water plumbing systems should conduct an overhaul of their systems. The industry as a whole should enhance its awareness of this contaminated water problem."

Sr Phyllis So, a solicitor, a member of the Quantity Surveying Division and a member of the Advisory Committee on Water Resources and Quality of Water Resources, said such a move would be a regulatory action implemented by the HA based on its contractor management system. "It does not involve public law...for [the] HA, the implication is that this will not be subject to judicial review."

Using the Waterworks Ordinance as the starting point, the lead contamination occurred within the realm of "Inside Service" [CAP 102 Waterworks Ordinance]. This meant it was in the branch pipes inside the premises supplying water to individual units, so the liability lies with the consumer and agents or licenced plumbers as defined under the Waterworks Ordinance."

Because soldering materials containing lead are widely available on the market, Wong said the government should get to the root of the problem. "The current situation is similar to the industrial use of asbestos, which has been banned by law." Wong compared the situation to that for food provision, for which legislation exists to require labels on product packaging to clearly state whether some materials should not be used for certain purposes. "I think the government can first implement this through executive action and then proceed to legislation for the long term...Product package labeling

can be used as a direct warning against the application of lead-containing solder[ing] materials to drinking water pipes."

The incident has pushed the industry to update its knowledge of current building specifications. While many documents already provide such specifications, some industry insiders have neglected to gain a full understanding of their details. "The industry should pay closer attention to the latest developments in other countries, so as to update their knowledge," Wong suggested. "Lead-contaminated drinking water problems have arisen in other countries and many have taken measures to eliminate them, such as through regular tests and replacing problematic pipes with conforming ones."

Regarding the recommendation that the HA adopt the central procurement of soldering materials, Wong believes that other developers and construction companies can take this measure as a reference for their own projects and that as members of the building profession, many surveyors are involved in project management and have an overall picture of project, which they can use to provide early warnings to the industry. "It is risk management...we can help identify possible problems early. Building surveyors can also be involved in updating [people's] knowledge of changes in [the] building materials available on the market. We can also play a bigger role [during the] post-occupancy evaluation. For instance, [based on the needs of individual buildings], we can recommend regular tests and help garner feedback from residents. We can also check if [the] heavy metal content increases when new materials have been used. Many countries have implemented post-occupancy evaluations. It is vital to get feedback from residents, particularly for buildings constructed with new materials and concepts.

In terms of legislation and enforcement, the top priority for legislation has always been to build a healthy, robust system and safeguard the public. This has remained unchanged. However, Wong believes, the government needs to update the "performance specifications" by taking into account the latest industry developments and new materials available. "[It] should also enhance its knowledge management by paying closer attention to the latest developments in other countries [and] needs to put more

resources into making changes in its legislation and enforcement."

It is, perhaps, surprising that the ultimate liability in the lead-tainted water scandal fell on an individual licenced plumber, rather than on a company. "Any legislative review should look at whether the company that install[ed] the plumbing system, rather than a licenced plumber – who can be just an employee – should be liable," So said.

Apart from legislation and law enforcement, Wong thinks that the government can set the standard for safety as a reference for private developers because it is responsible for many projects, such as public housing, hospitals, and community centres. "The government should take a clearly-defined leading role." The Hong Kong Waterworks Ordinance also needs updating, So added. She explained that while the ordinance focuses on the quality and safety of pipes and fittings, this does not necessarily equate to the quality of water. "Some countries have Water Quality Acts that require the responsible authority to supply 'pure and wholesome water'."

In the wake of the scandal, the Water Supplies Department has also taken action to avoid a repeat of such incidences. In December, it launched the "Quality Water Supply Scheme for Buildings – Fresh Water (Plus)" to aid in the provision of a healthy environment for water consumption and the supply of good quality water to consumers. Wong thinks the government should include a detection mechanism for Legionnaires' disease in the scheme.

"The government can also consider making it mandatory for regular tests of devices such as drinking water dispensers in schools or other public places."

# 正本清「鉛」

為避免再次發生去年備受關注的食水含鉛事件,各界提出多項建議,當中包括採用類似食品包裝的標籤制度。

去年夏天,傳媒披露,有多個公共屋 食水樣本含鉛量超標, 引發公眾對食水安全的憂慮。一石激起千層浪,公眾紛紛將目 光轉向房署在建造項目方面的監管措施,而有關的專業人員、 承建商及水喉匠在事件上的角色。

10月底,調查食水含鉛量超標專責小組向發展局局長陳茂波提交最終調查報告,確定啟晴邨和葵聯邨第二期食水含鉛量超標是由於承建商使用了含鉛焊接物料接駁食水喉。為防止日後發生同類事故,專責小組建議了一系列措施,以防止使用含鉛錫焊物料及不符合規格的喉管裝置,並建議水務監督研究使用其他喉料以避免水務工程誤用含鉛錫焊物料和檢討相關法例,以及房屋委員會(房委會)研究採用中央採購焊接物料。陳茂波說:發展局認同調查報告的結論,並會積極研究和跟進有關建議。

報告亦建議,涉事承建商最長九個月內不得參與政府的未來項目的投標。香港測量師學會前會長、香港測量師學會物業設施管理組成員及項目管理委員會主席黃山測量師認為,該措施可能會對這些承建商產生重大經濟影響。黃山提出專門從事供水設備工程的公司應徹底檢討現有的制度,而整個業界亦應提升對本次水污染問題的認知。

首先,根據《水務設施條例》,本次鉛污染發生在「內部供水系統」[《水務設施條例》第102章],即處所內部個人亞軍國人現成的分支戰管出現,因此,責任應由《水務設施條例》界定的用戶及代理人或持牌水條匠承擔。

黃山表示,由於含鉛焊接物料在市場上廣泛出售,政府應查清問題的根源。「目前的情況類似在工業上使用石棉,而後者已為法律所禁止。」黃山將情況與食品供應相比較,現行法例要求產品包裝上的標籤清楚標明某些材料不應用於某些用途。「我認為,政府可先行透過行政手段實施該項規定,然後著眼長遠,促進立法……可利用產品包裝標籤方式,直接標示焊接食水喉管不得使用該含鉛物料。」

事件已促使業界重新了解現行樓宇規格方面的知識。儘管已有多份文件訂明相關規格,部分業內人士卻疏忽大意,未能全面了解詳情。黃山建議:「業界應密切關注其他國家的最新發展,掌握新知識。食水鉛污染在其他國家已有先例,而多國已採取定期檢測及以符合規格的喉管替換問題喉管等措施,徹底解決這方面的問題。」

黃山認為,發展商及建築公司可參考房委會採用中央採購焊接物料的建議,而身為建築業界成員,很多測量師均有參與項目管理、掌握項目的整體情況,可籍此提前向業界發出警示。「這是風險管理……建築測量師可盡早識別可能出現的問題,讓[公眾]更加了解市面出售的建築物料的變化。我們亦可在樓宇用後評估中擔當更重要的角色。例如,我們可[因應個別樓宇的需求,]建議進行定期檢測及協助收集住戶反饋。我們亦可在使用新物料時檢查重金屬含量有否增加。許多國家已實施樓宇用後評估。收集住戶反饋至關重要,尤其是對於採用新物料及概念建造的樓宇而言。」

至於立法及執法,一直以來,立法的最高宗旨是建造健康、穩健的制度和保護公眾。這項宗旨至今依然未變。儘管如此,黃山認為,政府仍需考慮業界的最新發展及可採用的新物料,更新「性能規範」。「[政府]亦應更加關注其他國家的最新發展,以加強知識管理,[並]需投入更多資源修訂法例及變更執法。」

鉛水事件的最終責任落在持牌水喉匠個人而非公司身上,著實出乎意料。蘇綺青說:「任何立法檢討均應關注是否由安裝水管系統的公司,而非由一名持牌水喉匠承擔責任—他可能只是一名僱員。」

黃山認為,除了立法及執法,政府亦可制定安全標準,以供私人發展商參考,因為事關公屋、醫院及社區中心等多個項目。「政府應承擔明確界定的領導角色。」蘇綺青補充說,香港《水務設施條例》亦需更新。她解釋道,儘管條例著重關注喉管裝置的質量及安全,但這些因素不一定等同水質。「部分國家設有《水質法案》,要求責任部門提供「純淨及健康的用水」。」

事件爆發後,水務署亦採取行動,力求避免日後發生同類事故。12月,水務署推出「大廈優質供水認可計劃—食水(2.0版)」,有助創造健康的用水環境及為市民提供優質用水。黃山認為,政府應將退伍軍人症的檢測機制納入計劃。

「政府亦可考慮強制要求定期檢測學校及其他公共場所的飲水 機等設備。」

Mann specialises in building surveying, which combines his expertise in architecture, engineering, and law. "A building surveyor is a cross between an architect, an engineer, and a lawyer. While an architect designs a building, a building surveyor makes it work...we look at the practical side of things." Mann also works as an Authorised Person and on project management.

Starting his surveying career in the UK during the early 1960s, Mann first worked for an estate agent in Sussex and then joined Vigers in London in 1965. His work for Vigers focused on all general Building Surveying work including property inspections for the London Underground, which paved the way for his future involvement in the MTRC's construction. In 1975, Vigers was appointed by MTRC to carry out building inspections and Mann initially came on a two-week visit in November. That was the start of a four-decade (and counting) association with the city, to where he volunteered to relocate to establish Vigers' office in 1976.

Mann's relatively unconventional upbringing has allowed him to adapt to foreign cultures easily. "My father worked as an engineer in India. I was born in India. It's probably the reason I took the job to come to Hong Kong. [My] other colleagues preferred to stay in London. When I came to work in Hong Kong, it did not feel strange to me...there was not any cultural shock."

Driving through the densely-populated Kowloon area where the old Kai Tak Airport was located,

Mann's first impression of Hong Kong was how crowded and close together the buildings were, which was very different from the cityscapes in the UK. He recalls that the main initial challenge was to get to know Hong Kong, which was a "brand-new" experience. As the head of Vigers, Mann's chief responsibility was to inspect buildings and prepare "Schedule of Conditions of Buildings" prior to the commencement of the MTRC's engineering works adjacent to them. His team of building surveyors included a retired staff member from the government's Dangerous Buildings Department.

Mann considers his building inspection works for the MTRC among his most significant achievements. "This gave me a thorough knowledge of all the different types of buildings in Hong Kong, ranging from the Mandarin Oriental Hotel in Central to squatter huts in Choi Hung." The MTRC's railway construction was carried out in collaboration with several local joint ventures and several projects proceeded simultaneously. "The engineering works were going in multiple directions. We had to ensure we were ahead of them. We had built a good understanding with the Buildings Department, which had conducted pre-inspection[s] before us. It was [a matter of] setting things up and getting [them] going. We carried out random inspections of buildings. We looked at the [exteriors], the common areas (i.e., the staircases), and some floors of the accommodation. I remember vibration piling was going on when we inspected some fragilelooking squatter huts of timber and bricks

in Wong Tai Sin. The entire building shook, we all vacated the building quickly and the construction company had to adopt a different form of piling."

Mann's team also prepared the schedules for the old HSBC and Standard Chartered Bank buildings, as well as that for the old Bank of China. "We had to be very careful with the current Court of Final Appeal Building (formerly the Legislative Council Building) on Jackson Road. It had already 'broken its back'. Part of the building was broken because two-thirds of it was built on one side of the old seawall (reclaimed land). Although the MTR eventually went through without any problem, we needed to be very careful. There were cracks in the building, but they were repaired eventually. Nothing became dangerous as a result of MTRC's engineering works. There were some minor movements between buildings and if we identified detects that had not been recorded previously, we would forewarn the contract engineers and the Building Authority. They then took measures to lessen the possible damage that might be caused by the MTR engineering works."

When Vigers was acquired by its new owners, Mann decided to establish his own practice, MRM consultants. We consult on building surveying services and provide expertise to clients in Hong Kong and throughout the Asia-Pacific region. MRM also specialises in property development, planning, construction, alterations, renovations, repairs, and maintenance, Mann serves as an expert witness for construction projects. "I'm a member of Project Chambers, whose membership includes building surveyors, project managers, and dispute resolution experts, among others. A memorable project was an insurance claim inspection for a hotel in Guam badly damaged in a typhoon. The hotel belonged to a group in the United States, but [was] insured through] a Hong Kong company. We visited the hotel three times and the claim settlement was agreed by both sides." The network of professionals in Project Chambers has been vital because we make referrals of projects to one another."

Mann believes the key to a successful surveying business is the building of relationships with clients. "We need to understand what clients want and do our utmost in servicing them.

Summing up his experience in community service for the Town Planning Appeal Board and Appeal Tribunal (Buildings), Mann enjoys interacting and analysing cases with professionals from a diverse range of fields and backgrounds. "The more you talk about [individual cases], the more you will learn and gain more experience."

It is highly beneficial for young surveyors to start their careers by working for experienced surveyors, Mann advises. "They should also start [by] working for a reputable firm. They will learn a lot by doing this. Gradually, they can start working on their own. My advice is that young surveyors should listen carefully and work hard while enjoying their experience[s] at the same time."

The local surveying sector nowadays is robust and vibrant. "The HKIS is strong and proactive in reaching out. It is important in trying to get to various government departments so that we are recognised as an authority. I think surveyors should do more self-promotion."

# 奠基香港

及至去年11月,香港測量師學會前會長Sr Michael Mann 來港設立威格斯香港辦事處已有 四十載。他當時親身參與主要為香港鐵路有 限公司(港鐵)開展的多個項目。接下來, Mann 將回憶當時的細節,講述這些工作如何 為這個在香港規模空前的基建項目奠定基礎。 Mann 曾出任英國皇家特許測量師協會(香港 分會)會長,現為 MRM Consultants 主席。其 公司將於今年迎來二十週年誌慶。

#### Wilson Lau

Mann 從事建築測量,深諳建築、工程及法律等專業知識。「建築測量師集建築師、工程師及律師三者於一身。建築師負責設計樓宇,而建築測量師則務求令設計切實可行......我們著眼於實際操作層面。」Mann 亦擔任認可人士及從事項目管理工作。

Mann 於六十年代初在英國開始其測量師職業生涯。他最初在薩塞克斯一間地產經紀公司工作,隨後於 1965 年加入威格斯倫敦分公司,主要負責一般屋宇測量事務,期間曾為倫敦地鐵(London Underground)開展物業視察工作。這段經歷為其日後參與港鐵的建造工程鋪就道路。1975 年,港鐵委任威格斯進行樓宇視察工作,Mann 因而於 11 月首次訪港兩週,由此開啟與香港至今已長達四十年的情緣。他於 1976 年主動請纓,並獲調派至香港及成立威格斯辦事處。

Mann 的成長背景令他可以輕鬆適應異國文化。「家父是一名工程師,在印度工作。我在印度出生。可能正因如此,我才會決定來到香港執業,而 [ 我的 ] 其他同事更願意留在倫敦。初來乍到,我並無陌生的感覺 ..... 沒有經受任何文化衝擊。」

駕車穿過熙熙攘攘的九龍城區(啟德機場舊址所在地),Mann 對香港的第一印象是人口雲集、高樓林立,與英國的城市面貌截



然不同。據他回憶,他初時面臨的首項主要挑戰是去了解香港,這是一次「前所未有的」經歷。身為威格斯負責人,Mann 的主要職責是在港鐵啟動建造工程前,對工程附近的樓宇進行視察並編寫樓宇現況列表。他的測量師團隊成員包括一名負責處理危險樓宇的前屋宇署退休公務員。

Mann 將為港鐵進行樓宇視察工作的經歷視為最引以為傲的成就。「這項工作讓我深入探究香港的各式建築,從中環的文華東方酒店到彩虹的寮屋,均有所了解。」港鐵當時正與若干當地合營企業合作修建鐵路,而且有多個項目同時展開。「工程項目紛繁複雜,我們必須快人一步。我們與屋宇署已建立良好的互信關係,當時的工作簡而言之就是設定計劃並推動執行。我們對樓宇進行隨機視察,對外牆、公用部分(例如樓梯)以及住房的若干樓層以進行目測。我記得在黃大仙視察一些採用磚木式結構、看來已搖搖欲墜的寮屋。當其時正進行振動沉樁,整座建築震動不已。所有人全部迅速撤離,而建築公司不得不採用其他打樁方式。」

當威格斯被新主收購時,Mann決定成立自己的事務所 MRM Consultants,為香港及亞太區的客戶提供建築測量諮詢服務及專業意見。此外,MRM 亦擅長物業發展、規劃、建造、改造、翻新、修復及維護。Mann 亦擔任建築項目的專家證人。「我是工程項目協會 (Project Chambers) 會員。該協會的會員包括建築測量師、項目經理以及爭議調解專家等。最令我難忘的項目是為關島一間遭颱風襲擊而嚴重損毀的酒店進行保險索賠調查。該酒店隸屬一家美國酒店集團,但透過一間香港公司投保。我們三度到訪酒店,協助雙方就賠償問題達成共識。」

Mann 認為,在測量業取得成功的關鍵在於與客戶建立良好關係。「我們要了解客戶所需,全力以赴為客戶服務。在工程項目協會,專業人士之間的網絡至關重要,因為我們會相互轉介項目。」

Mann 提到為城市規劃上訴委員會及建築物上訴審裁小組提供社 區服務的經歷。Mann 樂意與不同領域及背景的專業人士互動及 分析案例。「你討論的案例越多,就學得越多,經驗亦更豐富。」

對年輕的測量師而言,從師於經驗豐富的測量師,對其開展職業生涯頗有助益。「最初入行時,他們應選擇聲譽良好的公司,在工作中不斷增進專業知識。假以時日,他們可逐步開始獨立工作。我建議年輕的測量師用心聆聽、努力工作,同時享受這個過程中的種種體驗。」

本港測量業正蓬勃發展。「香港測量師學會實力雄厚,積極進取。 我們必須與各個政府部門建立密切聯繫,只有這樣,測量專業的 權威才會得到認可。我認為測量師應更積極地大眾推廣,提升社 會對測量專業的認受性。」

# 國家住房和城鄉建設部 到訪香港測量師學會

國家住房和城鄉建設部工程質量安全監管司司長李如生先生及工程質量監管處處長廖玉平先生於1月14日到訪香港測量師學會。學會由高級副會長何國鈞測量師主持接待,其他出席的學會代表包括上任會長何鉅業測量師、產業測量組主席趙錦權測量師、工料測量組主席黃國良測量師、建築測量組副主席李偉峰測量師及理事李國華測量師。

在交流會議中,學會高級副會長及其他代表講解了香港測量師學會的會員管理制度及與內地資格互認情況,雙方代表亦就兩地的工程質量標準及工程造價管理交換了意見。



# Land Supply Policy Forum - Reply from the Development Bureau

Further to the submission made by the HKIS to the Development Bureau in August 2015 (http://www.hkis.org.hk/ufiles/hkisview-20150820.pdf). regarding the views, comments and recommendations regarding land supply policies collected in the Land Supply Policy Discussion Forum held in July 2015, the Development Bureau had responded to our letter by end of last year (http://www.hkis.org.hk/ufiles/hkisview-20151230.pdf)





The HKIS submission set out various possible strategies discussed at the forum including (1) country park land; (2) removal of planning constraints of CDAs) and R(E) zones; (3) relaxation of density control at the outskirts of New Towns and (4) streamline the premium assessment process in lease modification. The reply from the Development Bureau addressed government land supply in both (1) short to medium term and (2) medium to long term. On the subject of Streamlining Premium Assessment Process, detailed feedbacks have been provided to the issues identified in the HKIS submission including Arbitration on Land Premium, Standardization of Premium Rates and Enhancing Communication and Reestablishment of the Modification Section. The reply has also set out the considerations for CDA and R(E) sites. The HKIS will continue to follow up on this important subject of land supply and communicate with the Development Bureau through different channels including the Land and Development Advisory Committee and its Land sub-committee and meetings with the Lands Department.

# Meeting with the Fire Services Department on the Proposed Registered Fire Engineer (RFE) Scheme


We mentioned the proposed RFE scheme in the last issue of Surveyors Times. In order to encourage building professionals to express their views on this topic, LegCo Councillor, the Hon Tony Tse, arranged a meeting on 23 December 2015 among the Fire Services Department (FSD), HKIS, HKIA, and BD Local Building Surveyors Association. I attended this meeting with our past BSD Chairman, Sr Raymond Chan; Sr Eddy Cheung; Sr Arthur Cheung; and Sr Frankie Tai. While the BSD supports the devolvement of fire safety risk assessment, compliance inspection, and certification on the market, we strongly object to the title of RFE, qualification, and the membership in the Registration Committee, as presented in the LegCo paper. After the meeting, the BSD submitted its written response to the FSD on 19 January 2016 for its review. To follow up, the Hon Tony Tse will organise a working group to oversee the drafting of the subject legislation. The BSD is grateful to have Sr Kenny Tse, Sr Eddy Cheung, Sr Frankie Tai, and Sr Stephen Tse as its members.

# Meeting with the Guangdong Construction Industry Association

On 29 December 2015, delegates of the Guangdong Construction Industry Association visited the HKIS. Together with SVP Sr Thomas Ho and representatives of the QSD, I attended the meeting with Sr Andrew Kung, Sr Nathan Lee, and Sr Edgar Li to exchange views and working practices on various areas such as:

# GPD Education Committee

During the 1<sup>st</sup> GPD Education Meeting, it was reported that the 2015 APC Part II Assessment was held in December 2015. Of the 44 candidates enrolled, 42 attempted the assessment and the pass rate was 57%. Awards will be presented to the top three outstanding performers in the assessment.

For the 2016 Structured Learning Programme, the open recruitment of speakers to give talks to members will be launched in *Surveyor Times*. The Committee agrees that the SLP fee scale will remain the same for 2016. In order to relieve such a financial burden for probationers, it also agreed that they can settle the fee in two installments.

The Committee has formed working groups to conduct an overall review of the GPD APC in terms of its procedures, arrangements, and syllabus. Its progress will be reported in mid-2016.

# Visit to CIREA/CREV/CAS

I visited the China Institute of Real Estate Appraisers and Agents (CIREA), the China Real Estate Valuers Association (CREVA), and the China Appraisal Society (CAS) in January. My discussions with the three valuation organisations included the possibility of further cooperation on continuing professional development seminars/conferences, reciprocity arrangements, and the third round of reciprocal recognition between the HKIS/CIREA. I stated that the cooperative and reciprocity arrangements with CIREA, CREVA, and CAS would be best handled by a working group within the GPD Council and this suggestion was well received by the ExCom during its recent meeting.

# PRE-QUALIFICATION STRUCTURED LEARNING PROGRAMME (SLP)

In accordance with Section 6 of the APC Rules and Guide promulgated in June 2012, candidates are required to attend a mandatory 40-hour programme designed to prepare them for the Part I Assessment. For the purpose of helping candidates meet this APC requirement, the GPD Education Committee will organize a 17-session (51 hrs) SLP for APC candidates. The SLP aims to teach candidates the practical side of GP surveying and how they can apply their academic knowledge learnt from university to their daily professional work. Candidates are expected to complete at least 40 hours of the lectures out of this 51 hours programme.

The GPD Education Committee would like to invite the senior practicing members (minimum 7 year post qualification practical experience but 10 years is preferred) who are experienced in the following fields to deliver talks (3 hours per session) to probationers on the following subjects.

Land Surveying Division
Sr Dr Conrad Tang LSD Council Chairman

In this hectic and competitive world, we, as land surveyors, are part of the professional services that help power the economic engine of our society. We have a neat scope of expertise; we perform our tasks with a prescribed standard; and we fulfill a duty that society expects from us. But do we know how well we have performed as individuals or the overall performance of the system itself?

We have a specific scope of skills and techniques. Technology has been constantly progressing such that even in our basic measurement operations, we now have the option of using new tools and skills. The point-to-point measurement mode may soon be replaced by scanning or imaging technology. Thus, the LSD picks hot surveying technology topics to discuss during CPD events.

Sr Yik Wai-fung of the Highways Department has agreed to deliver a CPD talk on mobile mapping systems in April. On the topic of smart cities, Jimmy Lau of Bentley Systems HK, Ltd, will present the Advanced Reality Model on 3D mapping in May. Sigma Mascot (HK), Ltd, has committed to presenting its low-cost, non-metric-camera UAV system during a CPD this summer. Many other interesting talks are also in the works.

Land boundary issues are always in my heart. I am pleased to tell you that our Past President, Sr Simon Kwok, has kindly agreed to deliver a CPD talk on the development of Hong Kong's land boundary system in August.

During the January 2016 LSD meeting, I received acknowledgements from our ALS Council members that each of them would give a CPD talk on land boundary disputes. Detailed arrangements are in progress. Sr Tang Winglun immediately 'volunteered' his partner at Leung Shou Chun Land Surveying consultants, Ltd, Sr SC Leung, to deliver a CPD talk in March. The topic is quite mathematical: "{Occupation

+ Greed} X {Record + Bureaucracy} = Adverse Possession". If this ALS series of boundary CPDs receive good feedback, the LSD will extend its invitations to all other ALS members.

Technical know-how is important. Professional ethics is even more important. It is the prescribed technical standard that we promise to achieve. On land boundary surveying, it is the Code of Practice under the Land Surveying Ordinance. The HKIS prescribes the Guidance Notes for Land Boundary Surveys to re-establish lot boundaries. It also follows the practices stipulated in the Code of Practice.

A land surveyor performs one's task with advanced technology and observes the rules contained in the professional guide. But it may not be satisfactorily completed in accordance with the general public's expectations. Many of us do our jobs well, yet we may not always do a good job. The professional ethics that we prescribe today may not comprise the whole picture of ethics to professionals. We always ponder if our work meets the general public's expectations. Many of us believe that there is a big gap between what we can and should do.



Throughout the four-hour deliberations, discussions, and sincere exchanges of views, council members suggested to inject more resources into the following important domains:

- a) To let the public know the core competencies of PDD members.
- b) To get the government (in particular the Planning, Lands, and Buildings Departments, as well as the Development Bureau) to recognise PDD qualifications in its recruitment drives.
- c) To increase membership by having more university courses gain PDD accreditation and multiple accreditation for HKIS members.
- d) To provide structural learning and APCs for graduates and widen the training avenues for them, such as having secondments to the Planning, Lands, and Buildings Departments.
- e) To promote PDD Surveyors through public relations or promotional campaigns to establish a well-defined PDD surveyor image.
- f) To establish better governance within the PDD Council.

I totally concur with my council members that Item (a) above is vital to the road map for the growth and right direction of PDD surveyors. This induced a lot of council members, if not all those present, to proactively and constructively advocate their views on the necessary skills, knowledge, and competencies of a good PDD surveyor. After over two hours of discussions, council members reinforced and elaborated the qualities of a good PDD surveyor as follows:

- a) knowledge and practical skills in town planning: this is of paramount importance and the council reckoned that they should not only be confined to Section 16 applications;
- b) knowledge and practical skills in property development: it encapsulates, *inter alia*, feasibility studies, valuations, the Buildings Ordinance and other regulations, lease matters, project management, construction costing, building services, green buldings and construction technoogy; and
- c) asset management, market research, and analyses of market trends.

# New Way of Real Estate Financing – the Concept of Emerging Real Estate Crowdfunding

Property Technology, or "Proptech," a term that is commonly used nowadays, is an emerging sector in the technology of space, where entrepreneurs, incubators, accelerators, and corporate property players seek new technologies that would improve the ways to deal with property.

Just like Airbnb in the hospitality business and Uber in the transport business, the property sector is getting a dose of the so-called digital "disruption," especially on property mortgages and finances.

In some countries, the introduction of real estate crowdfunding (RECF) has allowed accredited individuals to invest in income-producing real estate projects supported by a large number of people ("the crowd"). This method for real estate owners to secure financing for their projects is a great alternative to traditional mortgages and bridge loans. RECF can be a way out for real estate owners, investors, landlords, and developers to secure mortgages/ financing outside of the traditional avenues.
