Working handinhand

Following the Chief
Executive's 2016 policy
address delivered on
January 13, three HKIS
Policy Panel Chairmen
discuss how closer
relationships can lead
to improvements in the
areas of land, building and
housing.

A closer relationship between the government, the private sector and different stakeholders is crucial to ensuring improved housing quality and more efficient use of land, says the Hong Kong Institute of Surveyors (HKIS) in response to the government's 2016 policy address.

Sr C K Lau, President of the HKIS and Chairman of the HKIS Land Policy Panel, says the policy address pointed in the right direction, but that it would be difficult to realise the policy goals if the government is to "work on its own".

For example, in the government's effort to boost land supply, it has announced a series of measures, including the move to release existing GIC (Government, Institution or Community) lands for commercial or residential use. While such efforts are appreciated, the government should also motivate developers to work on the land in their banks, Lau says. "The government needs to think about how to provide incentives to the private sector in order to get them on the same page. So much more can be achieved when the public and private sectors work hand in hand together."

In another example, the government announced the launch of a pilot scheme wherein the land premium for lease modifications can be waived. Its aim is to encourage landowners to construct footbridges or subways at their own cost in accordance with the pedestrian network planned by the government.

While such a move will reduce the landowners' costs, it does not offer enough incentive to take advantage of the move, which is in the public interest. Lau urged the government to widen the pilot scheme to include all of Hong Kong, and look at the possibility of sharing the costs of the pedestrian network construction with the private sector in order to improve pedestrian traffic.

Sr Vincent Ho, Immediate Past President and Chairman of the HKIS Building Policy Panel, says that the government should also consider ways to enhance the efficiency of the building and construction approval process. He suggested a centralized system for the Lands Department to approve the submission of building plans and master layout plans, and the appointment of senior technical officials to oversee such a mechanism to avoid unnecessary back-and-forth technical enquiries.

"At the moment, most of the manpower of the Lands Department is devoted to lands administration and lease enforcement, and they may not be sufficiently familiar with building and construction matters," Ho says. "The officers tend to ask for a lot of unnecessary or premature details just because they see something unfamiliar on the submissions." In the meantime, the HKIS is keen to work closely with the Lands Department to update them on industry practices to save time for both sides. Ho adds.

While agreeing on the overall direction of the policy address, Ho says that it did not pay enough attention to addressing the issues related to building maintenance. While the policy address recognized the need to regulate the building repair and maintenance industry, it had yet to make the commitment to establishing a regulatory body to ensure service quality and transparency in pricing.

"We need a game-changer to the entire business model in the industry, which is unhealthy and opaque," Ho says. "Think about the many ordinary citizens who do not have the means or information to handle dishonest contractors. They need a platform to share information, to seek help in ending unfair contracts and seek compensation from the contractors."

The need for better regulation is becoming more imminent, as Hong Kong is faced with the challenge of keeping up the condition of ageing buildings – another aspect that has been overlooked by the policy address. "There are a good number of old buildings in our existing housing stock and you cannot simply demolish them all," Ho says. "You have to think about how to preserve, maintain and enhance them to make sure that the residents have a secure and comfortable living environment. We should have a policy to promote the preservation and enhancement of old buildings, and lengthen their longevity."

Sr CK Chan, who chairs the Housing Policy Panel at the HKIS, says it is usually a struggle for the organizing committees of old buildings to carry out maintenance work because of chaotic, multiple ownerships. He suggests the government consider lending money to owners to improve their living conditions, and register the expenses with the Lands Registry so that the amount will be charged to respective landlords when there is a change of ownership.

Chan also says the government has yet to follow up with its pledge to improve the average living space of Hong Kong people. "Compared with other cities with a similar GDP level, our living condition is probably among the worst because our average living space is one of the smallest," Chan says. "The Chief Executive has pledged to improve our living space, but new flats are getting smaller and smaller. This is contrary to the government's intention.

"These 30-, 40-, 50-storey buildings of tiny flats won't just go away. They are here to stay for decades. We need a policy that clearly says that we are not going to have smaller and smaller flats flooding the market in the future because this is not how we want Hong Kong people to live."

On housing policy related to newly built homes, Chan says there is a void in catering to the housing needs of an ageing population, especially when it comes to less affluent elderly people who live on their own. He suggested the government provide policy support to provide affordable, elderly-friendly housing. Referring to current issues in this area, he cited the Housing Society's development of its elderly homes as an example: the society did not enjoy any land premium discount, and had to sell the units at millions of dollars each as a result.

When asked about the major effects of the 2016 policy address on surveyors, both Chan and Lau say there will be plenty of opportunities for the industry, as the government will need expertise in boosting land supply, building new homes and maintaining the existing buildings.

Ho adds that the "Belt and Road" initiative, as mentioned in the policy address, could provide great opportunities for Hong Kong surveying professionals to work in Mainland China and overseas markets. He urged the government to provide more market information for Hong Kong surveying professionals to remind them to the opportunities linked to Belt and Road, and to help them promote their professional services across the border and overseas.

"It is also a good opportunity for small- and medium-size start-ups, especially with financial support from the government in terms of low-interest loans and seeding funds," Ho says. "We look forward to more solid details from the government on how it will work with us to capture business opportunities."

攜手共進

行政長官於 1 月 13 日發表 2016 年施政報告後,三名 香港測量師學會政策小組主席討論如何透過加強各方關 係,改善土地、樓宇及房屋問題。

香港測量師學會就政府的 2016 年施政報告稱,加強政府、私營企業及不同持份者之間的關係,對確保改善房屋品質及提高土地使用效率至關重要。

香港測量師學會會長兼土地政策小組主席劉振江測量師表示, 施政報告方向正確,但若政府「獨自行事」,政策目標未必能 充分實現。

舉例而言,政府在提振土地供應時宣佈了一系列措施,包括將現有的「政府、機構或社區」(GIC)土地用作商業或住宅用途。劉振江表示,這些努力值得讚賞,但政府也應鼓勵開發商發展他們持有的土地。「政府需要思考如何激勵私營公司,讓他們與政府同步。如果公營機構和私營企業攜手協力,他們將取得更顯著的成果。」

此舉雖然會降低土地擁有者的成本,但未必足以鼓勵他們參與,從而公眾能受惠於此措施。劉振江敦促政府擴大先導計劃至整個香港,並研究分擔私營企業的行人網絡建設成本的可能性,以改善行人交通。

香港測量師學會上任會長、建築政策小組主席何鉅業測量師表示,政府亦應考慮如何提高樓宇及建造審批程序的效率。他建議地政總署採用集中的系統審批所提交的樓宇規劃及總綱發展

藍圖,並委任高級技術人員監督有關機制,避免不必要的反覆 技術諮詢。

「目前地政總署把大部分人力分配於土地管理及契約執行,他們可能不夠熟悉樓宇及建造事宜。」何鉅業稱。「工作人員詢問很多不必要或時機不對的問題,因為他們對所提交的材料內容不熟悉。」何鉅業補充道,香港測量師學會希望與地政總署緊密合作,向他們介紹最新的行業慣例,以節省雙方時間。

何鉅業雖然同意施政報告的總體方向,但認為施政報告對解決 樓宇維修相關問題的關注不足。儘管施政報告承認有必要規管 樓宇維修及維修行業,卻並未承諾設立監管機構,以確保服務 質素及定價的透明度。

何鉅業表示:「行業的營運模式不良且並不透明,我們需要一個能改革行業規則的機構。想想大眾市民缺乏途徑或資訊來應付不誠實的承建商。他們需要一個平台分享資訊,幫助他們終止不公平合約,並追討承建商賠償。」

加強監管已經迫在眉睫,因為香港正面臨維修老化樓宇的挑戰,這是施政報告忽略的另一方面。「現有住宅當中,舊樓數目眾多,不能就此拆除了事。」何鉅業說。「你必須考慮如何保護、維修及強化這些舊樓,確保居民有安全舒適的生活環境。我們應有促進保護及強化舊樓的政策,並延長樓宇的壽命。」

香港測量師學會房屋政策小組主席陳昌傑測量師表示,由於舊樓的業主可能是基層長者,難以進行維修工作。他建議政府考慮協助他們成立業主立案法團,如有需要可提供借貸,並向土地註冊處登記有關費用,以便在業權變更時向相關業主收回費用。

陳昌傑還表示,政府尚未兑現改善香港人平均居住面積的承諾。 他說:「與其他本地生產總值相約的城市相比,我們的生活環境可能是最差的,因為我們是人均居住面積最小的城市之一。 行政長官承諾改善我們的生活環境,但新樓卻越來越小,有違政府的意圖。

「這些 30 層至 50 層高的微型住宅不會一下子消失,還會存在數十年。我們需要制訂政策,確保未來不讓越來越小的住宅充斥市場,因為我們不希望香港人這樣生活。」

至於有關新建房屋的政策,陳昌傑說現有政策未能完全滿足老化人口的住屋需求,對不太富裕的獨居長者尤其如是。他建議政府推行政策,提供容易負擔的、適合長者的居所。談及這個範疇的問題時,他以房屋協會發展的長者房屋為例,表示房屋協會沒享有任何補地價優惠,只能以數百萬元的價格「出售」這些單位。

當問及 2016 年施政報告對測量師的主要影響時,陳昌傑及劉振 江均表示行業機遇處處,因為政府需要有關促進土地供應、建 設新住宅及維修現有樓宇的專業人才。

何鉅業補充說,施政報告中提到的「一帶一路」計劃可為香港 測量師帶來在中國內地及海外工作的機會。他敦促政府為香港 測量師提供更多市場資訊,讓他們留意與「一帶一路」相關的 機會,協助他們在內地及海外提供專業服務。

「特別在政府低息貸款及創始資金的支持下,這是中小型新企業的發展良機。」何鉅業說。「我們期待政府公佈具體細節, 説明政府如何與我們一起抓緊商機。」

ivisional Councils and the Young Surveyors Group are working on the themes they have set for this year. We have submitted proposals to the Government previously on three subjects:(1) Use of Independent Cost Consultant in Government projects; (2) Set up Building Repair and Maintenance Authority ("BRMA") and (3) Reestablish Lease Modification Section within Lands Department. The Government has not taken our proposals forward. We will adopt a three prong approach to pursue these proposals including: (1) continue the dialogue with relevant Government bureaus and departments; (2) engage with the general public through newspaper articles; and (3) liaise with other stakeholders including industry associations and advisory committees, as appropriate.

Monitor Public Works Projects

Budget overrun for public works projects has caused serious public concerns. The slow progress of funding approval in the Legislative Council has aroused different actions from the The Construction Industry Alliance ("CIA") of which HKIS is a member and leading business chambers and associations. Our Institute advocates the use of Independent Cost Consultant as an effective monitoring mechanism to improve cost control and

management of public works projects and to sound out warnings of possible budget overruns.

Set Up Building Repair and Maintenance Authority

While we appreciate the Government has requested Urban Redevelopment Authority to implement the Building Rehabilitation Facilitating Services Pilot Scheme, we maintain the view that BRMA would be more effective in addressing the ageing problem of building stock in Hong Kong. Many of our buildings are tired and not considered by developers for redevelopment. The extension of the physical and economic lifespan of existing buildings through suitable and regular repairs and maintenance is important to the well-being of Hong Kong.

Re-establish Lease Modification Section

Progress for unlocking private sector land resources for development purposes has been slow. The process involves both approval of application by the Government and agreement of land premium. How the Pilot Scheme of the Arbitration on Land Premium could bring improvements to the system is yet to be seen. The Institute advocates the re-establishment of the Lease Modification Section ("LM Section") for the purpose of processing applications and liaising with various Government departments and stakeholders. Staffed with subject experts plus dedicated team of professionals, this LM Section should help to improve operational efficiency and address the concerns of many applicants.

Embrace Spatial Data Infrastructure strategy

We have met recently with the Director of Lands and many of her senior colleagues to discuss ways for speeding up Spatial Data Infrastructure development, and formulating a digital framework and standards for development of Hong Kong as a smart city.

and Planning and Development Division will continue their effort in raising public awareness of their work including such activities as Quality Property and Facility Management Awards (coorganised with The Hong Kong Association of Property Management Companies) and the discussions with Government departments for employment opportunities for our members.

What Young Surveyors Want From **Education?**

With the assistance from the Young Surveyors Group, I have gathered valuable feedbacks from many young and qualified surveyors about changes they want in surveying courses. The feedbacks include: (1) Invite practitioners to teach for "practicality"; (2) Organize more seminars/ workshops /firm visits and students can learn practical knowledge; (3) Build up working relationship amongst different professions within the built environment; and (4) Research on local affairs to keep abreast with domestic market. It is important to note that the practical training should not obstruct creative thinking of students.

More opportunities will be available to students in Hong Kong to join the surveying profession. The THEi (member of the Vocational Training Council) will start in this year offering five surveying courses covering BS, GP, PFM, PD and QS. The University College of Estate Management (UCEM) has also set up its first international office in Hong Kong. Both THEi and UCEM will help to promote the growth of the surveying profession in Hong Kong.

別理事會及青年組正為他們今年訂立的主題作出努 力。本會早前已就三項議題向政府提交建議書: (1) ▲ 在政府工程項目引進獨立成本顧問;(2)成立樓宇 維修工程監管局(「BRMA」);(3)在地政總署豁下重置 土地契約修訂組。政府並未採納我們的建議。我們將三管齊 下跟進這些建議,包括:(1)繼續與相關政府政策局及部 門對話; (2) 透過報刊文章與公眾交流;及(3) 聯絡業界 組織、諮詢委員會等相關持份者。

監察公共工程項目

公共工程預算超支一事,已引起公眾深切關注。有見立法會 審批工程撥款進展緩慢,香港測量師學會所屬的建造業大聯 盟以及主要商會和組織已採取多項行動表達意見。學會建議 引入獨立成本顧問制度,作為有效的監控機制,以改善公共 工程項目的成本控制和工程管理,並就建造成本超支風險作 出預警。

設立樓宇維修工程監管局

政府雖已要求市區重建局落實「樓宇復修促進服務」先導計 劃,我們仍然認為,樓宇維修工程監管局更能有效解決香 港現有樓宇的老化問題。本港許多建築物都已老化,亦從開 發商角度看不適合重建。為本港利益起見,實有必要延長現 有樓宇的實際及經濟壽命,合適及定期之維修及保養非常重

重新設立土地契約修訂組

私人土地資源釋出作各種發展用途進展緩慢。當中過程涉及 兩部份,除了要經政府核准有關申請外,亦要就土地補價達 成協議。「補地價仲裁先導計劃」究竟能如何改善制度,仍 待觀察。學會建議重新設立土地契約修訂組,以處理有關申 請及與各個政府部門和持份者聯繫。透過地政總署專家及專 業團隊的努力,土地契約修訂組應有助提高運作效率,回應 一眾申請人所關注的不同問題。

實施「空間數據基礎設施」策略

日前,學會與地政總署署長及其多位高級官員會面,探討如 何加快發展「空間數據基礎設施」,制訂數碼架構和標準, 促進香港發展成智慧城市。

學會的物業設施管理組和規劃及發展組會繼續致力讓公眾認 識他們的專業範疇,活動包括學會與香港物業管理公司協會 合辦的「優質物業設施管理大獎」、與政府部門探討會員的 就業機會等。

年青測量師需要怎樣的培訓?

在青年組的協助下,我收到許多年青一輩的專業測量師對改 進測量課程的寶貴意見,包括:(1)邀請執業測量師教授「實 用知識」;(2)舉辦更多研討會/工作坊/企業參觀活動, 讓學生學習實用知識; (3) 與建造業的各個專業建立工作 關係; (4) 就本港事務作研究, 適時掌握本港市場情況。 要留意的是,實用訓練不應窒礙學生的創意思維。

本港學生將有更多途徑投身測量業。職業訓練局轄下的香港 高等教育科技學院將於今年起開辦五個測量課程,涵蓋建築 測量、產業測量、物業設施管理、規劃發展,以及工料測量。 英國產業管理大學學院亦已在香港設立首間國際辦事處。這 兩間學府將為本港測量業界帶來生力軍。

With Hong Kong's ongoing large-scale infrastructure projects and flourishing property developments creating steady demand for professionally trained surveyors, an increasing number of people are keen to seek out more information on the surveying profession.

To help enhance the public's understanding of surveying and provide basic information to those who are considering joining the profession, the HKIS exhibited at the recent HKTDC (Hong Kong Trade and Development Council) Education and Careers Expo held from 28-31 January at the Hong Kong Convention and Exhibition Centre.

Visitors to the Expo, many of them secondary school and university students, stopped by the HKIS booth to collect leaflets and listen intently to information offered by the enthusiastic volunteers on duty. "The event was well-organised and run with great efficiency, attracting many youngsters," said Sr Lau Chunkong, President of the HKIS.

At the Expo, Lau observed that an increasing number of university graduates studying for general degrees wanted to find out more about the surveying profession. "They want to get into the property sector, with many expressing an interest in developing their careers in surveying. This is a growing trend."

Gigi Mok, a probationer at the HKIS and committee member of its Young Surveyors Group (YSG), echoed Lau's sentiment. "I've helped out at the Expo for several years. One change I have observed is that more and more visitors are coming to our booth to ask

questions because the Hong Kong Government has launched several large-scale infrastructure projects, driving up the demand for specialist manpower. Local consultants and contractors are recruiting more professionals, including surveyors. Many students and people working in other fields have become interested in joining the profession."

YSG's main purpose is to enhance communication between the profession's new blood and local youth, with its members, who mostly consist of corporate members under 40, probationers, and surveying students. With the strong emphasis that the HKIS places on connecting with secondary-school students, YSG was the obvious choice to organise the institute's exhibition at the Expo.

Through direct interaction with youngsters visiting the Expo, the HKIS was able to gain a better understanding of their aspirations. Among other things, this will enable the Institute to better tailor the career talks it holds at secondary schools and universities to address the audiences' needs and concerns.

Sr Lizzy To, Chairman of YSG, believes that younger surveyors can more easily relate to other young people and are able to better address their needs. "We asked university surveying students and YSG executives to help out at the booth to give information about the profession, the details of our six divisions, and the HKIS in general. The students also shared information about their university programmes with visitors.

"Many visitors to our booth, particularly those whose degrees are unrelated to the profession,

but who aspire to become surveyors, were interested in knowing more about the system of Assessment of Professional Competence and eligibility for election to corporate membership of the Institute. We told them that now the HKIS has several new paths for them to attain professional qualification. We also capitalised on this opportunity to let them know about surveyors' career prospects, the types of companies that look for surveyors, and the remuneration package for newly-recruited surveyors."

Mok echoed To's thoughts on the importance of opening up more paths to professional qualification. "Given the restructuring of the system of Assessment of Professional Competence, there are more paths that qualify individuals to become corporate members of the HKIS. This attracted more individuals to come to our booth and make enquiries." Visitors to the booth, which included students, teachers, and parents, also enquired about the differentiations and distinct responsibilities of the six divisions within the HKIS.

Sr Dr Lawrence Poon, HKIS corporate member and Chairman of its Board of Education, was invited to the Expo to discuss the career prospects for surveyors. Poon, who is also a senior lecturer at the College of Science and Engineering at the City University of Hong Kong, also shared his insights on the professional training given to surveyors in Hong Kong. According to To, several secondary school teachers dropped by the HKIS booth to enquire about the possibility of the HKIS holding career talks at their schools.

"We also received requests for more information from other exhibitors at the Expo, such as educational institutions," To said. "Some wanted to know if the HKIS recognises surveying degree programmes offered by overseas universities. They also asked about information on the diverse roles that surveyors play in the property market and construction sector." To added that the HKIS distributed tens of thousands of leaflets during the four-day Expo. "We were highly encouraged by the enthusiastic responses from visitors."

Sr Rex Ying, Immediate Past Chairman of YSG, said some parents requested more specific information. "For instance, they asked about surveyors' entry-level salaries. Many are helping their children to make decisions on what programmes to study at university."

Some visiting students had begun to look beyond Hong Kong when considering their career opportunities, said Rock Man, a HKIS probationer and committee member of YSG. "They wanted to know more about the possible career-development opportunities for surveyors outside Hong Kong. For example, many Hong Kong quantity surveyors work in Mainland China."

To better equip volunteers at the booth with relevant information and to ensure that they gave consistent answers, YSG organised workshops with seasoned surveyors who shared their experiences in responding to frequently asked questions from the public.

Adding that YSG also worked on the booth design and logistics, To said her involvement in the event demonstrated the dedication of the organising committee. "It made me realise that collaboration was crucial to our successful participation at the Expo. The experience also enabled me to get a better understanding of the public perception of surveyors. Many students enquired about a surveyor's scope of work and the system of Assessment of Professional Competence. This helps us identify what to focus on in our future career talks and better address their interests."

Leonie Chan, a surveying student at the University of Hong Kong who helped out at the Expo, said she enjoyed the experience because she had the opportunity to know more surveyors. "I took the opportunity to interact with other exhibiting professional groups, too, such as engineers. I might be working closely with these professionals in the future."

在今年的香港貿發局教育及職業博覽 上,測量師學會的攤位吸引了一眾有志 從事測量師的學生及求職者

香港的大型基建工程接二連三,物業發展蓬勃,不斷需要經 過專業訓練的測量師,對測量業有興趣的人士也越來越多。

為增進公眾對業界的認識,讓有意入行的人士了解一二,香港測量師學會參加了 1 月 28 日至 31 日在香港會議展覽中心舉行的香港貿發局(香港貿易發展局)教育及職業博覽。

博覽訪客以中學生及大學生為主,紛紛駐足香港測量師學會的攤位,接過學會各組別介紹單張,認真聆聽當值義工的熱心講解。香港測量師學會會長劉振江測量師表示:「這次活動安排完善,運作順利,吸引了許多青年人。」

據劉振江在會上所見,越來越多非專業學科的大學畢業生有 意了解測量業。「他們想投身房地產業,不少人有志在測量 業界發展。這個趨勢與日俱僧。」

香港測量師學會見習生兼青年組委員會委員莫韻芝表示同意:「我在博覽幫忙已有數年。我察覺到來我們的攤位查詢的訪客越來越多,這是因為香港政府推出了好幾個大型基建項目,促進了對專業人才的需求。本地的顧問公司和承辦商都在招聘更多測量師等等專業人士。許多學生及從事其他行業的人士都有興趣入行。」

青年組的宗旨是加強業界新血與本地青年之間的交流,組員主要是 40 歲以下的學會專業會員、見習生及測量系學生。香港測量師學會十分重視與中學生的交流,由青年組負責學會的參展安排,乃最適合不過。

香港測量師學會透過直接接觸參觀博覽的年青人,深入了解 他們的心聲,以便籌辦中學及大學的職業講座時,更能切合 聽眾的需求和關注。

青年組主席杜嘉儀測量師相信,年青一輩的測量師較易與其他年青人溝通,回應他們的需要。「我們請來就讀測量系的大學生及青年組的幹事在攤位幫忙,由他們分享業界資訊,

介紹我們的六個組別,以及香港測量師學會的基本資料。測量系的學生亦有分享他們所就讀的課程的資訊。」

「不少參觀我們的攤位的訪客,都想了解專業評核試制度, 以及參選學會專業會員的資格,特別是本身學位與測量無 關,卻有志成為測量師的人士。我們告訴他們,香港測量師 學會新增了幾個獲取專業資格的途徑,亦藉此機會向他們介 紹測量師的職業前景、各類招聘測量師的公司,以及新入職 測量師的薪酬待遇。」

莫韻芝贊同杜嘉儀的見解,認為有需要開闢更多獲取專業資格的途徑。「專業評核試制度改革之後,符合條件的人士可以透過更多途徑成為香港測量師學會的專業會員。這點吸引了更多人來到我們的攤位查詢。」參觀攤位的訪客當中有學生、教師及家長,他們亦問及香港測量師學會六個組別之間的差異及各自的職責。

香港測量師學會專業會員兼教育委員會主席潘永祥博士測量師應邀出席博覽,討論測量師的職業前景。潘永祥身兼香港城市大學科學及工程學院高級講師,亦談及對香港測量師的專業培訓的見解。杜嘉儀稱,有幾位中學老師來到香港測量師學會的攤位,詢問學會能否到他們的學校舉辦職業講座。

杜嘉儀說:「有與會的教育機構和其他參展者查詢其他資訊。 有參展者問到,香港測量師學會是否認可海外大學的測量學 位課程。他們亦問及測量師在房地產市場及建築界所發揮的 不同作用。」杜嘉儀又指,在為期四天的博覽期間,香港測 量師學會派出了上萬張傳單。「訪客反應熱烈,令我們深受 鼓舞。」

青年組前任主席應鍾秀測量師表示,有部份家長查詢較為具體的資訊。「例如,他們問及新入職測量師的薪金。許多家長正為子女選擇在大學修讀哪些課程。」

香港測量師學會見習生兼青年組委員會委員文瀚鋒表示,部分參觀博覽會的學生在考慮就業方向時,目光已開始放到香港以外的地方。「他們想了解香港測量師在外地的發展機會。舉例來說,本港有不少工料測量師都在中國內地工作。」

青年組事前舉行了工作坊,安排資深測量師分享經驗,講述 他們如何回答公眾的常見疑問,讓攤位義工掌握更多相關資訊,確保他們提供一致的答覆。

杜嘉儀補充説,青年組在攤位設計及物流方面也下了工夫, 她身體力行,體現出籌備委員會的不懈努力。「今次活動 讓我認識到,合作精神是我們順利參展的關鍵。這次經驗亦 讓我多加了解公眾對測量師的看法。許多學生問及測量師的 職責及專業評核試制度。這有助我們日後釐定職業講座的主 題,更切合他們所關注的話題。」

在香港大學就讀測量系的陳悦敏同學也有在博覽幫忙,她表示很享受這次經歷,認識了不少測量師。「我藉今次機會接觸了工程界等其他參展專業團體。我將來工作時,可能會與這些專業人士密切合作。」

HKIS Media Luncheon

Media Luncheon

The HKIS Media Luncheon was held on February 2. Sr KK CHIU, Chairman of the GPD, announced that the GPD will join hands with the Land Policy and Housing Policy Panels this year to carry out a "land supply" study and submit proposals to the Government for further exploration.

1st GPD CIREA Working **Group Meeting**

The 1st GPD CIREA Working Group Meeting was held on February 15 under the supervision of Sr Alexander LAM. WG members unanimously agreed to the Terms of Reference, as set out below:

- 1. To promote further cooperation between the HKIS and the three China valuation organisations, namely the China Institute of Real Estate Appraisers and Agents (CIREA), China Appraisal Society, and China Real Estate Valuers Association in the areas of continuing professional development (such as co-hosting seminars and conferences) and reciprocity arrangements;
- 2. to liaise with CIREA to facilitate the reciprocity discussions between the HKIS and the two other China valuation organisations;
- 3. to foster the progress of reciprocal recognition with CIREA; and
- 4. to provide regular reports to the GPD Council.

CPD: Application of Sustainable Building Design Guidelines and Case Studies (Code 2016001)

The CPD on Sustainable Building Design Guidelines, held on Saturday, January 30, was well-attended by over 100 members despite its four-hour length. The keen interest shown by participants indicated the complexity behind these guidelines. However, the speaker, Mr Wayne Chan, was able to guide the audience through a number of case studies to demonstrate the applicability of the guidelines.

In late January, the Buildings Department issued a revised version of the Practice Notes for Authorised Persons, Registered Structural Engineers, and Registered Geotechnical Engineers (PNAP) APP-152. The GPD wants to organise another CPD on its impact in late 2016.



CPD: "Surveyor" and "Sustainability" - Two Incompatible Terms? (Code 2016002)

The HKIS had the pleasure of sharing Mr Ian Brownlee's insights into the question of sustainable development in Hong Kong. The event, held on February 16, was attended by 80 participants. During the talk, lan highlighted the importance of the public engagement



exercise being conducted in respect of the Lantau Development and questioned if land supply actually impacts flat price levels. The talk also touched on the waste management issue and the proposed pedestrianisation of Des Voeux Road Central.

A Dialogue with the Director of Lands on Smart Cities and the Land Survey Ordinance

Four LSD surveyors joined a Chinese New Year Tea Gathering on 22 February with representatives of the Lands Department. After a warm welcome address by Ms Bernadette Linn, Director of Lands and a briefing on our wishes for communication by our President, Sr C K Lau, we had a chance to discuss land surveying issues with the Director.

Prof Sr SC Leung brought up the issue of amending the Land Surveying Ordinance. He pointed out that without a legal sanction of land boundaries, colleagues at the Survey and Mapping Office could not efficiently manage land boundary matters. This would result in a waste of talent and resources and society at large eventually suffers. Hence, the Government should step up its amendment efforts on the land survey law.

The Director made an affirmative glance at her SMO colleagues nearby and replied that Lands Department staff strive to serve and tackle tasks in a professional manner. The Administration understands the need for a new version of the land survey law and will make this issue a high priority.

Smart City is the theme of a working plan for the LSD this year. We told the Director that the road to a smart city starts with the establishment of a government policy – preferably a top-down one that forms the administrative institutions and authorises the sharing of data amongst departments. The law, technical know-how, and specifications come afterward.

The Director replied that her SMO colleagues were eager to explore and implement GIS and a land information hub. Furthermore, the policy staff at the Bureau and Department have consented to the need to develop a Smart City. She welcomed HKIS members to contribute more ideas to the development.

A Dialogue with the Deputy Director of Lands on Access to Deposited Survey Information at the District Survey Office The LSD had an opportunity to discuss this issue with the Deputy Director, Sr Paul Ng. Land surveying practitioners have difficulty gaining access to survey information that was deposited before the enactment of the 2013 version of the Personal Data (Privacy) Ordinance (Cap 486). Staff at the District Survey Offices could not provide copies of the searched plans and other deposited information by claiming that they had no authority to distribute the information, which came in two categories – information deposited by other government departments and by previous private practice land surveyors (later authorised land surveyors).

The SMO is the official holder of all land boundary information in Hong Kong. Its mission is to collect relevant land boundary information for the execution of surveying activities. Simply put, its duty is to share relevant survey information with surveyors who are now working on the subject area. If this law or any other statute and by-law has inadvertently hampered access to survey information previously available to the industry, the SMO should stand up and seek clarification on the particular functions of the law and arrange for a workable procedure to restore access to the necessary land boundary information.

Sr Paul Ng acknowledged that land surveyors in the private sector may face such difficulties. While the SMO administration should consider plausible answers, he advised that the Code on Access to Information could be properly utilised. A researcher of survey information may request the plans that

were deposited by other government departments. The SMO should, upon receiving this request, communicate with the depositing department and properly seek consent from the relevant authorities.


Summary on the Briefing Session for Facilitating the Provision of Pedestrian Links by the Private Sector on 18 February 2016 (by Gigi Mok)

In 2012, the multi-disciplinary Energising Kowloon East Office (EKEO) was inaugurated to steer, supervise, oversee, and monitor the development of Kowloon East (KE), which comprised the former Kai Tak Airport and the Kwun Tong and Kowloon Bay business districts. Among the four key strategies of the policy initiative, as shown in the latest EKE Conceptual Master Plan, connectivity is the most important one for the success of the complex urban transformation process of KE.


In its 2016 Policy Address, the Government announced new policies for KE, including a pilot scheme to waive the land premium for a lease modification to encourage landowners to construct, at their own cost and in accordance with the planned pedestrian network, footbridges or subways to form part of a safe, comfortable, and convenient network that separates pedestrians from vehicles and facilitates the transformation of KE into a second core business district (CBD2).

YSG was invited to the briefing session for Facilitating the Provision of Pedestrian Links by the Private Sector, which was arranged by the EKEO on 18 February to explain the new policy with the following details:

The EKEO advised that the proposals would be considered on a case-by-case basis if a landowner has a good proposal that is supported by a comprehensive pedestrian traffic study.

The tentative commencement period will be Q3 2016. Under the new policy, the EKEO will first finalise the comprehensive pedestrian network in KE, which would then be incorporated into the relevant ODP. Finally, applications for waiving the land premium could be made by the private sector.

Site Visit to the Wo Lee Ping Che Warehouse (30 January 2016)

Over 60 years since its establishment in 1954, the Wo Lee Steel Company Limited (Wo Lee) has become a reputable supplier of a wide range of steel materials like piles, H-columns, channels, hollow sections, angles, squares, rounds, flats, and deformed bars to the construction industry. It also supplies in bulk shaped bars, plates, galvanised sheets and coils, etc., to the manufacturing sector and has even diversified its offerings to include a product innovation and processing centre to keep pace with the needs of an ever-demanding worldwide market.

YSG arranged a site visit to Wo Lee's warehouse training centre in Ping Che, which was equipped with various kinds of processing machinery. The center supervisor, Mr Donald Choi, introduced various steel products to the visitors and explained the fabrication of materials using plasma cutters, drills, and other fabrication procedures, as well as a JAS rainwater drainage system.
