Marking Milestones at West Kowloon

Surveyors are playing a critical role in the development of the West Kowloon Cultural District, but must overcome a host of challenges to ensure the success of the proposed arts and cultural hub of Hong Kong.

While the operational parts of the much-anticipated West Kowloon Cultural District (WKCD) might currently consist of only a two-hectare section used for open concerts and bike riding, by completion it will boast an impressive 40 hectares of arts and entertainment space in whose planning and development surveyors are playing key role.

Sr Dr Chan Man-wai, Executive Director, Project Delivery, of the West Kowloon Cultural District Authority (WKCDA), says that the harbourfront international arts complex will gradually reveal its first-phase constructions over the next two years, with the Xiqu Centre performance venue, M+Pavilion art hub and a sprawling park all operational by 2018.

Responsible for hardware development. Chan points out that the WKCD demonstrates the collaborative effort of planners, engineers, architects, surveyors and builders. "Collectively, we have to overcome many challenges," he says. "First, we aim for zero accidents. Second, it is very difficult to meet the tight budget that was set in 2008 due to the 136 per cent increase in construction costs since then. Third, the district is being built at the junction of four railway lines – the West Rail, Tung Chung, Airport Express and future Express Rail Link – and the Western Harbour Tunnel, which creates challenges ranging from land issues to noise mitigation. There are also complicated communications processes among the various stakeholders, as well as the constant need to report to Legco and district councils."

Despite the challenges, there is much good news. The Xiqu Centre, with its innovative design mixing old and new styles, recently passed a milestone in its construction with the successful raising in May of its 2,400-tonne steel main structure – representing three-fifths of the theatre – to its planned height of 45 metres above street level. According to

Carrie Lam, Chairman of the WKCDA Board, this significant milestone represents the beginning of the countdown to the Xiqu Centre's completion.

"This action alone had to be done three times spanning three months, with the roof first and the base last," Chan recalls. "Six sets of gigantic cables, each with a huge bundle of wires, were used. The process took an entire day each time, closely monitored every second by numerous computers at various check points to ensure absolute accuracy." This was preceded by the laying of foundations (started late 2013) and the building of superstructures (early 2015) as well as countless measurements and calculations to ensure precision.

Aiming to take Chinese opera to new heights with modern acoustics and design, the centre's design was inspired by Chinese theatrical tropes and folk bamboo theatres. The completed centre will feature a tea house where visitors can enjoy refreshments and listen to nanyin music.

"The 13,800 square metre centre will have a 1,100-seat main theatre at the top of the building, followed by learning and rehearsal centres and restaurants in the middle, and a spacious public atrium on the ground level. The theatre, which has no pillars so as to enable the best views of the stage, is at the top to ensure minimum loading," Chan says.

Even though the roof is now in position, surveyors continue to contribute to the Xiqu Centre's development. Built at the busy intersection of Canton Road and Austin Road, the theatre needs to be "a box within a box" to mitigate external noise and avoid structurally transmitted sound, Chan says. His team also has to work on specialised seating and stage design dedicated to the art form. Despite the difficulties, Chan is glad that the Xiqu community, who will be the end users, enthusiastically anticipate its opening.

Sr Adam Lee, Senior Director and Head of Land Advisory Services at Knight Frank, and a sitting consultant of the WKCDA, explains that there are huge complexities involved in the mega project. "WKCD plans to serve multiple purposes, including arts and culture, leisure, retail, dining, entertainment, hospitality, commercial, and residential use. This involves extremely complicated interfaces between the public and private sectors. For instance, the WKCDA is tasked with preparing the WKCD development plan by ordinance, in which the arts and cultural facilities, as well as retail, dining and entertainment facilities, will belong to the WKCDA; whereas the hotel, office and residential uses could be sold to private owners in future," he says.

"We thus need to project into the future and, with a purpose-designed land grant, ensure the feasibility of such dynamic development on this large piece of land in the next two or three decades. We also need to safeguard the interests of the multiple stakeholders, including the WKCDA, the government, future private owners and the general public."

Obtaining land grants is one of the major areas where general practice surveyors make a difference, Lee says. He explains that they play an advisory role in relation to the planning, development and implementation for the WKCD, taking into account development controls from the perspectives of land administration, town planning and building ordinance. These encompass development planning, institutional structure, the evaluation of development potential, valuations, development packaging and programmes, and relevant land applications, among others. "When a building is completed, the role of general practice surveyors could even extend to cover sales, leasing and property or facilities management. In short, we find the biggest room for development within the development controls and legal framework," he says.

Lee echoes Chan's concerns on the added complexity of multiple parties' land rights and physical limitations brought about by the site's location at the junction of several major works. "Intersecting with the site are existing infrastructures – including railway facilities, the Western Harbour Tunnel, government pumping stations, private water

cooling mains, fire station and public roads – while the future Express Rail Link, under construction, has significant physical interface with the WKCD site," he says.

"These lead to the need for interaction with various parties, including the MTR Corporation and KCR, Western Harbour Tunnel Company, Water Supplies Department, Government Property Agency, Fire Services Department, Highways Department and more. As general practice surveyors, we need to communicate with, and moderate, various stakeholders to resolve interface issues such as 'what belongs to whom' and 'how interests of respective parties can be protected'. At the same time, we need to propose innovative solutions to facilitate the overall development of the district which, though self-financed in future, is a public mission after all."

Sr Daniel Pong, Director of Union Contractors, is one of the people behind the development of the two-storey M+ Pavilion, which will be the site's first major operational construction with events scheduled for this summer. Pong's company is the main contractor and, having been awarded the project barely a year ago, is tasked with resolving difficult issues including completing the site formation, building underground drainage and manholes deep below sea level, and ensuring budget control.

Pong explains that building information modelling (BIM) is practised to record all information about equipment, structure and material with digital representations down to "every pillar and every brick". "Although BIM means higher cost during construction, it will facilitate maintenance and thus cost-saving in the long run, thus showing the forward-looking nature of the WKCD project," Pong says.

At the same time, however, Union Contractors needs to handle issues which cannot be resolved by BIM. "Before its opening, we hope to resolve issues caused by the gaps between the design concept and its implementation, such as, the "mirror" concept of external wall!" Pong says. "We look forward to the M+ Pavilion being well-received."

西九新里程

測量師對西九文化區發展發揮著至關重要的作用,他們必須克服重重挑戰,以確保香港擬建的文化藝術樞紐順利落成。

西九文化區備受期待,雖然現時其營運部分佔地面積可能僅有兩公頃,用作舉辦露天音樂會及供市民騎單車運動,但西九文化區落成之日,其將提供佔地面積達 40 公頃的藝術和娛樂空間。對於西九文化區的規劃及發展,測量師發揮著重要作用。

西九文化區管理局項目推展行政總監陳文偉博士測量師表示,這座位處維 港海旁的國際藝術綜合園區的首期建築工程將在未來兩年逐步落成,及至 2018年,區內的戲曲中心表演場地、M+展亭藝術中心及一個佔地面積龐 大的公園均將全部投入營運。

陳文偉負責園區硬件設施建設,他指出,西九文化區彰顯規劃師、工程師、建築師、測量師與建築商之間的精誠合作。「我們必須共同克服多重困難,」他説,「首先是零事故的目標;其次,自 2008 年制定預算以來,建築成本已增加 136%,預算緊張,資金壓力非常大。第三,西九文化區位於西鐵、東涌線、機場快線及未來高鐵線四線交匯處,還有西區海底隧道,為項目帶來了土地問題和減低噪音等一連串挑戰。此外,項目還需要與不同持份者進行細緻溝通,並需時常向立法會及區議會匯報。」

儘管項目困難重重,但依然不乏喜訊佳音。採用新舊風格混合創新設計的 戲曲中心建設近日邁進新里程,於今年五月成功將 2,400 公噸的主體鋼結構 (佔劇場大小五分之三) 升頂,到達高出路面 45 米的規劃高度。西九文化 區管理局董事局主席林鄭月娥女士稱,這一重大里程碑標誌戲曲中心進入落 成倒數階段。

「單這項工程就需要進行三次,為期三個月,首先升高屋頂,最後是底座,」 陳文偉回憶道。「工程使用了六組巨型纜索,每組纜索均配有大捆鋼線。每 次作業都需要一整日,而且每一秒鐘都有多台電腦在不同檢查點進行密切監 控,以確保萬無一失。」在此之前,還必須奠定地基(2013 年後期動土) 及建設上蓋結構(2015 年初),以及進行大量測量及計算工作,以確保精 確無誤。 戲曲中心的設計靈感源自中國戲台和民間戲棚,其採用現代聲學技術及設計,旨在將中國戲曲推向新的高度。落成後的戲曲中心以茶座為特色,遊客可在裡面一邊茗茶,一邊欣賞南音音樂。

陳文偉稱:「中心佔地 13,800 平方米,位於建築頂部的主劇場設有 1,100 個座位;中部是教學、排練中心和餐廳;底部是寬敞的公共中庭。為了獲得最佳的舞台觀感,主劇場上並無任何立柱,而其位於建築頂部亦可確保建築負荷減至最低。」

儘管屋頂現時已吊升到位,測量師仍繼續參與戲曲中心的發展工作。據陳文 偉介紹,戲曲中心位於廣東道與柯士甸道的繁忙交界處,中心需要成為「盒 子中的盒子」才可滅弱外界噪音和避免結構性回音。陳文偉的團隊亦必須專 門就這種藝術形式研究特色座位和舞台設計。儘管困難多多,但戲曲中心的 最終使用者一戲曲社團熱切期盼中心早日開幕,這讓陳文偉倍感欣慰。

李家豪測量師是萊坊高級董事及地產拓展部主管,也是西九文化區管理局常任顧問,他說明該龐大項目的錯綜複雜:「西九文化區計劃包含多種土地用途,如藝術與文化、康樂、零售、餐飲、娛樂、酒店、商業及住宅等用途,當中涉及公共和私人機構之間極複雜的相互影響。例如,西九文化區管理局的任務是根據有關條例制定西九文化區發展規劃,其中文化藝術設施以及零售、餐飲及娛樂設施將屬於西九文化區管理局所有,而酒店、寫字樓及住宅的使用則可在未來向私人業主出售。」

「有見及此,我們必須考慮未來,在獲得專用批地的情況下,確保未來二、 三十年可在這幅大型土地上靈活發展。我們亦需保障不同持份者的利益,包 括西九文化區管理局、政府、未來私人業主及公眾的利益。」

李家豪稱,獲取批地是產業測量師發揮作用的主要領域之一。他解釋道,測量師就西九文化區的規劃、發展及實施擔當顧問角色,他們會從土地管理、城市規劃及建築條例等角度考慮發展管制問題,包括發展規劃、組織架構、發展潛力評估、估值、發展組合及計劃,以及相關用地申請等。李家豪說:「建築物落成後,產業測量師的職責甚至還包括銷售、租賃及物業或設施管理方面的工作。簡而言之,我們要在發展管制及法律框架內尋求最大的發展空間。」

李家豪與陳文偉一樣,關注多方土地權利所增添的複雜性,以及園區位於多個大型工程交界所帶來的地理限制。他說:「該園區與多項現行基建相交匯,包括鐵路設施、西區海底隧道、政府抽水站、私人冷水管、消防局及公用道路,而興建中的高鐵對西九文化區更具有重要的實際影響。」

「因此我們有必要與港鐵公司、九廣鐵路、香港西區隧道有限公司、水務署、政府產業署、消防處、路政署等部門互相合作。作為產業測量師,我們需要與不同持份者溝通和協調,以解決『何物歸誰』及『如何保護各方利益』等相互影響的問題。與此同時,我們亦需要提出創新方案,以促進區內整體發展。雖然區內發展會於未來自籌資金,但這終歸是一項公共使命。」

華聯建築有限公司董事龐耀寶測量師是雙層 M+ 展亭的開發人之一。M+ 展亭將是園區內首個投入營運的主要建築,計劃在今個夏天推出活動。龐耀寶所在公司是總承建商,一年前才剛剛獲判該項目,負責解決各種難題,包括完成地盤平整工程、建設地下排水設施及海底沙井,以及確保預算控制。

龐耀寶解釋道,公司採用建築信息模擬(BIM)記錄所有與設備、結構及材料相關的信息,以數碼形式詳細記錄「一柱一磚」。他表示:「雖然 BIM 意味著施工期的成本增加,但長遠來看卻有助維修保養從而節省成本,因此彰顯西九文化區項目的前瞻性。」

但與此同時,華聯建築有限公司亦需要處理 BIM 無法解決的問題。「在開幕前,我們希望解決因設計理念與具體實施之間存在差異所引致的問題,例如:那 ° 鏡 』 概念的外牆!」龐耀寶説道,「我們希望 M+ 展亭被大眾接受。」

he HKIS has continued to strengthen its collaboration and communication with the Government and professional organisations both in Hong Kong and China.

HKIS Branding and Communication

In Hong Kong, we met with Ms Janice Tse, Director of Home Affairs and her colleagues over lunch to exchange views on the importance of proper building repairs and maintenance, and also the concerns over bid-rigging. A lunch meeting with Mr Paul Chan, Secretary of Development and his colleagues was also fruitful, with discussions including the four divisional themes of the HKIS this year and proof of ownership for building plans submission. The supply of flats through the lease modification route has reduced significantly in recent years and the Secretary considered that such reduction was attributed to two major factors: the regular supply of residential development land by the Government and the downward trend of residential land prices. These market relationships are worth further research. Lease modifications had, in the past, made a significant contribution to the good use of leasehold land resources; it is important for this practice to continue serving the needs of Hong Kong. We also met with Mr KK Ling, Director of Planning and his colleagues at a drinks

gathering. Our members exchanged views with senior planning officials on subjects including CDA zoning, new town development, and the use of brownfield sites.

At recent regular gatherings amongst five professional institutes (HKIA, HKIE, HKILA, HKIP and HKIS), we discussed the business outlook for private practices in the construction industry, including the challenging operating environment for some architectural practices. The HKIS also launched a survey to gather the views of firms in the construction industry.

Strengthening Connections in China

China presents a lot of opportunities for surveyors. In our regular visit to Beijing this June, we met different Government Ministries and bodies relating to our profession, including the Ministry of Housing and Urban-Rural Development, the National Administration of Surveying, Mapping and Geo-information, the Ministry of Land and Resources, and the Ministry of Finance. We also met with different professional organisations related to these authorities and discussed such subjects as mutual recognition of qualifications, professional development, and co-operation between international and regional professional organisations. Our visit also included Shanghai. Dinner gatherings were arranged with our members working in China and guests in both cities. I received feedback from members that the HKIS should hold more activities for members and increase its influence within China.

Separately, I also joined part of the 9th National Congress of the China Association for Science and Technology (CAST) in June. CAST is China's largest national, non-governmental organisation of Chinese scientists, engineers and other people working in the fields of science and technology.

Young Surveyors Group

Congratulations went to our Young Surveyors Group for their wins in the Dragon Boat Competitions held at Stanley Main Beach this

year, including the race amongst professional institutes. A senior member of the Stanley Dragon Boat Association thanked our Institute for its land surveying expertise in determining results for races (with high precision up to 0.01 seconds). Races proceeded more smoothly and disputes were kept at a minimum.

High Quality CPD Events and Diversity

The HKIS organised 178 CPD events in 2014 and 166 in 2015. Members have a large choice of good quality events to attend. I have to thank our many CPD organisers for their big effort in organising these events and making them successful. The Institute will continue to make improvements to the CPD arrangements, including the IT facilities.

Female membership within the HKIS has continued to grow and we now have 1,852 corporate members (including 31 fellows) who are female. In terms of percentage, females account for 30% in the corporate member grade and only 6% in the fellow grade. Many of our councils and committees have few female members. The Institute's work would benefit from the views and expertise of more female members. I encourage more female members to participate in the work of the Institute and to become fellows so as to qualify for senior posts within the Institute.

港測量師學會一直積極與香港及內地的政府部門及專業機構加強合作及交流。

香港測量師學會品牌與交流

在香港方面,我們與民政事務總署署長謝小華女士及署方同事進行午餐聚會,就適當開展樓宇維修保養的重要性及「圍標」等關注話題交流見解。透過與發展局局長陳茂波先生及局方同事舉行午餐會,我們亦獲益良多。在午餐會上,我們討論了本年度學會四個專業組別的主題,以及提交建築圖則涉及的業權證明。近年透過契約修訂供應的房屋大幅減少。局長認為,這種情況可歸因於兩個主要因素:政府定期提供住宅發展用地及住宅用地價格下調的趨勢。這些觀點值得進一步研究。過往,契約修訂讓私人土地資源得到善用,可謂貢獻良多;此等做法實有必要延續,藉以繼續滿足本港的需

要。我們亦與規劃署署長凌嘉勤先生及署方同事在酒會上會面。學會會員就綜合發展區地帶、新市鎮發展及棕地土地用 途等議題,與高級規劃官員交流意見。

最近,在五個專業學會(香港建築師學會、香港工程師學會、香港園境師學會、香港規劃師學會及香港測量師學會)的定期聚會中,我們商討建造業私人企業的業務前景,包括多間建築師事務所現時所面對極具挑戰性的營運環境。本會最近亦進行一項調查,向建造業界的企業收集意見。

加強與內地的聯繫

中國內地為本港測量師提供大量機會。我們於6月前往北京展開定期訪問,期間與多個政府部門及業界相關機構代表會面,當中包括住房和城鄉建設部、國家測繪地理信息局、國土資源部、及國家財政部。我們亦與這些部門及機構有聯繫的多個專業機構會面,探討資格互認、專業發展、國際及地區專業機構之間的合作等議題。我們亦前往上海參觀訪問。在京滬兩地,均與本會內地會員及嘉賓共進晚宴。本人亦收到會員的反饋,建議本會在內地開展更多會員活動及加強在內地的影響力。

此外,本人亦於 6 月參與中國科學技術協會(中國科協)第 九次全國代表大會的部分議程。中國科協是中國最大的科學 家、工程師和科技專業人士的非政府組織。

青年組

本人在此祝賀本會青年組在今年赤柱正灘舉行的龍舟競賽上 (包括專業團體組)奪得勝利。赤柱龍舟協會的一名資深會 員向本會致謝,感謝本會在近年的賽事當中就裁定賽果提供 土地測量方面的專業意見(精確度高達 0.01 秒),讓比賽得 以順利進行並大幅減少爭議。

高質素持續專業發展活動及多元化

學會於 2014 年及 2015 年分別舉辦 178 項及 166 項持續專業發展活動,會員有大量高質素的活動可供選擇。本人謹藉此機會,衷心感謝各位參與組織持續專業發展的會員,為成功舉辦活動所付出的努力。本會將繼續改善持續專業發展活動的安排(包括資訊科技設施)。



The HKIS has long strived to build closer regional ties with relevant authorities and professional bodies in mainland China and since the signing of the Closer Economic Partnership Arrangement (CEPA) has held regular visits to Beijing to expand and strengthen those ties.

Through these visits, participants have the opportunity to update themselves on the latest industry regulations and policies, conduct professional knowledge exchanges, and foster greater cooperation between the surveying industries of Hong Kong and China.

In June 2016, delegates from HKIS travelled to Beijing and Shanghai to meet with senior officials from the central government and visit the sites of two development projects. Sr Lau Chun-kong, President of the HKIS, called the event a great success, as the level of reception was the highest in recent years. The visit also featured the largest number of delegates so far, at 22.

During the two-day stay in Beijing, delegates met with several government and professional bodies related to the surveying sector. One of the highlights was meeting senior central government official Yi Jun, Vice-minister of the Ministry of Housing and Urban-Rural Development.

Led by Sr Lau, delegates had an in-depth conversation with Yi on how local surveyors can make contribution to the Belt and Road Initiative. "We touched on enhancing mutual recognition of professional qualifications between Hong Kong and China. We also explored the possibilities of having surveyors from the mainland register as members of the HKIS," Sr Lau said.

Sr Stephen Lai Yuk-fai, Past President and Chairman of the Mainland Affairs Committee at the HKIS, was excited about the opportunities that the Belt and Road Initiative had for surveyors. He recalled that National People's Congress Chairman Zhang Dejiang expressed a high opinion of local surveyors during his visit to Hong Kong in May.

"During the Belt and Road summit, Zhang acknowledged the achievement of our profession by pointing out that the building projects supervised by Hong Kong surveyors in Nepal were not damaged in the 2015 earthquake. His words are recognition of the high quality of service that Hong Kong surveyors provide," Sr Lai said.

Sr Lau added he was glad to know that many surveying governing bodies on the mainland were positive about fostering a closer relationship with Hong Kong surveyors. This has boosted the confidence of local surveyors who are considering working on the mainland, he explained.

Going forward, Sr Lau added, the HKIS would continue to provide more events for local surveyors to learn about opportunities on the mainland and how they can support work there. "In the past two to three decades, the surveying profession on the mainland has grown by leaps and bounds. We are looking forward to providing members with more opportunities to visit the mainland. A closer collaboration between Hong Kong and mainland China is beneficial for both sides," Sr Lau said.

Echoing Sr Lau's opinion on increased collaboration, Sr Lai said the recent visit was a great opportunity for local surveyors to promote their services. "We are looking forward to expanding the scope of services across all six of our divisions in the mainland. During the visit, we took the chance to explain the strengths of local Hong Kong surveyors and we look forward to having more involvement in mainland projects," he said.

Sr Y L Wu, Chairman of the HKIS Beijing Forum, expressed hope that, with enhanced collaboration, surveyors in Hong Kong would be able to play a bigger role in mainland projects.

Sr Wu said the experience and professionalism of local surveyors could add great value to the mainland market. "Currently, local surveyors hold managerial roles in mainland projects, but we have a lot more to offer. Similar to Hong Kong, cities on the mainland are undergoing rapid development. We can definitely share our expertise and experience regarding urban renewal projects," Sr Wu said.

With better mutual recognition of professional qualifications, Sr Wu hoped, more local professionals would consider developing their careers on the mainland.

During the stay in Beijing, delegates also met with Kurexi Maihesuti, Vice Minister of the Ministry of Land and Resources and also the Director General of the National Administration of Surveying, Mapping and Geoinformation. Maihesuti discussed setting up mutual recognition of professional qualifications with HKIS, and said he looked forward to having closer collaboration with Hong Kong surveyors. He also encouraged Hong Kong surveyors to participate in The 8th Cross-Strait Geomatics Conference, which will take place in November in Xiamen.

Delegates also met with officials from Ministry of Finance, Ministry of Land and Resources, and representatives from the China Appraisal Society and China Real Estate Valuers and Agents Association, and discussed mutual recognition of professional qualifications for surveying professionals working on asset valuation and land valuation, which will benefit the General Practice division of HKIS.

During the stay in Beijing, delegates also visited the Hong Kong and Macau Affairs Office of the State Council and the Ministry of Commerce.

After two days in Beijing, delegates travelled to Shanghai, where they were welcomed by the United Front Work Department and paid visits to two of the city's mega-development projects, namely the Hongqiao Transportation Hub, which includes an airport and a network of

railways, and the West Bund waterfront area.

Sr Iris Lee Pui-wa, Chairlady of the HKIS Shanghai Forum, was impressed by the scale of the Hongqiao Transportation Hub and the integration of transportation means and commercial developments and said that surveyors from Hong Kong had a lot to offer in development projects on the mainland.

Sr Lee added that the West Bund development project is quite similar to the West Kowloon Cultural District in Hong Kong, as both involve setting up spaces for arts and culture activities. The West Bund development model is the first of its kind in China, as it has a single developer in charge of the underground development and a number of developers taking on projects on the ground. "It is an eyeopener for us to see these projects," she said.

Looking forward, Sr Lee said she hoped the visit gave mainland authorities a glimpse at what surveyors from Hong Kong are capable of, and that they would allow local surveyors to have more involvement in government projects.

Delegates also met with representatives from The Architectural Society of Shanghai China and the Shanghai Society of Civil Engineering. "The Chinese government is driving the move to adopt a similar project management approach as that of Hong Kong. In China, the architect is normally in charge of design only and often not being involved in construction stage. In recent years, some pioneer projects in China have employed a cross-disciplinary approach, with the "authorised person" leading engineers, surveyors and other professionals to execute the project from start to finish. The professional institutions should work closely to promote this approach," she said.

Sr Edgar Li, Vice-chairman of the HKIS Guangzhou Forum, found the visit encouraging. Many surveying professionals are considering expanding their involvement on the mainland due to the huge market on real estate projects. He said that, after the implementation of CEPA, the cross-border collaboration among professionals can be progressively made. There have been more opportunities since the new agreement was introduced this year and The Belt and Road Initiative was launched.

As well as fostering closer collaboration, mainland authorities encouraged local surveyors to have more involvement in international professional surveying bodies.

"This is in line with the nation's policy to have more presence internationally," Sr Li said. "Mainland authorities hope surveyors from Hong Kong can continue our contribution to these international bodies and share our best practices with counterparts from around the world."

「現時,本港測量師在內地項目中擔任監理職責,但我們還可以做得更多」

香港測量師學會代表團最近赴北京和上海進行 CEPA 參觀訪問,探討與內地同行進行多項合 作,以加強測量專業的區域發展。

長期以來,香港測量師學會一直致力與中國內地的有關當局和專業 團體建立更緊密的區域連繫。自《內地與香港關於建立更緊密經貿 關係的安排》(CEPA)簽署以來,香港測量師學會定期到北京參觀 訪問,以擴大和加強兩地連繫。

透過這些探訪活動,代表團成員均有機會了解最新行業規定及政 策,互相交流專業知識,促進中港兩地測量行業深入合作。

2016年6月,香港測量師學會代表團到北京和上海面見中央政府 的高級官員,並參觀了兩個發展項目現場。香港測量師學會會長劉 振江測量師稱活動圓滿成功,接待規格亦是近年最高。是次探訪活 動的另一個特點是代表團人數為歷來之最,共有22人。

於北京逗留兩日期間,代表團與多個跟測量行業有關的政府機關和 專業團體會面。其中,與國家住房和城鄉建設部副部長易軍會面是 活動的焦點之一。

於劉會長帶領下,代表團與易副部長進行了一次深入交流,探討本 港測量師如何就「一帶一路」倡議作出貢獻。劉會長表示:「我們 研究加強中港兩地的專業資格互認,亦探討內地測量師註冊成為香 港測量師學會會員的可能性。」

香港測量師學會前會長兼內地事務委員會主席賴旭輝測量師對「一 帶一路」倡議為測量師帶來的機遇感到興奮。他回憶起全國人民代 表大會張德江委員長在5月訪港期間對本港測量師的高度評價。

他表示,「於『一帶一路高峰論壇』上,張德江肯定了我們的專業 成就,他指出由本港測量師監理的尼泊爾建築項目在2015年地震 中沒有受損。這是對本港測量師高質素服務的認可。」

劉會長亦表示喜聞內地許多測量管理機構對於促進與香港測量師的 更緊密聯繫持積極態度。他説這為考慮在內地工作的本港測量師增 加了信心。

劉會長補充指,香港測量師學會未來將繼續為本港測量師提供更多 活動,讓他們了解內地存在的機遇及如何支持當地的工作。劉會長 説:「過往二、三十年間,內地測量專業發展如日方中。我們希望 為會員提供更多到內地探訪的機會。香港與內地加強緊密合作對兩 地有利。」

響應劉會長關於加強合作的意見,賴測量師亦指近期探訪活動是本 港測量師推廣服務的良機。他表示:「我們希望將轄下全部六個組 別的服務範圍拓展至內地。於探訪期間,我們亦藉機會展示香港測 量師的優勢,期望參與更多內地項目。」

香港測量師學會北京議會主席胡煜琳測量師亦表示希望绣過加強合 作,香港測量師能夠在內地項目中發揮更大作用。

胡測量師表示,本港測量師具備的豐富經驗和專業技能可為內地市 場增加巨大價值。他説:「現時,本港測量師在內地項目中擔任管 理工作,但我們還可以做得更多。同香港一樣,內地城市在快速發 展,我們在市區重建項目方面的專長和經驗定能與他們分享。」

隨著專業資格互認趨於完善,胡測量師希望更多本地專才會考慮在 內地發展事業。

探訪北京期間,代表團亦面見了國家國土資源部副部長及國家測繪 地理信息局局長庫熱西•買合蘇提。庫熱西談論與香港測量師學會 建立專業資格互認,他説期待加強與香港測量師的緊密合作,同時 亦鼓勵本港測量師參與11月於廈門舉行的第8屆海峽兩岸測繪發 展研討會。

代表團一行亦面見了國家財政部、國家國土資源部的官員,以及中 國資產評估協會、中國土地估價師與土地登記代理人協會的代表, 並就資產估值及土地估值方面測量專業人士的專業資格互認進行了 討論。香港測量師學會的產業測量組將從中受惠。

在京期間,代表團亦拜訪了國務院港澳事務辦公室及國家商務部。

代表團在京訪問兩日後赴上海,在當地受到統一戰線工作部的歡 迎,並考察了兩個市內大型發展項目,其中包括虹橋交通樞紐(內 有一個機場和一個鐵路網絡)及上海西岸濱水區。

香港測量師學會上海議會主席李佩華測量師對虹橋交通樞紐的規模 之大,以及對交通方式與商業發展的整合留下了深刻印象。她表示 本港測量師在內地發展項目上大有用武之地。

李測量師亦提到,上海西岸發展項目與香港的西九文化區十分相 似,兩者均為打造藝術及文化活動場地。上海西岸發展模式是內地 同類項目之首創,項目由單一發展商負責地下建設並由多個發展商 開發地面項目。她說道:「這些項目令我們大開眼界。」

展望未來,李測量師希望透過探訪活動,內地當局能對香港測量師 的能力有所了解,並允許本港測量師參與更多政府項目。

代表團一行亦會見了上海市建築學會代表及上海市土木工程學會代 表。她表示,「中國政府現鼓勵採用的項目管理方法與香港的相似。 目前建築師於內地項目中往往僅負責設計而未參與施工階段的管理,近年內地已有若干先行先試的專案採用了跨專業的管理方法, 由『認可人士』帶領工程師、測量師及其他專業人士自始至終地貫 徹執行項目。專業機構應合作推廣這種方法。」

香港測量師學會廣州議會副主席李國華測量師認為探訪活動對測量 專業人才起到鼓勵作用。由於內地地產項目市場龐大,很多測量專 業人才考慮擴大參與內地的活動。他亦表示,自 CEPA 實施後,兩 地專才的跨境合作有望迅速發展。隨著本年引入新協議(服務貿易 協議)和「一帶一路」的啟動,都為測量界帶來了更多機遇。


除了促進更緊密合作之外,內地當局亦鼓勵本港測量師參與更多國 際專業測量機構活動。

上海议会CPD活动

考察世茂佘山深坑酒店

2016年6月4日,上海议会组织 CPD 活动参观位于上海市佘山之世茂「深坑酒店」。作为世界上第一个建在废石坑里的五星级酒店,早在2013年开工当年,深坑酒店就被入选拍摄美国国家地理频道《伟大工程巡礼》系列纪录片,摄制组从最初施工开始就进驻工地,全程记录了酒店的建设过程。深坑酒店以其反向天空发展的建筑理念,充分利用深坑的自然环境并向地表以下开拓建筑空间的做法成为建筑界革新的又一创举。

工程师陆道渊先生受邀参加,为大家分别介绍了本项目的各项特色、创举以及建筑难点等。与会者不禁感慨,这样一个极其复杂、浩大的工程,施工过程面临无数史无前例的技术难题,项目团队凭著自身的专业知识及先进的创新科技,有效地解决了各项难题,并获得了多项创新专利。

讲座结束后参观者一行 30 多人前往工地现场实地考察,并且非常荣幸地参观了从未对外开放的酒店客房样板间,其设计利用了周边环境资源,充分展现了酒店所处旧矿场的特色。大家搭乘架设在塔吊两边的施工电梯从地面垂直下降到深80米的坑底,抬头仰望天际之下整个酒店,四周岩壁包围,让人感受到无比震撼的壮观。

建成后的酒店,坑内建筑 16 层包括水下建筑 2 层,坑外建筑 3 层设有蹦极等娱乐项目。整个酒店包含天然室内花园、大型景观瀑布、景观总统房和水下情景房等。世茂佘山深坑酒店海拔为负 80 米,有望成为全球人工坑内海拔最低的酒店。

酒店计划于 2017 年底开业,让我们拭目以待。



SCALES OF PROFESSIONAL CHARGES

The General Council has sought legal advice on the implications of the Scales of Professional Charges and Rules 1.2.5 and 1.2.6 of the HKIS Rules of Conduct under the Competition Ordinance (Cap. 619).

The Scales of Professional Charges have already been suspended and will not be reissued. The HKIS had previously announced to members on 11 December 2015 that the Scales of Professional Charges (or Fees Scales) would no longer be in effect and would be withdrawn from that date.

The General Council has planned to arrange an Extraordinary General Meeting in September 2016 to address inter alia the abolition of Rules 1.2.5 and 1.2.6 of the HKIS Rules of Conduct. A copy of the Rules of Conduct is available from the HKIS website at www.hkis.org.hk.

The HKIS does not encourage its members to apply or otherwise give effect to the Scales of Professional Charges and the above two Rules. HKIS members should seek independent legal advice about the potential risk of doing so.

The HKIS Outstanding Dissertation/ Thesis Awards 2015 **Executive Summary of** Winning Papers

MODELLING OF PEDESTRIAN BEHAVIORAL DYNAMICS IN **COMPLEX URBAN SETTING** AND BUILT ENVIRONMENT

Grand Prize (PhD) Awardee: WANG Weili **City University of Hong Kong**

Understanding pedestrian movement patterns through space is important for transportation scientists, urban designers, and retailers. However, given heterogeneous and complex properties, how pedestrian behaviours can be realistically reproduced remains an open issue. Computer simulation models provide a potential means through which the interactions between pedestrians and different spatial environments can be revealed at the microscopic level. A hybrid agent-based pedestrian behaviour simulation model – CityFlow-U – was developed for this study to reproduce various realistic pedestrian movement behaviours in complex urban settings and built environments.

The section-and-portal graph approach was proposed to facilitate pedestrian navigation in an environment where the sections were divided into four subsets according to neighborhood numbers and linked portal characteristics. The model in this study was implemented at three different levels, namely the strategic level, the tactical level and the operational level.

- The Strategic Level: elements at this level deal with the nature of trips, activity-scheduling, and time-budgeting.
 - The Tactical Level: two different routing strategies were considered. One was The Goal-Oriented Static Navigation Module that is utilised when pedestrians are familiar with their environments and had specific destinations, while the other was The VGA-Based Dynamic Navigation Module that dynamically investigates situations in which pedestrians have no specific destination. The results of the visibility graph analysis (VGA) of the spatial environment were innovatively used as an important reference for pedestrians' dynamic routing decisions, as it was reported that their general movements were directed along their lines of sight. Along with other significant factors, The VGA-Based Dynamic Navigation Module reproduced realistic trails and microscopically generated natural movements. Its reliability and flexibility were demonstrated by comparing the simulated results of pedestrian movements with the empirical spot count and trail data obtained from the earlier literature on Britain's Tate Gallery.
- The Operational Level: involves the implementation of pedestrian locomotive behaviours described in The Goal-Directed Locomotion Module and The Exploratory Locomotion Module. In the former module, aside from common behaviours that include steering and collision avoidance, emergent behaviours such as attracted movements and side-by-side walking groups were examined,

illustrated explicitly, and reproduced with considerable credibility. The Exploratory Locomotion Module was developed to innovatively reproduce pedestrian exploratory behaviour through which a rarely-explored activity choice behaviour, impulse stop, was successfully reproduced using simple heuristics. Moreover, observational studies on pedestrian exploratory behaviour in a shopping mall were carried out and the credibility of the module was demonstrated by the good uniformity of simulated impulse stop behaviour and data in the empirical video.

"Walkability' is a measure of the livable urban form," which is affected by rapid and intense urbanisation worldwide. Dhaka, Bangladesh is an example of an uncontrolled and fast-growing city that now faces the challenge of creating a livable and healthy urban environment, especially in newly-planned residential areas where comfortable, walkable streets are almost absent. Automobile-dominated and newly-planned residential sprawl severely compromises pedestrian mobility in terms of

accessibility, safety, comfort, etc. This study investigates the thermal comfort condition of the walkability of two different street fabrics in Dhaka. It starts with a theoretical review of "pedestrian-friendly community development" while looking into case studies and standards in order to synthesise "walkability" matrices. It then proceeds to a comparative analysis of the walkability between newly-planned residential (Bashundhara R/A) areas and historic settlements (Shakhari bazar) while taking into account their street fabric as a variable of outdoor thermal comfort in the context of a sub-tropical city like Dhaka. The next step is the calculation of thermal comfort indices to determine the comfort conditions of the historic and new street fabric using simulation software, "City Comfort +" (Jianxiang et al. 2014). Scientific tools are used to collect site-specific microclimatic data for thermal comfort. To understand users' responses to the comfort sensation and walkability of the street, observations and questionnaire surveys are conducted. Survey data are then synthesised to determine the matrix between the street fabric and thermal comfort condition. The aim is to develop and recommend a checklist of comfortable streetscape elements and potential design features from the historic street fabric and reinterpret these features for a selected study area to investigate the scope of improvement in the outdoor thermal comfort and streetscape (and, thus, walkability) of these areas. The outcome is tested by "City Comfort +". The conclusion suggests some urban design options for achieving a more effective and comfortable streetscape for the streets of the Bashundhara Residential Area in Dhaka.



Updates on the Registered Fire Engineer (RFE) Scheme

The Security Bureau issued a letter to the HKIS on 19 May outlining the RFE qualifications framework and confirming the positive vetting of the proposed amendment bill. The proposed RFE qualification accepts professionals with relevant academic qualifications, such as a building surveying degree, or experienced building surveyors to register as RFEs if they meet the requirements of the top-up course and have relevant work experience. The Fire Expert Panel considers the RFE qualification framework acceptable in principle, but the relevant work experience and contents of the top-up course should be further examined. A response was issued to the Security Bureau on 2 June.

Promoting the Building Surveying Profession

As resolved by the BS Council, the BSD is tasked with expanding its exposure and reinforcing its professional image. To achieve this, the Promotion and Publication Panel, led by the Vice Chairman, Sr Kenny Tse, has been working hard to formulate the means and contents of its promotional materials. Do keep a close eye on the latest news in this column.

BSD Volunteer Team on Green Roof Inspections

After announcing green roof inspection services for schools and charitable organisations during its press conference on 25 May, the BSD has received 26 green roof inspection applications. To meet this demand, around 53 BS volunteers

have offered to provide such services. Briefing sessions for applicants and volunteers were held on 13 June to inform each party of the services it would deliver or receive, along with aligning the inspection technique. It is the BSD's honour to have members of the Hong Kong Institute of

Landscape Architects (HKILA) join the volunteers to advise on landscape matters. Apart from that, the BSD will collaborate with the HKILA to prepare a green roof guide for laymen/professionals.

The seminar will be held on the morning of 9 July at the Diocesan Girls' School. The BSD is delighted to have its Past Chairman, Sr David Chan, represent it by presenting topics on "Preinspection desk study, site inspection, and aspects of ongoing maintenance management of green roofs".

HKIS Visit to Beijing

I joined a HKIS visit to Beijing, where the group, including Mainland Affairs Committee member, Sr Edgar Li, met with representatives of various government departments/bureaus and professional bodies from 12-14 June. The purposes of the visit were to strengthen connections with the HKIS's Mainland counterparts, learn about the latest real estate legislation, and mutually recognise each other.

Lunch Gatherings with the Director of Home Affairs and Secretary for Development

Along with the HKIS President, Sr CK Lau, and other EC members, I attended two lunch gatherings with the Director of Home Affairs and Secretary for Development on 6 and 10 June, respectively. The Director of Home Affairs was very concerned about the management and bidrigging issues in strata-titled buildings. It was suggested that the HKIS form a working group with the Home Affairs Department to address these issues. During the second gathering, the Secretary for Development focused more on land supply and administrative issues with the aim of meeting the public's demands concerning land development.

學會理事會分別於6月6日及6月10日以午餐會形式與 特區政府首長級官員會面。當中民政事務總署署長對建築 業圍標及分散業權物業之管理維修表示關注,並希望測量 師學會能與民政事務署成立專責小組研究改善。發展局局 長則著重討論本港現今土地資源議題。



HKIS Visit to Beijing (12-14 June)

During the HKIS visit to Beijing, GPD Vice Chairman (External Affairs) Sr Alex Lam and I met with representatives of the China Institute of Real

Estate Appraisers and Agents (CIREA), China Real Estate Valuers and Agents Association (CREVA), and China Appraisal Society (CAS). Below is a summary of our discussions.

CIREA

- 1. It did not object in principle to the 3rd Reciprocity arrangement between itself and the HKIS. The approval application among the different departments is in progress.
- 2. A joint CPD organised by the CIREA, HKIS, and Shenzhen Institute of Real Estate Appraisers (SIREA) will be held in Shenzhen on 19 August 2016.
- 3. During the meeting, the HKIS requested that representatives of the Ministry of Housing and Urban-Rural Development allow it to discuss with other valuation organisations, namely the CREVA and CAS.

CREVA

1. It did not object in principle to the reciprocity agreement between itself and the HKIS. However, CREVA representatives pointed out that the Asset Appraisal Act will pass in 2016. This Act will affect the reciprocity arrangement. The respective regulations and rules will be issued in due course. The CREVA will be able to discuss with the HKIS after the regulations and rules are prepared.

CAS

- 1. It agreed, in principle, with the reciprocity agreement between itself and the HKIS.
- 2. It suggested that the following terms be included in the reciprocity agreement:

- a. the number of candidates from each institute to be set at 100:
- b. five years of post-qualification experience in business valuation;
- c. 3-5 days of intensive training before a written examination/interview:
- d. candidates should fulfill the CPD requirements of their respective institutes: and
- e. an annual review of the work undertaken by practitioners will be executed by the CAS (note: no annual review will be needed for non-practitioners).
- 3. The HKIS and CAS agreed to cooperate on the issues at the IVSC and WAVO.

GPD Public Forum: Consultation on Reciprocity Recognition with the RICS, CREVA, and CAS

The GPD planned to organise a public forum this year to gather members' views on the reciprocity recognition arrangement with the Royal Institution of Chartered Surveyors (RICS), China Real Estate Valuers and Agents Association (CREVA), and China Appraisal Society (CAS). The purpose is to decide if the HKIS's reciprocity recognition of these respective organisations should proceed. Background information will be shared with members for their information and the meeting format will be announced later.

Sharing Session with the Secretary for Development

On the evening of 16 June, Legislator Sr. Tony Tse organised a sharing session for over 100 attendees from the Architectural, Surveying, Planning and Landscape constituency. Speakers included the Secretary of Development, Mr Paul Chan, and directors of the Lands, Buildings, and Planning Departments in Room 502 of LegCo headquarters. The 1.5hour meeting was characterised by vehement enquiries and frank replies, along with intermittent elaborations made by the host. Five land surveyors raised the most questions, which comprised about one-third of all the questions during the sharing session.

The first question from a land surveyor, addressed to Mr Chan, concerned the government's arrangements and policy on smart cities. Mr Chan informed the audience of detailed projects like the smart traffic control and intelligent car-parks in Kowloon East. He confirmed that the Government is now making a blueprint of a smart city, which is now being handled by Mr Nicholas Yang of the Innovation and Technology Bureau. Mr Chan also mentioned that the Development Bureau is now working on the Spatial Data Infrastructure, so a common spatial data platform will be considered. Sr Tse reminded the Secretary and directors to hire more hands for extra government tasks. His comment received the immediate applause of most of the audience.



A smart city relies on free access to wellstructured land data. Sr S C Leung followed the supply of government data, which states

that government officials have to change their attitudes and make more government data available to all citizens.



"For future development, the existing 200,000 lots in the New Territories are best available land resource," Sr Chan Hak remarked. "Thus, the government should consider amending the Land Survey Ordinance so that these land boundaries can be re-established with legal sanction." The Director of Lands, Ms Bernadette Linn, addressed Sr Chan Hak as "senpai" and explained that the Lands Department had considered the issue. Yet, in practice, it is a complicated legal issue, as even a minor change to a land boundary law may trigger many situations that need to be addressed. Ms Linn said the amendment was not considered an imminent task.

Sr Johnny Lau pointed out that many Chinese cities have implemented BeiDou satellite positioning, wi-fi, and GIS systems as basic elements in their smart city projects. The Secretary remarked that China has moved ahead of Hong Kong, so the latter's mission, to be led by the Innovation and Technology Bureau, is to catch up. The Development Bureau will continue to work on the common standard of spatial data.

Sr Lam Lit Yin, representing the engineering surveying sector, brought up the issue of asbuilt surveys. He pointed out that too many public construction projects had performed no real as-built survey. Many so-called asbuilt plans were just engineering design plans. A smart city's as-built BIM is critical. Hong Kong cannot afford such a mistake again. The Secretary pondered Sr Lam's point and replied that the Works Branch will consider this issue.



International Land Measurement Standard (ILMS) Coalition

The HKIS has been invited to join the ILMS. This international surveying institutional coalition works within a land information framework that analyses the systemic elements of land rights, land transactions, and exchange processes. The HKIS will join this coalition because its General Practice, Planning Development, and Land Surveying Divisions perform similar work to that of the ILMS.

HKIS Visit to the National Surveying Bureau in Beijing

President Sr C K Lau led HKIS delegates, including the LSD's Sr Koo Tak-ming and Sr Olivia Chiu, on a visit to Beijing from 12-14 June. Sr Koo brought back news stating that the HKIS expects to strengthen its connections with the National Administration of Surveying, Mapping and Geoinformation Bureau and to support and participate in international surveying activities conducted by the International Society for Photogrammetry and Remote Sensing and the International Federation of Surveyors. The mutual recognition of registered land surveyors by both sides should be enhanced. Also, they wish to meet more land surveyors in the coming



8th Cross-Strait Geomatics Conference. Sr Koo and Sr Chiu exchanged development information with their Mainland colleagues on UAVs, BIM, Common Spatial Data Infrastructure, and big data on property.

We had a good discussion on our respective roles in China and Hong Kong and plan to hold a joint conference in Beijing during the second half of 2017.

The Property Management Services Ordinance

Hong Kong's property management industry is about to change for the better, which includes becoming more "professional," following the conclusion of the third reading of the Property Management Services Bill (hereafter the Bill) on 26 May. On that date, the PFMD issued a press release on the passing of the Bill. I want to highlight the terms of the new ordinance for members here.

Property management companies and practitioners are currently not subject to any regulatory control. The Government proposed a regulatory regime for property management under the Bill, which was published in the Gazette on 25 April and introduced to the Legislative Council on 7 May. Passed on 26 May, the now-Property Management Services Ordinance (hereafter the Ordinance) prescribes a licencing regime for property management companies and practitioners and will be enforced by a new statutory regulator and standards promotion body. The Ordinance aims, among other things:

- 1. To establish a Property Management Services Authority to regulate and control the provision of property management services with the power to enforce statutory provisions, issue a Code of Conduct, institute disciplinary actions, etc.;
- 2. to introduce a single-tier mandatory licencing regime for property management companies; and
- 3. to introduce a two-tier mandatory licencing regime for property management practitioners (i.e., registered professional property managers and licenced property management officers).

There are, of course, many challenges ahead for us in the property management services industry. The passing of the Ordinance is merely the first step towards the implementation of the regulatory regime. But future developments and the promotion of the regime are actually more important. On one hand, many unclear details will have to be addressed by subsidiary legislation, so the Administration should release such details as soon as possible after adequate consultation with stakeholders. On the other hand, the industry looks forward to announcing the PMSA's membership roster with much anticipation.

Passing of "Property Management Services Bill" **Ensures Enhancement of Industry Standards**

The HKIS to continue support the Property Management Services Authority

The Hong Kong Institute of Surveyors (HKIS) is pleased to see the passing of "Property Management Services Bill" (The Bill) by an overwhelming majority in the Legislative Council today. With the enactment of the licensing regime, property management companies and professionals will be required to meet with specified criteria, thereby raising professional standards of the industry as a whole. HKIS is looking forward to discussing with the to-be-established Property Management Services Authority (PMSA) on such subjects as formulation of regulatory guidelines and licensing criteria which would be commensurate with current professional standards.

The HKIS Property and Facility Management Division Chairman, Sr Prof Eddie Hui. commented, "We expect the quality of property management services will improve significantly as a result of the passing of this Bill. Property management companies will strive for raising their service standards, and so will the personnel of the industry, in compliance with the licensing requirements. Such effort will enhance corporate and professional image, while at the same time further guarantee safety of the general public. By and large, this helps the industry attain sustainable development goals in the long

The Institute opines passing of the Bill is only a starting point. The industry will look forward to seeing how PMSA further establishes the licensing requirements within the new regulatory regime.

"We are concerned about the structure of the new PMSA. We strongly recommend that the forming of PMSA include one member from each of the related professional bodies including the HKIS, whereby industry opinions can be delivered efficiently. The professionals are able to render expert opinion on, for instance, the formulation of rules of conduct, arbitration of disputes and complaints, and assessment of the quality of continual professional development." said Sr Prof Hui.

CPD: Control of New Buildings in Hong Kong on 28 May 2016 (by Sr Gigi Mok)

Thanks to Sr Anderson CB Chan and Sr Edward Au for discussing in front of a full house the Control of New Buildings in Hong Kong, including the application process for an occupation permit (OP), temporary occupation permit (TOP), and certificate of compliance (CC).



CPD: Duty of Care of the Occupational Safety & Health of Employees in Hong Kong & the Sharing of Judgements from Court of Final Appeal Cases on Fatal Accidents at Construction Sites on 1 June 2016 (by Sr Gigi Mok)

We were honoured to have Dr Wong, the Managing Director of YY Wong Safety Consultants, Ltd, deliver a seminar on the duty of care of the occupational safety & health of employers and occupiers of

industry. Dr Wong used two judgements from Court of Final Appeal cases on fatal accidents in construction as illustrations. He mentioned that the prior identification of hazards can reduce the chances and consequences of accidents. He also showed how to identify hazards and conduct risk assessments to develop controls to mitigate the risk of accidents.



CPD: Damage Assessment on a Reinforced Concrete Building after a Fire Attack on 3 June 2016 (by Sr Gigi Mok and Sr Kenneth Wan)

It was our honour to have Ir Prof Wong Yuk Lung deliver a seminar on 3 June. Prof Wong addressed the damage mechanisms of concrete under elevated temperatures during his presentation, which used a case study to illustrate the procedure of assessing various damage levels of reinforced concrete

buildings after fire attacks and the associated repair methods. Finally, Prof Wong discussed how to prevent the explosive spalling of highstrength concrete under fire, as recommended by the current Code of Practice of



Structural Use of Concrete 2013.

Technical Visit to the District Cooling System at Kai Tak Development (KTDCS) on 11 June 2016 (by Sr Gigi Mok, Sr Frank Poon, Sr Kendy Chek, and Sr Sana Shek)

YSG visited the District Cooling System at Kai Tak Development (KTDCS) on 11 June. It is a large scale, centralised air-conditioning system that provides chilled water to user buildings for airconditioning purposes. Chilled water is produced at central DCS plants and then distributed to user buildings via a water-piping network. To promote greater energy efficiency and conservation, the Government is implementing a district cooling system at Kai Tak Development. The KTDCS is the first project of its kind to be implemented by the Government in Hong Kong. This technical visit brought the participants to the North Plant



of the KTDCS and its E&M installations, which included chillers, pumps, and other DCS equipment. Special thanks go to Mr Tommy Lo and KTDCS representatives for providing us with an informative tour.

PDD + YSG Heritage Exploration Series (Sr Icy Choy and Sr Victor Ng)

A joint professional tour was successfully held with the PDD and YSG on 18 June. The tours covered two selected spots of historic value in Sham Shui Po: the Savannah College of Art and Design (SCAD), which was formerly the North Kowloon



Magistracy (北九龍裁判法院), and the YHA Youth Hostel, formerly Mei Ho House and part of Shek Kip Mei Estate (美荷樓). Both are Grade II-listed historic buildings in Hong Kong. Thanks go to Sr Icy Choy and Sr Victor Ng for making the arrangements and Sr Vincent Ho, Immediate Past President and Chairman of the Heritage Working Group, for serving as our guide.

CPD: Real Estate Investment Trusts (REITs) – Latest Trends and Opportunities (Code 2016024)

The real estate market is no longer restricted to outright sales and leasing. Increasingly, property will be leveraged on the depth and breadth of the liquidity of the capital market. A real estate investment trust (REIT) is one of the hottest asset classes to arouse the interests of developers and investors.

Mr Derek Cheung, Chief Executive Officer of New Century Asset Management Limited, the manager of New Century Real Estate Investment Trust (HK Stock Code 1275), shared the latest trends of the REIT industry in the region at a CPD event held on 18 May. During his presentation, Derek highlighted the legal structure of a REIT vehicle and compared Hong Kong and Singapore's markets, their listing considerations, and investors' concerns. He finished his presentation by illustrating a case study of the financial model of a typical REIT.





CPD: Road to Qianhai (Code 2016028)

On 6 June, Dr Witman Hung, Hong Kong's Principal Liaison Officer for the Shenzhen Qianhai Authority, presented the latest updates on the Qianhai-Hongkong Modern Service Industry Cooperation Zone of Shenzhen, its preferential policies, and the opportunities for Hong Kong companies and startups.

Dr Hung mentioned that under the current plan, Qianhai will accommodate a resident population of 150,000 and a working population of 650,000 that plies its trade in finance, logistics, IT, and other services. A suite of preferential policies, plus a huge government investment totalling nearly RMB400 billion (US\$65 billion)*, will foster a booming financial and business hub generating some US\$25 billion (RMB150 billion) in annual GDP. More fundamentally, Qianhai will promote greater integration between the Mainland and Hong Kong and serve as a laboratory for bold financial and economic reforms as China seeks to internationalise its currency and gradually open its capital accounts.

Talk on Built Heritage Conservation

On 2 June, PDD held a wonderful CPD talk, "Conservation of the built heritage: Can you contribute?," by Sr Wong Bay and Dr Lee Ho Yin, both of whom gave an interactive talk and got us to understand the difference between graded historic buildings and declared monuments. Dr Lee is the head of HKU's Architectural Conservation Programme (ACP). We sincerely thank him for delivering this valuable talk to us.





"Sr" - The Abbreviation for Surveyor

"Sr" is adopted as the abbreviation for surveyor by The Hong Kong Institute of Surveyors. The pronunciation for "Sr" is "surveyor".

In order to promote its use to the public, corporate members are encouraged to adopt the abbreviation "Sr" in front of their English names in their official communications. Likewise, corporate members are also invited to address themselves as "測量師" after their Chinese names.
