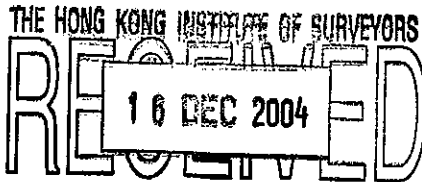



You may also wish to note that when addressing the Panel, your representatives are not covered by the protection and immunity provided under the Legislative Council (Powers and Privileges) Ordinance (Cap. 382). Your written submission is also not covered by the Ordinance.

On the date of the meeting, representatives are requested to arrive **15 minutes before the scheduled meeting time**. On arrival at the Legislative Council Building, they are required to obtain entry passes at the Security Control Post at the entrance beside the carpark before proceeding to Conference Room C on the first floor. They will be invited to join the meeting when members are ready. Please note that representatives are required to wear the entry passes at all times while in the Building and return them to the Security Control Post before leaving the Building.
