Hong Kong prepares to go underground

The government is planning a holistic underground development scheme that will connect disparate neighbourhoods, increase mobility and alleviate street-level congestion, but stiff challenges need to be overcome to ensure success.

The construction of underground space can help ease the problem of urban congestion dilemmas in Hong Kong by providing more space below the ground level.

[Underground space development] is intended to create underground pedestrian links and additional usable space to solve the problem of limited land resources. It's not a development project per se.

While the development of underground space has already been successfully undertaken in many countries around the world, the practice has not yet been fully explored in Hong Kong. This is all set to change, however, with the recent launch of Hong Kong's pilot study in selected Strategic Urban Areas (SUAs) for public engagement. To discuss the issue further, representatives from the HKIS recently met with individuals from the Development Bureau (DEVB), the Civil Engineering and Development Department (CEDD) and the Planning Department (PlanD).

The aforementioned government meeting was attended by DEVB's Principal Assistant Secretary (Works) Ir Francis Chau Siu-hei and Assistant Secretary (Infrastructure Coordination) Mr Tim Fung Tin-yin, CEDD's Chief Geotechnical Engineer Ir Tony Ho Ying-kit and PlanD's Chief Town Planner Ms April Kun Ka-yin. Attendees from the HKIS included President Sr Thomas Ho Kwok-kwan, Honorary Secretary Sr Tony Chan Tung-ngok and *Surveyors Times* Honorary Editor Sr Dr Joseph Chan Hing-lun.

Tony Ho outlined the value of pursuing underground space development. "The exploration of underground space development considers first and foremost the overarching factor of connectivity, such as connections with MTR stations," he said. "It is intended to create underground pedestrian links and additional usable space to solve the problem of limited land resources. It's not a development project per se."

The Study Team is now exploring the preliminary planning concepts for four SUAs. First, the Tsim Sha Tsui West concept involves utilising space underneath Kowloon Park to create a regional multidirectional underground space network. The network will ultimately connect with Jordan to the north, the West Kowloon Cultural District to the west, Tsim Sha Tsui and East Tsim Sha Tsui MTR stations, and the busy Nathan Road to the south and east.

The concept for the second and third SUAs, Causeway Bay and Happy Valley, aims to better connect several key destination nodes, namely Victoria Park, Happy Valley and Hong Kong Stadium. Victoria Park, as a venue for year-round large activities, will benefit from convenient and barrier-free access to nearby Causeway Bay and Tin Hau MTR stations. There is also the distinct potential for creating space for a mix of facilities to address the needs of the district.

Finally, the Admiralty and Wan Chai concept involves using the underground space of Southorn Playground for connecting Wan Chai North and the waterfront by enhancing north-south pedestrian connectivity, and alleviating current pressure on the O'Brien Road elevated walkway.

Tony Ho explained that the below-ground setting is equally congested, due to presence of building foundations, underground utilities and MTR tunnels. It is not easy to identify suitable areas for developing underground space, not to mention other constraints such as narrow street and busy traffic environment. With all these taken into consideration, the sizeable parks and playground in the proximity of MTR stations can offer an opportunity with less physical barriers for

developing underground space to improve the connectivity and create new solution space to meet the needs of the society.

The government representatives noted that developing underground space to enhance connectivity is not entirely new to Hong Kong. Existing examples include the pedestrian subway system between Tsim Sha Tsui and East Tsim Sha Tsui MTR stations, which links the underground levels of several hotels and retail complexes, as well as the basements of many other buildings. Notable examples abroad, they said, include the all-weather pedestrian network in Montreal, and the area beneath the public park in Paris' central Les Halles which links an underground shopping and leisure complex to Metro stations in the area.

The government representatives also explained how public concerns on the preliminary proposals might be addressed, such as excluding the sensitive areas of the parks, including those with dense vegetation and heavily used facilities. Development will likely be carried out in phases to minimise impact on above-ground facilities. They were also keen to emphasise that whereas some people may misunderstand the plans as being focused on the building of "shopping malls", in actual fact the plans focus on enhancing connectivity, alleviating street-level congestion while enhancing the living environment with facilities for recreation, arts and community activities, as well as for commercial elements.

The government recently finished its Stage 1 Public Engagement (PE1) for the Pilot Study on Underground Space Development in Selected SUAs, which has the aim to create a "connected, coherent, high-quality and vibrant network of underground space". Public feedback from the consultation has been generally positive. Some people have given suggestions regarding the use of underground space – for example creating space for young entrepreneurs. Some have expressed concerns about possible disturbance to the parks during construction. After PE1, the government will proceed to develop conceptual schemes and underground master plans with due consideration of the views received. Preliminary technical assessments on various aspects of the schemes including geotechnical/structural constraints, fire safety, impact on the surrounding environment and financial viability will also be undertaken. The Stage 2 PE will then be carried out.

In response to more specific concerns including fire safety, conservation and the impact of construction on the public, the government representatives stated that they will definitely put safety and public interest first and explore the best solutions by using the latest technologies. Heritage, as well as "Old and Valuable" trees, will be preserved. The underground developments may expand further pending the urban renewal of older districts. The government will also take into consideration the results of the PE and will remain open to suggestions.

April Kun reiterated that using both above-ground and underground space can facilitate the streaming of pedestrians and solve crowd problems. Even if population growth may see a drop in the times to come, congestion still needs to be alleviated. "We have listened to

local members consistently expressing concerns about congestion in Tsim Sha Tsui, Wan Chai and Causeway Bay, thus showing the need to enhance connectivity in areas which have reached saturation point."

Hong Kong is unique; its closest comparison is cities in Japan," she said. "Whereas Hong Kong people travelling in Japan may perceive shopping in association with 'underground cities', they are in fact about connectivity and walkability. They provide alternative pedestrian routes and contingency for adverse weather or natural disasters. Shopping is only meant to enhance the pedestrian experience."

Kun also stressed that the government understands public concerns about the impact of underground development on traffic and users of above-ground facilities. "We hope people understand that, as with home renovations, there will be an impact for a while. When proceeding to the Conceptual Scheme, we will explore and choose methods with less impact, such as phased rather than one-off development. We will continue to communicate with, and cater to, the needs of the district. The future Underground Master Plan will look at underground space development three-dimensionally."

HKIS Honorary Secretary Sr Tony Chan points out that Hong Kong's development historically started along the coasts of Victoria Harbour and that while new towns have been developed in the outlying areas, people still tend to congregate in crowded urban areas. Since the urban land is already mostly used, he believes developing underground space to be a viable solution to relieve congestion and enhance connectivity to transportation systems, commercial areas and hubs.

Chan however adds that a number of technical constraints exist that involve land ownership and underground obstructions. "If space is to be developed under existing buildings, it will involve solving tough issues such as land acquisition, and conflicts with existing underground structures for things like water, electricity, sewage and MTR lines. These issues can be avoided if space is developed under public parks, though there would still be an impact on park users during construction," he says.

Despite slowing population growth and the proliferation of unoccupied units in shopping districts, Chan believes underground space development is still necessary. "For Hong Kong's long-term benefit, development needs to be continued. The census says the local population will continue to grow. Studies show that congestion causes emotional stress and has a social impact. Unoccupied store space is only a temporary phenomenon, and tourists will continue to come. We cannot assume that things will remain stagnant."

Sr Prof James Kenneth Pong, Chairman of the HKIS Planning and Development Division and a chartered town planner, chartered building engineer, authorised person and barrister, also highlighted the importance of determining property ownership, given that under the laws of Hong Kong a person who owns land also owns anything below it – including, but not limited to, underground space. In addition, he explained the different construction methods that could be used to develop underground areas.

"Technically, underground space can be created by tunnel boring, but this is costly and requires careful investigation and planning with regards to the nature of the terrain. Alternatively there is the comparatively simple 'open cut' method. This begins above ground, cutting downwards to create a void. Once development is completed underground, the void is covered up again for activities to continue above ground. For Hong Kong, it is more likely that development will start using the open-cut method in public parks, where there are few ownership issues. Underground passageways will then have to be constructed to amalgamate these otherwise segregated underground voids."

Pong adds that careful attention needs to be paid to fire regulations, which require that underground structures have stronger fire resistance. "Underground structures must have the capacity to contain a fire in one location for four hours to give people ample time to escape before it spreads. The requirements for robust structures can be modified, but only when one can demonstrate that such modification is justified under a fire-engineering approach, which aims at performance compliance with all the technically specified fire regulations. Coupled with fire resistance requirements, another important fire requirement for underground space construction is compartmentation, i.e. separating underground space into different compartments to confine fire and smoke in case of fire. In Hong Kong, compartmentation is usually achieved by using roller shutters."

Pong acknowledges that the cost of building underground structures is usually more than double that of above-ground ones. Apart from cost concerns, there are also disposal concerns. "If an open-cut method is used to excavate under Kowloon Park, the excavated spoil needs to be disposed of. However, the dumping of non-inert excavated soil into the waters and seas of Hong Kong are forbidden under the Water Pollution Control Ordinance and the Dumping At Sea Ordinance for the sake of protecting the environment, marine life and aqueous biodiversity. This will impose an unprecedented burden on our landfills. Government should coordinate with the private sector to re-use this surface spoil for land reclamation as much as possible."

Pong agrees that the construction of underground space can help easing the problem of urban congestion dilemmas in Hong Kong by providing more space below the ground level. "We cannot compare with sparsely populated countries like Australia where suburban dwellers mostly stay in the suburbs after work. Hong Kong's closest comparison is the hustle and bustle in the city centres of Tokyo or New York. Our CBD is busy even on weekends and week nights, and underground space can help alleviate congestion."

As mentioned by Pong above, the project will be very costly. Though Pong generally supports the idea of underground space, he suggests that a detailed cost-benefit analysis be carried out before launching the proposed underground space project to ensure that such work is, in the long run, value for money.

發展香港的 地下空間

香港政府鋭意發展地下空間,以連接各社區、增加 流動性、紓緩路面擠塞。不過,在取得成功之前, 先要解決眼前的重重挑戰。

發展地下空間已成趨勢,外國也提供了不少成功例子,然而,香港在應用層面尚有許多發揮空間。香港近期展開策略性地區先導研究,就發展地下空間進行公眾參與活動。香港測量師學會代表最近與發展局、土木工程拓展署及規劃署會面探討有關議題。

出席會議的包括發展局首席助理秘書長(工務)周紹喜工程師和助理秘書長(基建統籌)馮天賢先生、土木工程拓展署總土力工程師何英傑工程師、規劃署總城市規劃師靳嘉燕女士,以及香港測量師學會會長何國鈞測量師、義務秘書陳東岳測量師及《測量師時代》義務編輯陳慶麟博士測量師。

何英傑簡述發展地下空間的意義,並指出:「在探討發展地下空間時,連接性是首要考慮因素,例如接駁地下空間與港鐵站。發展地下空間的目的是開闢地下行人網絡、提供額外使用空間,以解決土地資源有限的問題。發展地下空間本身不只是個發展計劃,其意義更深遠。」

研究小組目前正探討四個策略性地區的初步規劃概念。首 先,尖沙咀西的規劃概念包括在九龍公園地底興建一個多方 位的地下空間網絡,連接尖沙咀不同地方:北連佐敦、西接 西九文化區、東和南則通向繁忙的彌敦道及港鐵尖沙咀至尖 東站。

第二和第三個策略性地區為銅鑼灣和跑馬地,規劃概念旨在 改善連接維多利亞公園、跑馬地和香港大球場這三個主要的 目的地。維園作為舉辦全年大型活動的場地,會受惠於興建 便捷和無障礙通道,以連接鄰近的港鐵銅鑼灣站和天后站。 此外,維園亦具有潛力向下發展,增建多元化設施,以應付 區內所需。 最後,金鐘、灣仔的規劃概念提議利用修頓球場的地下空間, 開闢貫通南北的行人通道,連接灣仔北和海濱,紓緩現時柯 布連道行人天橋的壓力。

何英傑解釋,地底情況同樣擠迫,建築物地基、地下公用設施及港鐵隧道走線等增加了覓地開發地下空間的困難,開發前亦要顧及街道狹窄和交通繁忙等限制。綜合以上因素,鄰近港鐵站的大型公園和遊樂場障礙較少,較適合發展地下空間,從而改善行人連接性及開拓更多空間滿足社會需要。

政府代表指,利用發展地下空間改善行人連接性,在香港並非新概念。港鐵尖沙咀站與尖東站之間的地下行人通道,就連接了數間酒店和商場地下層,以及多棟樓宇的地庫。可作參考的外國例子,則有蒙特利爾地下城的全天候行人通道,以及位於巴黎大堂區公共公園的地下空間,連接了地下商場與該區的地鐵站。

此外,政府代表亦提到如何釋除公眾對初步方案的疑慮,例如避免影響公園的敏感範圍,包括茂密樹木和常用設施的地方。發展亦可分階段進行,以減低對地面設施的影響。政府代表解釋,有市民可能誤解這項發展計劃旨在興建地下「商場」,其實,計劃的宗旨是優化行人連接性、紓緩路面擠塞、透過新開拓的空間提供文娛、康樂、藝術、社區和商業等設施,以改善生活環境。

政府最近完成了「城市地下空間發展:策略性地區先導研究」第一階段的公眾參與活動,研究旨在創造一個「互通、連貫、高質素和富有活力的地下空間網絡」。公眾諮詢獲得很多正面的意見,包括如何善用地下空間作不同用途,例如為青年企業家提供發展空間;有市民則關注施工期間可能對公園造成的滋擾。第一階段公眾參與活動結束後,政府將整理收集到的意見,擬備概念方案和地下空間總綱圖。政府稍後會就方案進行初步技術評估,包括土力/結構限制、消防安全、對周圍環境的影響,亦會考慮方案在財務上是否可行。之後再進行第二階段的公眾參與活動。

就消防安全、保育、建築工程對公眾的影響,政府表示必定以安全和公眾利益為優先,運用最新技術研究出最佳解決方案。當局將保留文化遺產和古樹名木。地下空間亦可擴展至舊區以配合市區重建。政府亦會參考公眾諮詢的結果,廣納民意。

斯嘉燕重申,同時運用地面和地下空間有助疏導人流,解決 人潮擠迫情況。即使日後人口增長放緩,擠塞問題仍需正視。 「市民持續提出尖沙咀、灣仔和銅鑼灣的擠塞問題,由此可 見,部份地區行人承載量已達飽和,需要改善行人連接性。」

她說:「本港的情況獨特,若要選最類近的城市可參考日本。然而,赴日旅遊的港人可能會從『地下城』聯想到購物。事實上,這些地下城旨在改善連接性和方便步行,同時提供額外的行人通道,以應付惡劣天氣或天災。購物設施只是為了提升步行的樂趣。」

「與香港情況最相近的是東京或紐約繁忙的市中心,本港的核心商業區在周末及平日晚上依然繁忙, 地下空間有助紓緩交通擠塞。」

斯嘉燕強調,政府明白公眾相當關注發展地下空間對交通和 路面設施使用者的影響。「正如裝修家居一樣,我們希望市 民了解發展地下空間難免會造成一段時間的影響。在制訂概 念方案時,我們會研究並選擇影響最少的方法,例如分階段 進行工程,並與區內居民保持溝通,照顧區內需要。未來的 地下空間總綱圖會以三維角度探討地下空間發展。」

香港測量師學會義務秘書陳東岳測量師指,香港最先開發的 是維港沿岸,後來雖陸續在偏遠地方興建新市鎮,但市民仍 多聚集在擁擠的鬧市地區。由於多數市區土地已開發,他認 為發展地下空間有助紓緩擠塞情況、連接交通網絡、商業地 帶和鬧市。

陳東岳承認當中存在許多技術上的困難,例如涉及土地業權和地底障礙物。「如果要在現有的建築物底下發展空間,需解決徵用土地等棘手問題,工程亦會影響現有的水電、污水、港鐵路線等地底建築物。假如在公園底下發展地下空間,就可以避免這些問題,不過在施工期間仍會對公園使用者造成影響。」

雖然人口增長放緩、購物區的空置店鋪增加,陳東岳依然認為有必要發展地下空間。「為了香港的長遠利益,需要繼續發展地下空間。人口普查指出,本港人口將持續增長,而研究更顯示擠塞問題會帶來負面情緒,對社會產生影響。空置店鋪只是暫時現象,遊客會持續訪港,我們不能假設現時情況將維持不變。」

龐錦強教授測量師是香港測量師學會規劃及發展組主席,亦 身兼特許城市規劃師、特許建築工程師、香港政府認可人士 及大律師,他關注釐定物業擁有權的重要性。根據香港法律, 一個人如果擁有土地,該片土地底下的所有東西亦為該名人 士所有,包括但不限於地下空間。此外,他解釋發展地下空 間的各種施工方法。

「技術上,地下空間可透過挖掘隧道來建造,但是這個方法 成本高,還需仔細勘查和規劃地形。地下空間亦可以明挖方 法建造,只需在地面開挖工作坑,待地下工程完成後,再填 補工作坑,回復地面上的活動。按香港情況,公共公園的發 展工程多數會先採用明挖方法,因為公園擁有權的問題較少。 之後要建造地下通道,將這些分開的地下空間合併起來。」

龐錦強提醒工程需小心留意消防規例,當中要求地底建築物需具備較強的耐火能力。「地底建築物必須能阻止火勢迅速蔓延,讓人至少有四小時的逃生時間。有關建築物的嚴謹準則,可以利用消防工程手段 (Fire Engineering Approach) 進行修訂,以確保其性能符合消防規例所訂立的技術要求。除了要符合耐火能力要求外,建造地下空間另一項重要的消防規則是防火分隔法,亦即將地下空間分成不同區域,以便發生火警時,可控制火勢及煙霧的範圍。在香港,通常使用捲閘作為防火分隔。」

龐錦強指出地下建築物的成本通常比地面建築物高出一倍以上。除了成本之外,亦要考慮廢物棄置問題。「如果使用明挖法挖掘九龍公園的地底,就需要棄置挖出的廢土。然而,為保護環境、海洋生物及水中的生物多樣性,《水污染管制條例》和《海上傾倒物料條例》規定,禁止將非惰性廢物,包括挖掘的泥土棄置於香港水域及海域。換言之,這將會對堆填區造成前所未有的龐大負擔,政府應與私營機構協調,盡可能將地面棄土回收作平整土地之用。」

為探討香港發展城市地下空間的潛力,提供額外行人通道以紓緩地面擠迫的人流和交通,政府現已完成第一階段的 公眾參與活動,收集市民意見。

龐錦強認同建造地下空間有助 紓解香港市區擁擠的困境。 「我們不能與澳洲等人口稀少 的國家比較,這些國家的郊區。 居民在下班後大多留在郊區區。 與香港情況相近的是東京或紐 約繁忙的市中心,本港的核然 繁監在周末及平日晚上依然 繁忙,地下空間有助紓緩交通 擠塞。」

如龐錦強所言,地下空間發展 項目成本不菲。雖然他支持發 展地下空間,但是他建議先詳 細分析項目的成本效益,再落 實地下空間發展項目方案,以 確保這項工程長遠而言是物有 所值。

he year 2016 proved to be an eventful and productive one for the HKIS. We made considerable progress towards our divisional goals. Quantity Surveying Division (QSD) advocated the use of an Independent Cost Consultant to improve cost control of infrastructure projects for the last decade, and, while the Government has still yet to adopt our suggestions in infrastructure projects, I am glad to see that it has made some moves towards better cost control in setting up a Project Cost Management Office.

Despite the Building Surveying Division (BSD) pushing the Government to establish the Building Repair and Maintenance Authority, the proposal is still up in the air, while bid-rigging remains a major problem. The Government instead requested the Urban Renewal Authority to tackle the problem. The HKIS will keep monitoring the progress of this.

General Practice Division (GPD) continues its dialogue with the Government regarding the re-establishment of the Lease Modification Section. The purpose of this is to process applications and liaise with various Government departments and stakeholders to improve operational efficiency and address the concerns of applicants.

Finally, Land Surveying Division (LSD) called for more spatial data infrastructure to create a smart city in Hong Kong. Following this, the Government, in its latest Policy Address, outlined its plan to set up a common spatial data infrastructure.

Studies of Government Policies

Following widespread consultations on land and housing issues, a number of related Government policies will be implemented in the years to come, including 2030+, Underground Space Development initiatives and several other schemes mentioned in the recent Policy Address. The HKIS will strive to involve our three policy panels

and six divisions in carrying out more respective studies in future. This not only strengthens our contribution to Hong Kong society but also our consultative role in Government policy, particularly on issues affecting land, property and construction.

HKIS Media Luncheon 2017

The HKIS kicked off the Year of the Rooster by hosting its annual media luncheon on February 8 at the World Trade Centre Club in Causeway Bay. A total of 35 media friends attended and met the Institute's 2016-17 representatives. During this luncheon, I shared the Institute's intended direction for 2017 and spoke about the unavailability of funding for government construction and related projects, highlighting that this is one of our key concerns. The divisional spokespeople then briefly outlined their divisions' themes for the coming year, including the main issues that they intend to focus on and the scope through which they might offer their expertise. Each spokesperson shared their professional points of view on topical public and social issues and answered enquiries from the editors and reporters. The event was well covered by the media.

New divisional themes

Our six professional divisions and Young Surveyors Group (YSG) have announced their new themes for 2017. BSD has proposed "Revitalisation: Conferring New Life upon Older Buildings", aimed at exploring alternatives to demolition for older and obsolete buildings, such as transformation or revitalisation. GPD chose "Exploring Ways to Increase Land and Housing Supply" and will also study ways to promote and fund building maintenance, rehabilitation and retrofitting. LSD will focus on a "Study on Common Spatial Data Infrastructure Development to Support General Plan Submission", following the Government's plans to commission a strategic study on the development of common spatial data infrastructure during the year. There will also be an emphasis on matters of land boundary determination.

Planning & Development Division (PDD) envisages "Recognition of Planning & Development Surveyors by the Government", which will implement more activities and enhance communications with the Government, as well as stepping up recruitment efforts for PDD surveyors. Property & Facility Management Division (PFMD) will start working within a new legal framework following the debut of the Government's Property Management Services Authority (PMSA). PFMD will work closely with the Authority and give its professional viewpoints.

QSD aims at "Promoting Services of Quantity Surveyors and Increasing Public Awareness of Construction

Cost Control". It will also concentrate on raising its professional image and public awareness by actively promoting its wide spectrum of services, ranging from cost control and monitoring to tendering and contractual arrangements.

YSG, which is dedicated to providing opportunities for young surveyors to develop their careers, will adopt the theme of "Y-S-G, Youth innovations – Search for interesting topics – Gather up dreams" to introduce and promote services provided by YSG.

Call for new ideas at annual retreat

A fresh initiative that enriched this year's half-day retreat was the addition of a team-building element. It is hoped that this will further enhance the spirit of cooperation and cohesiveness among divisions. During brainstorming sessions, we tried to think outside the box and identify things about the Institute that can be improved. The suggestions included boosting HKIS's status and image; exploring ways such as direct membership to increase our membership numbers; the possibility of relaxing the threshold of APC and expanding the involvement of young members in HKIS's affairs. We welcome members' perspectives on all these ideas and invite them to share them with us.

Building brand image at the Careers Expo

From February 23 to 26, the HKIS again made use of the Education and Careers Expo 2017 to promote public awareness of the surveying profession and build the Institute's brand. This year, the HKIS booth drew more than 800 visitors. Under the joint leadership of YSG and other divisions, we found 20 student helpers and 20 members to man the booth and answer queries from Expo visitors. As well as distributing leaflets, YSG gave our image a big boost by handing out to interested students pens bearing the HKIS logo and the names of its six divisions.

會在 2016 年渡過了充實、豐碩的一年,各組別朝著目標邁步前進。工料測量組在過去十年建議政府委任獨立成本顧問,控制基建工程的建造成本。雖然政府尚未在基建工程方面採納有關建議,本人樂見當局已設立項目成本管理辦事處,逐步改善成本控制。

建築測量組提倡設立樓宇維修工程監管局,但政府至今尚未落實有關建議。另外,圍標問題仍有待解決,政府現要求市區重建局跟進,本會將繼續監察事態發展。

產業測量組繼續與政府磋商重新設立土地契約修訂組,以便處理有關申請及與各個政府部門和持份者聯繫,從而提高運作效率,回應申請人所關注的各項問題。

最後,土地測量組呼籲增建空間數據基礎設施,推動香港邁向智能城市。 政府在最近發表的施政報告中,提到建設空間數據共享平台的計劃。

政府政策研究

政府就土地和房屋議題進行廣泛諮詢後,未來將推行多項相關政策,包括施政報告中提及的 2030+、地下空間發展計劃等。本會三個政策小組和六個專業組別將致力進行更多相關研究,我們期望藉此貢獻香港社會,同時加強我們在政府政策,尤其涉及土地、物業及建築的議題,所扮演的諮詢角色。

香港測量師學會傳媒午餐會 2017

踏入雞年,本會於2月8日假銅鑼灣香港世界貿易中心會舉行年度傳媒午餐會,35位傳媒朋友獲邀出席,與本會2016-17年度的發言人共聚一堂。席間,我分享了本會的來年計劃,亦提及我們最關注的其中一項議題:政府工程撥款嚴重拖延。各組發言人隨後簡介今年的組別議題,包括每組重點關注的項目和他們可提供專業意見的範疇。每位發言人以專業角度評論市民關注的公共及社會議題,並回答編輯和記者的查詢。傳媒及後亦有廣泛報導當日的活動。

新組別主題

本會六個專業組別及青年組已宣布各自在2017年的新主題。建築測量組提出「活化建築:重建以外的選擇」,探討拆除較舊和老化的建築物的替代方案,當中包括改建或活化建築物。產業測量組的主題是「研不同方案增加土地和房屋供應」,並探討如何鼓勵樓字保養、復修、維修,及研究籌集維修費用的方法。政府計劃於本年度就空間數據共享平台展開策略研究,土地測量組以「研討『空間數據共享平台』助業界入則」為主題,跟進有關發展,同時關注釐定土地界線事宜。

規劃及發展組期望「提升政府對規劃及發展測量師的認可」,將會舉辦更多活動,加強與政府溝通,致力增加規劃及發展測量師的就業機會。物業設施管理組將在全新的法律框架下,與新成立的物業管理業監管局緊密合作,提供專業意見。

工料測量組以「推廣工料測量師專業 提升公眾對工程造價之知識」為目標,將積極推廣多項專業服務以提升專業形象,包括工程的造價評估及監控、招投標、合同制定事宜,期望能提升公眾對有關事宜的認識。

青年組致力為青年測量師提供事業發展機會,今年將以「Y」(Youth innovations 青年創意)、「S」(Search for interesting topics 尋找有趣議題)、「G」(Gather up dreams 凝聚夢想)為主題,介紹及推廣青年組提供的服務。

年度退修會 集思廣益

建立團隊精神是今年半日退修會新增的元素,我們期望藉此提升各組別間的合作精神及凝聚力。在集思會上,我們嘗試跳出既有思考框架,找出本會有待改善之處,收集到的建議包括提高本會的地位及形象、探討增加會員人數的方法(例如設直接會員制)、放寬專業評核試門檻及增加青年會員參與學會事務。我們歡迎並誠邀各會員就上述建議提出意見。

職業博覽會 建立學會形象



Surveying in the spotlight

EVENT SPOTLIGHT

Career prospects are bright given future developments like the new CBD on Lantau and civil works in China springing from Belt and Road initiatives.

The HKIS took part in the 27th HKTDC Education & Careers Expo held at the Hong Kong Exhibition and Convention Centre from February 23 to 26, joining more than 860 organisations from 22 countries. This premium annual event draws tens of thousands of students and jobseekers every year and provides a perfect platform for the Institute to enhance its image, as well as the public's understanding of the profession.

HKIS President Sr Thomas Ho hailed the event as a golden opportunity to give the general public a much clearer picture of what it is surveyors do. "The general public tends to lack a clear understanding of our role, and some may be confused about our contribution to Hong Kong's progress," Ho said. "It was therefore encouraging to see so many people being drawn to our booth to learn more about the industry. From past experience, common questions usually raised are things like what is surveying, how to join the profession, what the salary levels are and how to get the necessary qualifications. Some even ask details about the six different divisions within the profession."

Ho said that he believes the future is bright for the profession not just because of the many ways to join the profession - such as via university or IVE courses - but because of its link to construction. "The maturity of Hong Kong's development is a well-discussed point because many areas have already been developed, but we must take into account the fact that many buildings were constructed 30 to 50 years ago or more. They need to be rebuilt or repaired, and such works need to be conducted by surveyors. When you talk about planning and housing, we have surveyors who specialise in construction, land and valuation. Also, the Belt and Road initiatives will provide good opportunities for surveyors working in and with these countries. Furthermore, the establishment of the Property Management Services Authority under the Property Management Services Ordinance will drive demand for surveyors as part of the new-style property facility

management."

Young Surveyors Group (YSG) Chairman Sr Chris Mook said that the idea behind this year's expo booth was to introduce the profession in a special way and deepen understanding

of the Institute's six divisions. To do this, the team introduced more interactive elements. "In the past we outlined and presented details on display boards, but this time we gave things a twist by introducing mini-games to promote more interactions. Three games were specially designed to denote the daily work of surveyors involving four groups of professional practices: building surveying, quantity surveying, general practice, and planning and development. The game on quantity surveying guided players through various quantity surveying-related tasks in building the 'Lego brick premises', such as BQ preparation, procurement and valuation of work in progress. For the game on general practice and planning and development. different scenarios were set for visitors to match the purpose of land use and understand height restrictions. The game on building surveying introduced the public to the way of measuring cracks by using the crack gauge, which is one of the tools to measure cracks. Participants could understand that building surveyor will measure cracks while carrying out a building inspection. To incentivise participants, we also produced a set of pens printed with the names of our six divisions to serve as reminders to the students who received them."

The spirit of the games, Mook explained, also matches the YSG's three special themes: Y - youth innovation, S search for interesting topics and G – gather up dreams. "This explains why this time YSG has involved itself more with the divisions. For instance, the Building Surveying Division produced a series of two-minute videos on building safety and we displayed them onsite. The various divisions also emailed requests to council members to send senior members to the booth and help brief student helpers serving the public."

During the expo's four days, the HKIS booth was managed by a team of 40 volunteers, comprising 20 university students and 20 HKIS members. There were three shifts per day of between four and six hours, the main task being to answer queries from the public. Mook spent all of the first day on duty and fine-tuned whatever was necessary to ensure everything worked smoothly.

"I observed a wide spectrum of the public, such as students of other academic subjects and graduates from overseas universities or with non-surveying degrees, visit the booth. There were even some adults who wanted to switch to surveying. Frequent questions included the way to attain qualifications, what overseas qualifications were recognised, job and career prospects, and salary levels. The prospects for the profession are certainly bright given future developments like the new CBD on Lantau and civil

works in China springing from Belt and Road initiatives."

This year, HKIS President Ho also gave a 30-minute talk on careers in the surveying profession, going back to Hong Kong's earliest days in 1843. He traced the many milestones the profession has achieved, such as developing training for local students at the then Hong Kong Technical College back in the 1960s, as well as the birth of the HKIS in 1984. He also highlighted surveyors' scope of work, the background of the HKIS and the qualifications required for surveyors, as well as career prospects.

His advice for students was to take that initiative to learn about the profession as early as possible. "They can do this, for example, by visiting future Careers Expos or signing up for activities designed along our branding campaign, such as map-making competitions in secondary schools," Ho said. "Indeed, the HKIS organises regular career talks in schools covering different surveying categories. Last November, we worked for the first time with the Education Bureau on the Business-School Partnership Programme on Work Experience Movement. So far,18 companies have got involved and arranged for students to work with them for two or three days."

The recruiting of 20 students to assist at the booth was done with an eye on building a long-term rapport with young surveyors. Tansy Cheung, a Year 1 student of the Department of Surveying at the University of Hong Kong, lent a helping hand on the weekend afternoons. "I wanted to know more about the industry and the people involved. There was also the opportunity to learn things that aren't on our university syllabus, such as communication skills. Also, my university course hasn't covered all aspects of land surveying, so I was able to pick up some basic information from the leaflets."

Cheung added that she was able to help a number of booth visitors with their enquiries. "Most visitors had limited knowledge of the profession," she said. "A student who said she was weak in mathematics asked if it's difficult to deal with calculations. I told her that it's pretty straightforward and not a key criterion for consideration. I also explained to one person how he could apply for membership of the HKIS. Fortunately, there were senior members present to field the more difficult questions."

Edward Tam, another student helper who shares the same academic background as Cheung, hoped to pass information about the profession on to interested parties as well as brush up his own knowledge of surveying. "As an executive member of my university's Surveying

Society, I learned about this expo through YSG," he said. "A 60-minute helpers' briefing was held at City University by Sr Prof Lawrence Poon. It covered basic knowledge on surveying, objectives, a rundown of the mini-games and what messages the Institute would like to deliver. My participation deepened my knowledge on building surveying and strengthened my confidence in communications. A family came by with a child who spoke English, so I had to test my English and explain clearly the instructions and steps involved. The creative games using Lego bricks proved to be very popular and got many people to stop at the booth to see what was happening. The concept was very basic so it was easy to understand."

One of the visitors to the booth, a Year 4 student from a Hong Kong university, admitted he had only a narrow understanding on surveying and thought it was only related to big construction projects like the West Kowloon development project. Afterwards, however, he had a much better idea of what the profession involved. "I gained a better understanding after playing one of the games and one of the helpers explained to me lesser-known perspectives like valuation," he said. "I also learned that the path to become a qualified surveyor is not easy due to the high entry level. For instance, in the first two years a graduate needs to build up a certain number of service hours within their respective field."

Adult visitors like Helen Chung popped by to find out how each division works and what specialised duties they perform. "I played a game related to general practice which tested me in different scenarios," Chung said. "The question was where I should site a park. My first choice was wrong as it was on private land, so the HKIS helper patiently guided me towards the answer which was that a park should be in a recreational zone."

Another younger visitor, who gave his name as Stephen, was interested in the validity of overseas qualifications via distant learning. "I asked on behalf of my friend who knows of a couple of schools overseas offering surveying, but he's not sure if they're legitimate," he said. "I got the answer I needed from the senior HKIS member who was present."

Mr Lee, an adult visitor who works in engineering, made inquiries on behalf of his niece, who is a quantity surveyor, but found that the information he received was useful for him as well. "I was glad to hear so much more about the various areas of surveying," he said. "This could be an alternative field for me to develop after retirement."

「未來有大嶼山市中心及『一帶一路』帶動中國土木工程等發展項目,測量業的前景一片光明。」

測量業受情際

香港測量師學會於第27屆香港貿發局教育及職業博覽,設立攤位向公眾介紹學會及香港測量業,增進公眾認識之餘,同時鼓勵參觀人士投身測量業。

第27屆香港貿發局教育及職業博覽在2月23日至26日假香港會議展覽中心舉行,香港測量師學會連同來自22國的860多個組織共襄盛舉。這項年度盛會每年吸引成千上萬的學生和求職者,學會藉今次展覽提升形象,增進公眾對業界的認識。

香港測量師學會會長何國鈞測量師指,是次活動讓公眾更了解測量師的工作,是一次難得的機會。「一般市民不熟識測量師的職責,亦有人不明白測量師對香港發展的貢獻。而令我感到鼓舞的是,我們的攤位吸引了大批市民前來參觀,他們想知道更多測量業的資訊。按過往經驗,最常見的問題包括:甚麼是測量、如何入行、薪酬水平、如何取得專業資格。也有人問及測量業六個組別的詳情。」

何國鈞測量師認為測量業具發展前景,一是因為入行途徑多,包括入讀大學或香港專業教育學院課程,二是因為測量業與建造業相輔相成。「我們常說香港發展成熟,很多地區已被開發,但很多樓宇興建至今已有30至50年甚至更久,這點值得關注。要重建和維修這些樓宇,就需要測量師進行有關工作。至於規劃和房屋方面,我們有專攻建築、土地及估值的測量師。而『一帶一路』則為測量師提供更多與沿線國家合作的機會。此外,根據《物業管理服務條例》設立的物業管理業監管局將帶動市場對測量師的需求,以滿足新型物業設施管理的需要。」

青年組主席莫璟瑭測量師表示,今年的展覽攤位旨在以特別

的方式介紹測量業,加深公眾對本會六個組別 的認識。攤位因此增加更多互動元素。「我們 以往只會用展板介紹資訊,但今次別出心裁, 推出小遊戲,增加互動。我們設計了三款小遊 戲,講述專業測量師的四類日常工作:建築測 量、工料測量、產業測量,還有規劃及發展。 其中有關工料測量的小遊戲指示玩家利用樂高 積木完成各項涉及工料測量的任務,如準備工 程清單、採購和估價。在產業測量師和規劃及 發展測量師的遊戲中,參觀人士根據我們設定 的不同情境,配對相應的土地用途和認識建築 物高度限制的概念。透過建築測量師的遊戲, 參觀人士可以學習如何利用裂縫規來量度裂 縫,也了解到建築測量師進行樓宇勘察時,裂 縫規為常用的勘察工具之一。為獎勵參加者, 我們還製作了一套原子筆,筆上印有本會六個 組別的名稱,加深學生的印象。」

莫璟瑭測量師指,這些遊戲的理念亦符合青年組的三個特別 主題,即「Youth innovations」、「Search for interesting topics」和「Gather up dreams」。「青年組這次積極與各組別合作。舉例而言,建築測量組製作了一系列有關樓宇安全的影片,每段片長兩分鐘,在現場播出。此外,各組別發電郵要求委員會成員安排幾位資深會員到場,向負責招待公眾的學生義工講解工作。」

在為期四天的展覽中,香港測量師學會招募了 40 位義工協助 攤位運作,其中 20 位是大學生,其餘 20 位是學會的會員。 義工每日輪值三更,每更四至六小時,主要工作是回答公眾的 提問。莫璟瑭測量師在第一天全日當值,確保攤位運作順利。

「我見到不同人士來參觀我們的攤位,例如有其他學科的學生、外國大學的畢業生或非測量學系的畢業生,甚至有一些有意轉行測量業的成年人。他們的問題一般包括如何取得測量資格的途徑、哪些海外資格獲認可、測量的就業和發展前景,以及薪酬水平。未來有大嶼山市中心及『一帶一路』帶動中國土木工程等發展項目,測量業的前景一片光明。」

今年,香港測量師學會會長何國鈞測量師發表了 30 分鐘演講,內容追溯到香港開埠早年,從 1843 年開始回顧測量界的多項里程碑:例如在六十年代,為當時的香港工業專門學院本地學生開辦訓練課程,以及在 1984 年成立香港測量師學會。他亦談及測量師的職責、香港測量師學會的背景、成為測量師所需的資格,以及就業前景。

何國釣測量師建議學生盡早學習行業知識。「他們可以參觀 更多職業博覽會,或登記參加我們為推廣學會形象而設的活 動,例如我們舉辦的地圖創作比賽。學會定期到學校舉辦就 業輔導講座,介紹測量界的各類工作。去年 11 月,我們首 次與教育局合作,參與商校合作計劃的工作體驗運動,目前 有 18 間公司參與,學生會被安排到公司工作兩至三天。」

學會招募 20 位學生協助攤位運作,目的是希望他們多與年輕測量師接觸,為雙方建立長遠關係。香港大學測量學系一年級學生張希甄在週末下午到攤位幫忙,她表示:「我想了解更多行業知識及業內人士,來這裡亦有機會學到學校課程以外的東西,例如溝通技巧。學校的課程也並未涵蓋土地測量的所有範疇,我可以從宣傳單張上得知更多基本資訊。」

張希甄亦指,她接觸了不少前來攤位參觀的人,並解答他們的問題。她說:「參觀人士大多不熟識測量業,有學生問我,

她的數學不好,在計算數據時是否會有困難。我告訴她,這 類工作其實很簡單,並非入讀測量學的主要考慮準則。我亦 向一位參觀人士解釋如何申請成為香港測量師學會的會員, 幸好當時有其他資深成員在場,可以回答較深入的問題。」

譚浩然是另一位學生義工,與張希甄同是港大測量系一年級生,他希望向有興趣的人介紹測量業,同時增進自己在測量方面的知識。他說:「我是大學測量學會的委員,透過青年組得知這場博覽會。潘永祥教授測量師在香港城市大學主持了一場60分鐘的義工簡介會,介紹基本測量知識、目標、小遊戲的流程,以及學會要推廣的訊息。這次博覽會加深了我的建築測量知識,令我溝通時更有自信。有一家人帶著說英文的小朋友來參觀,我只好用英文與他們溝通,清楚説明有關指示和步驟。以樂高積木製作的遊戲別具創意,大受歡迎,吸引許多人在攤位前駐足觀看。當中的概念簡單易明。」

一位香港大學四年級的學生參觀攤位,他表示不認識測量,以為測量只與西九龍發展計劃之類等大型建築項目有關。但是次展覽增加他對測量業工作的認識。他說:「我玩了其中一個遊戲,工作人員向我解釋『估值』,這是較少人知的測量知識,加深我對測量的了解。我明白要成為合資格的測量師很不容易,因為入行門檻很高。舉例而言,畢業生畢業後的首兩年內,需要在各自的專業累積一定的工作時數。」

參觀人士當中亦有像 Helen Chung 這樣的成年人,她前來了解各組別如何運作,以及每組的職責。「我玩了一個有關產業測量的遊戲,要根據不同的情況為公園選址。我第一次選錯了,因為那是私人土地。香港測量師學會的職員耐心地引導我選出正確答案,將公園設在康樂用地。」

另一位參觀者 Stephen 較年輕,他希望了解遙距課程頒授的海外資格在香港是否獲認可。「我是代朋友問的,他得知海外有一些學校開辦測量課程,但他不確定這些學校的課程是否正規。一位駐場的香港測量師學會資深會員解答了我的疑問。」

從事工程工作的李先生,原本是代現職工料測量師的姪女查詢,後來卻發現這些資訊對自己亦相當實用。他說:「我退休後或許可以向測量界發展。」



HKIS Media Luncheon

The GPD Chairman, Sr KK Chiu; Vice-Chairman (External Affairs), Sr Alexander Lam; and Honorary Treasurer, Sr Tony Wan, attended the HKIS Media Luncheon on February 3. Sr KK Chiu addressed the theme of GPD this year:

The GPD would explore and study ways to increase land and housing supply in Hong Kong (e.g. examine the feasibility of developing certain peripheral areas of country parks while maintaining/increasing the overall size and ecological value of the parks). Secondly, we would study ways to promote and fund building maintenance, rehabilitation, and retrofitting, so as to extend the life spans of buildings and enhance the efficiency of existing land use.

A working group under the Land Policy Panel will be formed to investigate land supply.



IVSC Insight Forum

The HKIS was invited to attend the IVSC Insight Forum organised by the IVSC Membership and Standards Recognition Board (MSRB) on 22 February. The purpose of the session is for the IVSC Membership and Standards Recognition Board to gather feedback from market practitioners, users of IVS, and regulators to develop and implement an International Valuation Standards (IVS) market recognition strategy. The Forum, which was divided into real estate and business valuation teams, was attended by accounting firms, the HKICPA, AICPA, surveying firms, the RICS, and the HKIS.

Strategic Growth Committee

The Strategic Growth Committee had its second meeting on 8 February. The terms of reference were confirmed as follows:

- To review GPD membership figures and understand the reasons for stagnant membership growth in recent years.
- 2. To gain a better understanding of the various academic institutions that provide GP surveying courses, including the number of students in the various existing undergraduate and postgraduate programmes; number and backgrounds of their teaching staff, etc.
- To review possible activities for brandbuilding in order to improve the awareness and image of GP surveying, with a view to attracting and encouraging more students and probationers to become GP surveyors.

- 4. To review the accreditation requirements for existing and new surveying courses.
- 5. To review and suggest possible improvements to the key components of the existing APC system with a view to providing clear paths for students and probationers to become qualified GP surveyors:
 - Minimum Training Period and **Experience Areas**
 - Pre-Qualification Structured Learning
 - Part I: Written Assessment Subject Areas
 - Part II: Oral Assessment
 - Referred Candidates
 - Panel of Assessors Existing Number and Eligibility
- To explore the possible ways to strengthen CPD requirements for newly-qualified GP surveyors with a view to helping them boost their surveying careers.
- To set short, medium, and long term growth rates in membership and recommend action plans (and implementation timelines) with a view to achieving the targeted membership growth rates and providing regular reports for the GPD Council's consideration and endorsement.

GPD Education Committee

APC Part I Re-examination

In order to help probationers get through the APC Part I Assessment faster, the GPD has agreed to conduct an additional Part I Written Assessment (hereafter the "Part I Reexamination") for those referred candidates from 2016. The Part I Re-examination will be held on 4 March and 11 March 2017 (Saturdays). Only probationers who attempted the last Part I Written Assessment in October 2016 will be invited to re-sit for the coming Part I Reexamination. A briefing session to all eligible probationers was held on 9 February to explain the re-examination arrangements.

The aim of the Working Group is to promote the role of land surveyors in Hong Kong's development into a smart city and advocate the importance of SDI as the key infrastructure of a smart city.

Boundary

To continue working on the site area determination under the General Plan Submission to the Building Authority, the Chairman of the Land Boundary Committee (LBC), Sr Prof SC Leung, reported that the LBC aimed to seek the consent of the Survey and Mapping Office (SMO) to conduct cursory checks on land boundary plans (LBPs) prepared by authorised land surveyors under the General Boundary Plan (GBP) Submission.

These LBPs shall follow the requirements of the Code of Practice, even though they are not for lot subdivision surveys. A time limit of 60 days for the relevant District Survey Office (DSO) to reply to the submission, so that it could cope with the same time limit for a GBP submission by the authorised persons (APs) to the Buildings Department, has been proposed.

The LBC proposed a procedure for GBP submissions:

- 1. The SMO introduces a submission fee for the LBP to be paid under the GBP submission in the long run.
- 2. In every GBP submission for a development project, the AP is expected to appoint a project ALS for a relevant LBP submission. The SMO should follow up/liaise directly with this appointed ALS for all boundary and/or land surveying issues instead of going through the DLO because that would override the professional status of a land surveyor.
- 3. The boundary lines of lots that have gone through the above checking procedures should be updated and shown on the lot index plan.
- 4. The SMO should clearly stipulate the kind of survey data and lot information, if any, that is restricted to private ALSs. In this connection, the old SRPs of any source should not be restricted by referencing the "Privacy Ordinance" because they are not feasible for obtaining consent from retired, migrated, or even deceased Al Ss
- 5. Data/information so restricted should not be subsequently used by the DSO to comment on LBPs submitted by private ALSs.
- 6. The SMO will impose the same standards and practices on all DSOs and officers.

Sr Prof Leung further reported that during a recent Authorised Land Surveyors meeting with the Land Survey Authority (LSA), the LSA indicated that the SMO could only accept voluntary submissions from ALSs. The SMO would look into a submitted boundary re-

establishment case upon the request, say, of the Buildings Department. The LBC will continue to communicate with the LSA on the GBP submission procedure.

Membership

Recruiting newly-qualified land surveyors is one of the HKIS's most important tasks, if not the most important one. Its Office Bearers have always kept this role in mind. One of the channels for attracting newly-qualified members is the "direct membership route" and is being considered by the HKIS. Should there be a favourable decision on the proceedings of such a proposal, it would be subject to a vote by all HKIS members.

In the near future, the LSD will have only one route for entry as a corporate member – the Assessment of Professional Competence (APC). Many non-members, including experienced land surveyors, have been unhappy with the two-year instituted training period for the APC. I vocally reiterated that for an experienced practitioner, whether a construction surveyor in a mega infrastructure project or an academic at a local university, the Divisional Education Council may reduce the required training period to one year. I sincerely urge our related colleagues to consider this route.

For the professional qualification of Resident Land Surveyor, the Government recognises the HKIS's professional qualification or its equivalent. However, the previous mutual agreements, which were categorised as equivalents, all expired a few years ago.

Last year, the LSD wrote to the Civil Engineering and Development Department (CEDD), Airport Authority, and AECOM to state the abovementioned fact. A group of professional surveyors working on infrastructure projects also communicated with then-President Sr C K Lau on this issue last year. Current President Sr

Thomas Ho, LSD Vice Chairman Sr Edmond Yu, Council member Sr Michael Wong, and I met with a group of professional surveyors consisting of TN Wong, SRLS-AECOM CWB; Frankie Yip, SRLS-AECOM BCF; Gary McAuslan, SRLS-AECOM LTH BCP; Clayton Li, RLS-AECOM TM-CLK Link; To Kai Chan, RLS-AECOM TM-CLK Link; Mark Chung, RLS-AECOM TM-CWB; and Roy Lim, RLS-AECOM BCF in the HKIS Board Room on 8 February to follow up on it.

The group asked the LSD to issue a letter to the CEDD, Highways Department, and AECOM to accept those who qualified before 2 January 2014 (for the RICS) and August 2015 (for ICES) as equivalent qualifications to HKIS membership under the terms and conditions stipulated in the Reciprocity Agreements that were in force between the two organisations and the HKIS before the two respective dates indicated above. I agreed to bring this issue up for the decision of the LSD Council at the next meeting.

Both sides believed that there are an insufficient number of senior and corporate resident land surveyor posts in Hong Kong's current construction projects. The LSD will join the negotiations with the relevant government bodies and construction institutes over this matter. For the sake of promoting construction surveyors, the group proposes increasing the ratio of professional land surveyors to engineers who work as resident site staff (RSS) in the Government's infrastructure projects:

- 1. One CRE should have at least one senior land surveyor, one land surveyor, and two assistant land surveyors.
- 2. Two CREs should have one senior land surveyor, two land surveyors (one for each contract), and two assistant land surveyors (one for each contract).
- 3. One PRE and four CREs should have a chief land surveyor, two senior land surveyors, and four land surveyors (one for each contract).

We need our professional members to speak up for our industry. The HKIS is the most appropriate platform for raising our voices to the Government and the general public.

Ideal Lives," which made a remarkably good impression on attendees during the award presentation on 29 September 2016. In order to allow more members and practitioners to improve their practices and be inspired to seek higher standards for the industry and community, the PFMD organised a half-day visit to QPFMA 2016's three winning sites on 21 January. HKIS Media Luncheon 2017

The HKIS arranged a media luncheon at the World Trade Centre Club, Causeway Bay, on 8 February. It was well-covered by the media. Four QSD spokesmen Sr Raymond Kam (Chairman), Sr Raymond Kong (Vice Chairman), Sr Paul Wong (Immediate Past Chairman), and Sr Keith Yim (Past Chairman) attended the event to answer media enquiries and share their professional points of view on issues related to quantity surveying.

Meeting with the Development Bureau on the Use of NEC in Hong Kong

Several QSD representatives, Sr Keith Yim, Sr HY Wan, and Sr Tiffany Chan, met the representatives of the Development Bureau, Mr Edwin Wong, Chief Assistant Secretary (Works); Mr Benjamin Chan, Assistant Secretary (Works Policies); and the Secretary of the NEC Users Group from England, Mr Robert Gerrard, on 10 February. During the meeting, all parties exchanged in-depth views and opinions on the applicability of NEC to public works projects in Hong Kong. The QSD raised its concerns, which included the effectiveness of NEC in controlling a project's time and budget, public accountability due to the project manager's dominant role in NEC, and the importance of maintaining an independent cost consultant role in public works projects. The Development Bureau expressed that all feedback on NEC from different stakeholders was welcomed and would be considered.



Developing a BIM-Based Programme Based on Preliminary FM Guidelines for Care and Attention Homes

Background

Hong Kong has one of the world's highest life expectancies and lowest fertility rates, which have contributed to its growing elderly population. The number of elderly in Hong Kong has been estimated to rise from 1.12 million (15.4% of the total population) in 2015 to 2.32 million (28.6% of the projected total population) in 2035 (Census and Statistics Department 2015). This phenomenon is expected to bring with it various problems such as a greater proneness to diverse diseases and disabilities, an increasing level of dependence and care, etc. To tackle Hong Kong's ageing problem, over 755 care and attention (C&A) homes have been constructed to provide accommodation for its elderly (Subcommittee on Retirement Protection 2012).

C&A homes in Hong Kong are gradually adopting the concept of continuity of care. Elderly people with different psychological or physical health conditions tend to live in the same areas. However, C&A home operators should consider that their patients' health will, on average, deteriorate as they age. A good facilities management (FM) programme in C&A homes is necessary to ensure that they live their golden years in safe environments and enjoy healthy social lives.

A preliminary FM guideline for C&A homes has been established via a systematic study supported by a grant from the Innovation and Technology Fund of the Hong Kong Special Administrative Region, China (Project No.ITF13-ITS/319/13). It consists of: (1) extensive literature; (2) onsite measurements; (3) radio frequency identification devices (RFID) to monitor space utilisation and traffic patterns; (4) questionnaire surveys; and (5) focus groups. In addition, to ensure that the FM guideline satisfies the needs of Hong Kong's elderly, a BIM-based programme has been developed based on a preliminary FM guideline for C&A homes. The detailed data analysis has been reported to the government and is not shown here. This article shares parts of the preliminary FM guidelines and our BIM-based programme for C&A homes.

Preliminary FM Guidelines for C&A Homes

Based on the findings of the study, a drafted FM guideline, namely, the FM(C&A) Guideline, includes three main sections (space management, building services, and support facilities), was prepared for the C&A homes. Space management covers the home layouts, functional spaces, floor levels, doors, and windows, while building services include ventilation, water supply, and vertical transportation. Support facilities consist of finishes and 18 fixture and furniture types. Some recommendations related to the layout of C&A homes were abstracted from the FM(C&A) Guideline as follows:

- a) The administrative area should be located next to the main entrance and have a good view of the entrance. This area enables live-in wardens to manage everything from residential care to building maintenance. In addition, the administrative office should connect to the reception counter.
- b) Function rooms, such as physical therapy, computer, exercise, and staff rooms (e.g., nursing, office, and changing rooms), should be located at the centre of the C&A home. Such a layout plan would not only facilitate the working processes of caregivers, but also ensure a certain amount of physical exercise (i.e., walking) for the elderly.
- c) The living and dining rooms shall be in proximity to the elderly living quarters, which ensure a reasonable distance for elders travel between living/dining room and bedrooms, so that long distances and travel times can be avoided. The mobility of the elderly is affected by the weather and conditions of their health. Hence, they may not be able to travel long distances from their bedrooms. A communal area for social activity should be arranged somewhere next to the corridor, as such an area can enhance the social relationships among the elderly.
- d) The isolation and hope rooms should be located close to the medical treatment room for easy access, while a family room should accommodate the patient's family members who want to stay for a while at the home.
- e) Zoning by colours is a possible way to separate C&A homes into different sections or areas, such as for storage, sitting, bedrooms, and so on, according to their uses and functions. This will help the elderly identify where they are. The colour of a particular section, such as the sitting area, should match that of other sitting areas.
- f) To create a feeling of home for the elderly, bedrooms or dormitories should be grouped together in each wing or location, while a group of dormitories could be considered a community. Bedrooms should have easy access to corridors and be near bathrooms and toilets.

- g) It is best that all main bedrooms be ensuite. At least one *toilet* with a wash basin for the elderly should be provided in each bedroom. The distance between the bedrooms and the toilets or bathrooms significantly affects the hygienic and satisfaction levels of the elderly. The placement of toilets requires further consideration when determining the locations of the bedrooms.
- h) A walking area should be provided in every C&A home. Elderly people with dementia are still physically active and tend to wander. If there is enough space, a walking area should be provided. If not, an indoor corridor can also act as a walking path. It is necessary to ensure that the movement of the elderly along corridors or other places will not hinder the normal traffic patterns of their fellow patients and staff.

BIM-based Programme for C&A Homes




Figure 1 BIM-based programme for FM(C&A) homes

Based on the preliminary FM(C&A) guidelines, a number of family FM members have also been established including different types of doors, windows, lighting, air-conditioners, cabinets, mobility aids, chairs, shower beds, tables, curtains, etc. All FM(C&A) guidelines and the BIM-based family members have been integrated into a BIM programme, which comprises two browsers (a project browser for building components such as architectural floor plans, ceiling plans, structural plans, etc., and a property browser for detailed information on building components and family members; see Figure 1). Endusers, either construction professionals (architects,

building service engineers, interior designers, facilities managers, etc.) or operators (superintendents, social workers, occupation therapies, etc.), can then change each home's design by simply inserting, omitting, or moving family members according to the drawings in the BIM programme.

Summary

The elderly in C&A homes suffer from diverse diseases and disabilities in their daily lives, which should dictate the basic FM needs required to support their activities. In order to meet their needs, this study briefly summarises their behavioural patterns and daily activities so that appropriate spaces for them could be incorporated into C&A homes. Based on the outcome of the study, a preliminary FM(C&A) guideline has been suggested for improving the general health of the elderly in Hong Kong's C&A homes. It establishes the minimum standards for the design of elderly homes, so as to ensure that the quality of life for the elderly meets a certain level. The results of this study should provide a platform for a more comprehensive guideline of the elderly's living environment in C&A homes throughout Hong Kong and the world.
