

BIM is a Big Boon

Building Information Modelling not only can make life easier for surveyors, it can also mean simpler, more cost-effective construction

BIM makes 3D diagrams easier to read. It shows information intuitively so that different industry players can store and retrieve information at different stages of construction, as well as present results and make direct comparisons.

The 2017 Policy Address proposes using Building Information Modelling (BIM) technology to help improve productivity. In this issue, we will explore how BIM helps surveyors, its strengths, limitations and applications in Hong Kong, and whether it offers a solution to labour shortages and high construction costs.

Sr Lam Lit-yin, Council Member of HKIS' LSD Land Surveying Division Council and General Manager of D-Reality Consultancy Limited, uses the imagery of a "3D file manager" to describe BIM, which facilitates the storage and recall of information among users.

In the past, surveyors made traditional 2D diagrams on paper for sizes and locations, after which engineers did calculations about reinforced concrete and cement. Professionals then cross-checked onsite structures with the diagrams to ensure consistency.

Since the introduction of computers, the industry has moved from 2D filing to 3D or above. Building on the basic information about colour, rendering and material, other dimensions such as time, placing, budgeting, as-built model, accident/safety reports, environmental reports, and complaints are now added, to enable 4D, 5D, 6D, 7D, and a potentially unlimited number of dimensions.

"BIM makes 3D diagrams easier to read," says Lam. "It shows information intuitively so that different industry players can store and retrieve information at different stages of construction, as well as present results and make direct comparisons. With some training, non-professionals can read and understand the diagrams. This helps professionals communicate with clients, district councils or other stakeholders to eliminate misunderstanding and enhance transparency and communications."

As BIM information can be stored via cloud computing, different professionals get the same information in real-time. This saves time and reduces inaccuracies, disputes, claims, delays or over-budgeting. Frontline workers on site can easily view augmented reality (AR) and virtual reality (VR) on computer tablets to ensure a perfect

match. The enhanced efficiency may help alleviate problems caused by labour shortages, and increase productivity.

There are two kinds of BIM models: Design and As-Built. For new mega projects, Design BIM Models are generated from the very beginning, in order to facilitate facility management later. For existing structures, land surveyors can capture their existing status via laser scanning and photogrammetry to generate As-Built BIM Models, which again facilitates facility management.

As such, BIM is useful for environmental and heritage preservation. For instance, for eco-friendly heat-reducing vegetation at external walls of buildings, BIM helps file information about watering, fertilisation, cost, and suppliers for easy maintenance. For heritage structures such as Queen's Pier or Lui Seng Chun, laser scanning generates As-Built BIM Models before demolition or revitalisation, which can later contribute to new Design BIM Models for redevelopment.

Lam thinks BIM provides opportunities in the long term but faces challenges in the short run. "BIM involves a total transformation of the work culture and heavy initial input. It encourages detailed planning from day one and the adoption of BIM from the beginning to the end of the building cycle, i.e. from design tender all the way to building maintenance. Foreign studies show that initial costing at the beginning has risen from only 5% of the total project cost without BIM, to up to 20% with BIM."

With BIM's good file management however, project costs towards the end are expected to decrease and offset the initial costing, resulting in an overall reduction. Having said that, the question remains as to how the initial bottleneck can be solved, i.e. who is going to bear the initial cost and allocate resources.

"Traditionally, during the initial stage of the design tender it has not been common for developers or contractors to make decisions about postconstruction work," Lam says. "It is only when a major corporation is responsible for the entire building cycle from end to end that a comprehensive BIM adaption

is facilitated. Smaller firms can hardly ensure that other vendors abide by the same standards, not to mention the fact that smaller developers usually consider the handover to facility management as the end of their involvement."

Lam therefore thinks that government incentives or mandatory requirements will be useful. "This had been the case in mainland China and Singapore, and even in Western countries. While some projects by individual government departments in Hong Kong have such requirements, there is not yet a consensus for entire project adoption."

Besides, Lam believes another way is to involve and benefit minority owners, i.e. give them BIM models of units they have purchased, so that they can carry out management and maintenance more easily. Neighbouring owners can then join together to hire firms to do facility management of the entire building with BIM models combined. The resulting transparency would help reduce bail-rigging or overbudgeting.

Sr Sunny Choi Shing-lam is Senior Quantity Surveyor/ Project Services of the Housing Department, Honorary Secretary of HKIS Quantity Surveying Division, and BIM Subcommittee Chairman. He agrees that BIM can improve productivity. "Generally speaking, Hong Kong's building industry has a 'rush' culture. Some design details are not yet complete before a project is tendered out. As a result, in the post-contract stage, project variations and abortive work are not uncommon."

"With the adoption of BIM, the whole design phase has to be advanced. Architects and engineers have to contribute their models in good time to form the combined design model. Any clashes or discrepancies between models can thus be easily identified and rectified at an early stage. This reduces time and human resources for handling project variations during construction stage."

BIM enables visualisation of the 3D design of a project. This is very useful when assessing potential sites and doing feasibility studies. Teams can examine computer-generated results and work

through different parameters and design options. "All surveyors will benefit from BIM," Choi says. "For a quantity surveyor, BIM models contain information on quantity and technical specifications of objects like doors, windows, walls and floors to facilitate measurement and cost estimation. Moreover, BIM's parametric modelling allows immediate visualisation of change in design and gives the corresponding change in quantity. On-screen digitised measurement reduces repetitive manual work. A digitised database can be created, which facilitates efficient value engineering and 5D BIM for clients."

"BIM is particularly useful for construction that involves a lot of coordination of routing, installation, and management of voluminous data for asset or facility management. It enables sophisticated landmarks with complex geometry."

Since BIM requires earlier design coordination, it allows for more prefabrication, which in itself can be a solution to combat Hong Kong's labour shortage and high construction costs.

The Housing Department has made use of BIM in its New Works Capital Works projects since 2014/15. The Development Bureau, after testing BIM in several pilot projects, recently issued a circular about adopting it for capital works over HK\$30 million from 2018. The Construction Industry Council (CIC) has upgraded its Task Force on Roadmap for BIM Implementation to establish a new Committee to lead implementation in the sector.

"BIM's inclusion in government projects gives a direct push to the industry, I hope the framework can be further strengthened by standards prepared by CIC and BIM contract conditions drafted by the HKIS."

As for the future, Choi considers BIM to be a must. "Whereas the Hong Kong 2030+, East Kowloon and Kai Tak plans realise the vision of building a smart city with big data, BIM will be part of the bigger vision, combined with smart transport and communication in order to proceed to full digitalisation."

善用建築信息模擬技術

建築信息模擬技術不但可以減輕測量師的工作,同時也可簡化建 築程序和增加成本效益。

2017 年施政報告建議利用建築信息模擬 (BIM) 技術提升生產力。本期封面 故事將探討 BIM 如何協助測量師工作,有關技術的優點、限制、在香港的應 用情況,以及能否解決建築業人手短缺和建築成本高昂這些問題。

香港測量師學會土地測量組理事及現實點顧問有限公司總經理林烈賢測量師 形容 BIM 為「三維檔案管理員」,有助用戶之間儲存和讀取資料。

測量師過往在紙上繪製平面圖去表達建築物的大小和所在位置,然後交由工程師計算所需的鋼筋水泥。其他專家則按照平面圖實地檢測建築物,確保建築物符合平面圖所述內容。

隨著電腦出現,業界由平面圖轉而使用三維或其他多維檔案。在考慮到顏 色、繪圖和物料這些基本資料後,業界還可以加入其他資料,例如時間、位 置、成本預算、竣工模型、意外/安全報告、環境報告和投訴等,製作四維、 五維、六維、七維,甚至其他多維檔案。

林烈賢指:「BIM 有助理解三維圖像,直接顯示資料,不同業者可以在建築過程中儲存及讀取資料、匯報結果和直接比較資料。即使並非行業專家,只要經過練習,也可閱讀及瞭解圖表,變相有助專家與客戶、區議會或其他持份者溝通,消除各方誤解和提高透明度,加強溝通。」

由於 BIM 資料可作雲端儲存,各界別的專業人士都可以取得實時資料,不但節省時間,更可減少出現誤差、爭議、索償、延誤或超支等情況。前線人員可實地透過平板電腦的擴增實境和虛擬實境應用程式查看資料,確保圖樣與實物百分百吻合。提升工作效率,可紓緩因人手短缺所引致的問題,更可提高生產力。

BIM 可分為「設計」及「竣工」兩大類。在開展新大型工程項目時,工作人員會創建設計類 BIM 模型,以便日後管理設施。至於現有建築,土地測量師可以透過激光掃描和攝影測量術捕捉其現狀,創建竣工類 BIM 模型,用以日後管理設施。

因此,BIM 有助環境及歷史保育。例如,在樓宇外牆種植節能降温的植物,使用 BIM 可將澆水、施肥、成本和供應商等資料存檔,方便管理。以皇后碼頭或雷生春等歷史建築為例,在進行清拆或活化工程前,只需利用激光掃描創建竣工類 BIM 模型,日後進行重建工程時,方便創建設計類 BIM 模型。

林烈賢認為 BIM 長遠可提供各種機會,但短期內要克服不少挑戰。「BIM 需要從根本上改變工作文化和進行大量前期工作。換言之,工程一開始便需要進行詳細規劃,BIM 將貫穿整個建築周期,包括設計招標直至樓宇保養階段。外國研究顯示,在不使用 BIM 的情況下,涉及的前期工程成本佔整體項目開支 5%,但在使用 BIM 的情況下,有關成本將大幅攀升至最高 20%。」

但是,BIM 具備優良的檔案管理功能,有助減少後期工程開支,抵銷前期工程成本,達致減省整體開支的效果。但最初的樽頸問題:誰人承擔前期成本及分配資源,如何解決?

林烈賢解釋:「傳統上,在設計招標的前期階段,發展商或承辦商很少決定工程後期的施工。只有需要監督整個建築周期的大型公司才會採用全面的BIM。規模較小的公司難以確保其他供應商跟從同樣的標準;規模較小的發展商往往認為,只要把樓宇交到負責管理設施的第三方,自己便可功成身退。」

因此,林烈賢期望政府推出其他鼓勵或強制措施。「中國內地、新加坡,以至西方國家的情況正是如此。雖然香港個別政府部門的工程有此類要求,但現時仍未就應否在整個項目周期採用 BIM 達成共識。」

另外,林烈賢相信另一個讓小業主參與和受惠的方法,是為他們提供所購置單位的 BIM 模型,讓他們更有效地管理及維修單位。相鄰單位的業主可合資聘用公司,結合 BIM 模型來管理整座樓宇。這樣增加透明度,將有助減少圍標或超支等情況。

房屋署的高級工料測量師(工程事務)、香港測量師學會工料測量組的義務 秘書及建築信息模擬小組委員會主席蔡盛霖測量師同意 BIM 有助提升生產力。「香港的建築界一般有『趕工』的情況出現。一些設計細節在工程投標前也無法落實。因此,即使到了後期的施工階段,修訂或甚至白幹重做工程的情況也時常會發生。」

「採用 BIM 後,整個設計階段便需要提前進行。建築師和工程師需要及時交出自己設計的模型,才可結合成總體的設計模型。方便找出互相不協調的地方並盡早作出修正,減少在施工階段需要修訂工程的時間和人力資源。」

BIM 可呈現工程項目的三維設計,有助評估項目所在位置的四週環境和研究項目的可行性。工作團隊可以根據電腦的運算,審視不同參數和設計選項。蔡盛霖表示:「所有測量師都可以選用 BIM。對於工料測量師來說,BIM 模型包括數量和技術規格的資料,好像門、窗、牆和地板等物件,方便量度和估算開支。此外,BIM 的參數建模功能可以即時呈現設計上的改變,並調整相應物料的數量。數碼化量度物料的方法可減省重複的人手工序。建立數碼化數據庫後,工料測量師可為客戶提供更快捷的工程估算及五維 BIM 服務。」

「BIM 特別適用於需要協調複雜的線路與設備安裝,以及管理大量涉及資產或設施管理數據的建造工程,再者,BIM 可應用創新的幾何設計,落實地標性的建築。」

由於 BIM 需要在早期協調及完善設計,變相可支援使用大量預製組件,這有望解決香港建築業人手短缺和建造成本高昂等問題。

房屋署自 2014/15 年度起已開始在多個新建築工程項目採用 BIM。發展局在數個先導項目中測試 BIM 後,最近亦發出一份技術通告(工務),表明由 2018年起,所有推行超過 3,000 萬港元的基本工程均須採用 BIM。建造業議會改組

原有的實施建築信息模擬路線圖工作小組, 升格為一個新委員會,推動 BIM 技術。

「在政府工程項目中採用 BIM,有助推動業界採用有關技術。我期望建造業議會擬訂的標準以及香港測量師學會草擬的建築信息模擬合約條款能夠加強有關工作。」

蔡盛霖認為 BIM 是未來工程的必要元素。「香港 2030+、東九龍和啟德規劃實現以大數據建構智慧城市的願景。BIM 將會是這願景的一部分,有望與智能交通及通訊結合,成就全面數碼化。」

Mentor

In the past, we only worked closely with university undergraduate programmes but now we hope to build a one-of-a-kind mentorship programme involving graduates and undergraduates in the surveying field, as well as secondary school students, and even undergraduates from outside the surveying field. It's like life planning – a departure from the previous purely academic or professional mentorship approach. I am confident that greater exposure to the HKIS will prove intriguing to more youngsters and encourage them to consider surveying as their ultimate career. Subject to the General Council's agreement, we hope this new mentorship programme will come into effect next year.

Growth

Growth both within and outside the HKIS is something we look forward to in the coming year. Through the reviewing and fine-tuning of our Assessment of Professional Competence (APC) and examination programmes, we would like to enhance the quality of young surveyors whilst attracting higher-calibre candidates through our all-round programmes. Externally, we hope to embrace other associations and professionals via different networking approaches such as alliance, reciprocity and affiliation, leading to greater and stronger bonding. This is not restricted by geographical location, and my aim is to explore new opportunities, whether they emerge locally or internationally. The HKIS will continue to deliver positive messages to youngsters and encourage them to work and study hard for a better future. Moreover, Mainland China will be emphasised more strongly due to the immense opportunities triggered by the "Belt and Road Initiative" and the "Greater Bay Area" scheme.

I am confident that this will be a common goal which all our members will be happy to pursue and contribute personally to its success.

齊心協力

參與

「區區有特色」地區發展創作比賽有助測量界建立良好公眾形象,來年我們將繼續舉辦有關活動,而且將更具規模和特色。我們將稍後公布活動的主題社區,但將優先考慮能夠展現豐富新舊歷史元素,與香港同步發展的社區。為了將活動辦得更有聲有色,我們會邀請來自不同界別的持分者參與。除本地學校外,我們亦會邀請非政府機構、政府和公眾人士參與,學會期望透過活動與不同界別建立聯繫。

啟導

過往師友啟導計劃的對象多為修讀相關課程的本科生,但我們希望擴闊計劃的對象,包括測量界的畢業生和本科生,以及中學生,甚至是修讀其他專科的本科生。有別於過往純學術或專業性質的啟導模式。今後計劃將傾向職業生涯規劃,相信全新的「師友同行計劃」,將吸納更多新血入行,推廣測量專業,促進行業持續發展。預期新計劃經理事會同意後最快可於明年展開。

發展

For this new government, housing and land supply will continue to be at the top of our agenda. A steady land supply is critical for Hong Kong's future as it's the cornerstone of the city's sustainable progress.











Well-established among members as a major highlight of its social activities, the HKIS Annual Dinner on the evening of 14 November was deemed a highly successful event celebrating and closing the Institute's year. As usual, seats were snapped up far ahead of the deadline, and all 49 tables at the glitzy Grand Hyatt Hotel Ballroom were packed with members, partners and distinguished guests from related government departments.

President (2016-2017) Sr Thomas Ho has wrapped up a fruitful year for the Institute, achieving notable advances in several important fields including public image promotion, public policy participation, and external collaboration. He said, "The long-awaited HKIS Long-Term Branding Project kicked off with the launch of the Create Your District Competition 2017, aimed at providing opportunities for secondary school students to gain a better understanding of the role of surveyors in all aspect of the land and property development process, as well as for students to unleash their creativity in developing their ideal future cityscapes.

"Apart from facilitating our overseas connections and developments like the Greater China Belt and Road countries and Canada, the HKIS also proactively voiced its professional opinions on public policies by holding press conferences, distributing press releases and issuing letters to the government on matters which included seven suggestions for the new government, plus views on land supply, housing and building matters."

Sr Ho's remarks were followed by a Vote of Thanks from Sr Dr Tony Leung, Chairman of the Organising Committee, who had given a warm welcome to all those attending the event, describing 2017 as a very meaningful year. In addition to recognising President (2016-2017) Sr Thomas Ho's continued leadership and dedication to the Institute, he also extended his sincere gratitude to the Organising Committee members, fellow HKIS members and staff in the HKIS secretariat office, for all their valuable contributions to this successful and happy event.

EVENT SPOTLIGHT

Sr Dr Leung said, "I felt very lucky to receive support and recognition beyond my imagination. To all guests sitting here in this room, your presence and continued support means a great deal to us. We are exceptionally grateful for the support given by countless stakeholders in our industry, many of whom have generously sponsored tonight's event. We look forward to further collaboration with each and every one of you for many years to come. Last, but certainly not least, I would like to declare that it has been a real pleasure working with all of you."

Prior to joining a toast to the guests by HKIS Past Presidents, Office Bearers, Board Chairmen, Divisional Chairmen & YSG Chairman, Guest of Honour Mr Paul Chan Mo-po, Financial Secretary of the HKSAR Government, ascended the stage to express his heartfelt gratitude for the HKIS's proactive contributions over the years. He said, "As the largest and most prominent surveyor association in town, with more than 9,500 members, you have provided different, yet much appreciated, advice to the government, and in a multitude of areas from development planning and building roads, to building construction, property management and housing management, thereby helping the government to formulate policies. I am well aware of this constructive help during my four-and-ahalf years as Secretary for Development.

"For this new government, housing and land supply will continue to be at the top of our agenda. A steady land supply is critical for Hong Kong's future as it's the cornerstone of the city's sustainable progress; on that, I am glad to see that the government's multipronged approach to push land supply for housing has started to bear fruit over the past five financial years ended 2016-17. To be sure, land development is a lengthy process that can easily stretch out from planning to realisation, which is why a concerted effort continues."

Mr Chan also indicated that the government estimated that major land supply initiatives in the short-to-medium term could yield over 380,000 private and public housing flats. Of these, some 310,000 units would be provided through the rezoning of about 200 sites identified in its land use review. He added, "Looking at the medium-to-long term, we estimate that major

supply initiatives will provide more than 200,000 flats – clearly, the key sources will be new development areas and New Town extensions. You are aware that this government formed a Task Force on Land Supply in September with a view to building the vital consensus that we need. It has been working full steam since its establishment. Public engagement is planned for the first half of next year, and this complements a community consensus on land supply options and strategies.

"Alongside increased land supply, the Development Bureau is now exploring how best to rationalise planning land and building standards and definitions. Not an easy task to maintain essential procedure and professional requirements. I welcome your input. I know you have much to contribute in this area beyond planning and land issues."

Turning to existing challenges such as ageing buildings, Mr Chan said that of 40,000 private buildings in Hong Kong, more than 7,000 are at least 50 years old, and that another 10,000 are expected to reach the half-century mark by 2034. The government's HK\$5 billion "Operation Building Bright" initiative will resolve the problem. This targets domestic buildings that are at least 50 years old and have a relatively lower rateable value. It also responds to public safety concerns. He said, "We plan to roll it out in the second half of 2018, and expect it will benefit 2,500 buildings over the next five years. I am confident that it will make a difference. But government can't do it alone; we need the cooperation of the entire community. In particular, we will be counting on the advice of your Institute and your members."

During the entertainment session, the 12-member Chinese Orchestra Group from Hong Kong Rehabilitation Power was invited on stage to perform three popular songs, while the Metro Vocal Group from the United States heightened the mood of guests with four foreign vocalists singing Cantonese and Mandarin songs.

一眾會員翹首以待的香港測量師學會周年晚宴在 11 月 14 日圓滿結束。新舊會員聚首一堂,共享成果之餘,亦回顧過往一年會務。一如既往,本年度晚宴座無虛席,於香港君悦酒店宴會大禮堂筵開 49 席,本會會員、合作夥伴代表以及來自政府相關部門的嘉賓皆有出席。

2016-2017 年度會長何國鈞測量師,總結本會在過去一年取得的 豐碩成果,包括成功提升公眾形象、積極參與制訂公共政策及拓 展外部合作等。他表示:「香港測量師學會展開品牌推廣計劃, 首個活動是『區區有特色』地區發展創作比賽 2017。活動旨在 讓中學生更深入地認識測量師在土地與物業發展過程中的角色, 同時鼓勵同學發揮創意,描畫心目中理想的未來城市面貌。」

「本會致力拓展在『一帶一路』沿線國家和加拿大等地的海外合作機會和參與相關發展計劃,同時舉行記者會、發布新聞稿和向政府提交信件,積極就各項公共政策發表專業意見,其中包括向新一屆政府提交了七項建議,並就土地供應、房屋與建築物事宜提出意見。」

何國鈞測量師發言後,周年晚宴籌備委員會主席梁家棟博士測量師緊接向來賓致謝。他熱烈歡迎各位蒞臨晚宴,並形容 2017 年極具意義。他讚揚會長 (2016-2017) 何國鈞測量師熱心處理會務,積極帶領本會向前發展,又感謝籌備委員會成員、本會會員及秘書處員工,籌辦了這次美滿愉快的活動。

梁家棟博士測量師表示:「能夠得到各位的支持和認同,我感到十分欣慰。在座各位來賓撥冗出席晚宴,以及大家一直以來給予的支持,都是推動我們進步的動力。我們特別感謝一眾業界同仁的支持,當中不少慷慨贊助了今晚活動。在未來的日子,我們期待與各位加強合作。最後,我感到很榮幸能夠和各位合作。」

在聯同本會前會長、理事會成員、委員會主席、專業組別主席和青年組主席向各位來賓祝酒之前,主禮嘉賓香港特區政府財政司司長陳茂波先生上台致辭,感謝香港測量師學會多年來的積極貢獻。他表示:「香港測量師學會是城中最大規模和最具知名度的測量師組織,會員人數達9,500人。貴會致力就發展規劃、道路興建、樓宇建築、物業管理和住屋管理等議題向政府提供寶貴意見,協助政府制訂政策。在過去擔任發展局局長的四年半時間裡,我深深體會到貴會多方面為政府提供具建設性的支援。」

「本屆政府繼續視房屋與土地供應為首要施政目標。穩定的土地 供應對香港的未來發展尤其關鍵,這是城市持續發展的基石。本 人樂見政府就增加住屋土地供應制定了多項措施,這些措施截至 2016-17年,在過去五個財政年度漸見成果。由規劃至完工,土 地發展過程漫長,需要各方持續合作。」

陳茂波先生指出,政府預計透過主要土地供應措施,在短中期可增建380,000個私人及公共房屋單位,其中310,000個單位來自當局檢討土地用途中重新規劃的約200幅土地。他補充指:「從中長遠角度而言,我們預計各項主要供應措施將可提供逾20萬個單位,新發展區和新市鎮拓展計劃將成為主要土地來源。本屆政府在9月成立了土地供應專責小組,希望取得各方共識。專責小組自成立以來全力開展相關工作,並計劃於明年上半年啟動公眾參與活動,爭取社會對土地供應方法和策略方面的共識。

「除了增加土地供應,發展局也在探討如何理順土地規劃和樓宇 的標準與定義。要兼顧基本程序和專業要求並非易事。歡迎各位 就此提出意見,相信各位在規劃與土地事宜以外其他方面亦能出 謀獻策。」

談到樓宇老化等現有挑戰,陳茂波先生表示,香港四萬幢私人樓宇中,超過7,000幢的樓齡已超越50年,而另外一萬幢的樓齡也將於2034年或之前突破50年大關。政府斥資50億元推行「樓宇更新大行動」計劃正好對症下藥。計劃將重點涵蓋樓齡最少50年及應課差餉租值相對較低的住宅大廈,亦藉此回應公眾對舊樓安全問題的關注。他表示:「我們打算在2018年下半年推出計劃,預期未來五年將有2,500座樓宇受惠。我深信計劃有助解決問題,但這不可能單靠政府的力量,社會各界必須攜手合作,共同參與其中。貴會和各位會員的寶貴意見,將為計劃注入重要力量。」

當晚的娛樂表演環節,請來由香港復康力量 12 位成員組成的中樂團上台獻技,為各來賓演奏三首金曲;而來自美國的 Metro Vocal Group 四位成員更為大家獻唱粵語和國語歌曲,把現場氣氛推到高點。

HKIS's 4 Key Suggestions on Elderly Housing Policy

The HKIS made 4 key suggestions on Elderly Housing Policy at a press conference on 7 December 2017.

Aging population has been a major concern in Hong Kong. According to the latest population projections by the Census and Statistics Department, it is estimated that the elderly population will reach 2.61 million by 2047. It means that nearly one in three Hongkongers will be elderly by that time. There are currently relevant policies on residential care, medical care and social services, but regrettably, none are related to elderly housing. In order to achieve the goal of "ageing-inplace", an elderly housing policy should be formulated.

Sr C K CHAN, Chairman of the Housing Policy Panel of the HKIS, briefly introduced the proposal on Elderly Housing Policy and outlined 4 key suggestions as below. "The purpose of the ageing-in-place is to provide suitable housing environment and appropriate care services for the elderly, enabling them to remain home whilst maintaining their quality of life, and pushing back their time of moving into elderly care homes.'

- 1. Promote "Elderly Housing Scheme"
- 2. Encourage Elderly-friendly Designs
- 3. Include the Land Use of Elderly Housing and the Provision Standard for Elderly Facilities in the Planning Standard and Guidelines
- 4. Establish an Elderly Affairs Committee and in the long run a Policy Bureau

HKIS Valuation Standards 2017

The General Practice Division (GPD) Council initiated a review of the HKIS Valuation Standards 2012 Edition with regard to two newly launched standards - International Valuation Standards 2017 and RICS Valuation - Global Standards 2017.

The HKIS Valuation Standards 2017 ("the Standards") were approved by the General Council on 9 October 2017, and ratified by resolution at the General Meeting on 8 December 2017. The Standards aims to provide appropriate directions or guidance to members so that the valuations/reports prepared by them can achieve the highest standards of professionalism, integrity, clarity, reliability and impartiality; and that the valuations/reports are prepared in accordance with the recognised bases that are appropriate for the purposes of their preparations.

The Standards will replace the HKIS Valuation Standards 2012 Edition and will come into effect on 30 December 2017.

The Standards is mandatory in nature to members of the HKIS, and shall be applied to the valuation reports prepared in respect of all properties to be included in any documents or to be used for any other purposes as referred to in the Standards and to all valuations where the valuation date is on or after the effective date. Through stringent compliance with the Standards, valuation services that are carried out by Corporate Members of the HKIS can be assured of the best quality and standards. Members would be advised to adopt the new Standards.

HKIS Joins International Ethics Standards Coalition

The Hong Kong Institute of Surveyors has joined a new international coalition that has developed the first set of globally-recognised ethics standards for real-estate, the built environment and related professional organisations.

The International Ethics Standards (IES) Coalition currently consists of over 120 member organisations with professionals working in a diverse range of countries.

Coalition Members, many of which already have their own codes of conduct focusing on qualities like trustworthiness, integrity and respect, will work together to align ethics principles through a new international standard.

The IES Coalition was first proposed during a meeting of a number of the founding organisations at the United Nations (New York) in October 2014.

The final International Ethics Standard was published in December 2016. More information and the standard can be seen at www.iescoalition.org.

HKIS Working Group on Green Building Results of Questionnaire Survey



- Help members to contribute more in Green Building




1. Membership status of respondents




2. Primary division of respondents




3. Ways respondents received formal training in Green Building




4. Respondents' current involvement in Green Building



Welcome Message from the BSD Chairman

Dear fellow surveyors, it is my pleasure to assume the chairmanship of the Building Surveying Division for 2017-2018. Coincidentally, it has been ten years since I joined the BSD Council. As announced in the New Chairman's message at the BSD annual general meeting (AGM), the BSD will focus on the following areas in the coming term.

External Affairs: Increase public recognition; communicate; and share up-to-date information with other professional institutes. public bodies, and trade associations.

Internal Affairs : Put together short training courses, increase a sense of belonging for members, set up a knowledge bank, attract associate members, initiate research, and employ the best practices and guidelines.

Sustainability of the BS Profession

: Establish a strategic foresight committee, explore BS job opportunities, and strengthen members' professional competence.

Voluntary Services for Community Housing Movement

Following the briefing session on 28 September regarding the voluntary services for the "Community Housing Movement" project, the BSD successfully recruited 78 BS volunteers to its BS volunteer Team (BSVT) to conduct preliminary condition surveys of potential domestic flats for the Hong Kong Council of Social Services

(HKCSS). The volunteers were grouped into 12 teams, each of which will be led by a senior BS member. A core team was also formed by BSD core members to oversee the project. Thanks go to Sr Peter Dy, the BSD Vice Chairman, for serving as the coordinator of this project.

Sr David Chan, Sr Kenneth Yun, Sr Peter Dy, Sr Billy Wong, and I conducted a trial inspection of several potential flats in To Kwa Wan on 6 December. A second briefing session was held on 11 December to discuss the project details, time schedule, and inspection techniques with volunteers. Special thanks go to BS master Sr David Chan, who kindly shared his technique in using surveying tools and the skills of building inspection during the briefing session. The first batch of flat inspections will occur in late December 2017 on some 70 units.

Joint Sharing Forum with **Guangdong Professional Institutes**

Our successful candidates under the CIREA-HKIS Reciprocity Examination recently obtained approval from the Ministry of Housing and Urban-Rural Development (住房城鄉建設部). A membership award ceremony conducted by both institutes and a review/outlook of the reciprocity arrangement and experience-sharing

Of these, 44 candidates (69%) passed the examination and will soon become GPD professional members. The pass rate exceeded that of the last assessment by 8%. Congratulations to these newest professional members and thanks go to all assessors for their support.

YSG Representatives in the GPD

I want to extend my warmest welcome to the YSG representatives in the GPD this year, Sr Kendy CHEUK and Sr Kitty NG. It is the second year in which Sr CHEUK has served as a YSG delegate to the GPD Council, which always encourages younger members to participate in its affairs and welcomes their views. We are also glad to see two previous YSG representatives, Sr Kirsten LAM and Sr David MUI, return to the GPD Council for this term. We look to them to echo the thoughts of the younger generation to the Council.

Executive Talk Series: Change is Forever How Should We Embrace Change in the Future? (Code: CPD 2017215)

Prof Mike Wong, JP, Deputy Managing Director of Sun Hung Kai Properties and Honorary Professor at HKU, delivered an Executive Talk entitled, "Change is Forever - How Should We Embrace Change in the Future?" on 17 November. Prof Wong began his talk by revealing a startling fact: most big corporations in the world do not last for decades, not to mention a century. He showed how fast sociotechnological environments change by providing many examples across the globe. Thus, an effective way to cope with change is to embrace

it because it has a profound implication on the real estate industry. Prof Wong referenced the development of many world class cities and the evolution of the vertical city in Hong Kong. He analysed Hong Kong's position in the context of the dynamic world, especially China, and concluded by listing the four principles that underpin the future development of mankind: Greener, Smarter, Cluster, and Together. Throughout the talk, Prof Wong referenced the literature on institutional economics, history, urban studies, etc., intensively. Afterwards, during the Q&A session, he shared with participants the importance of reading and work-life balance and how they influence his delivery of professional services to both the development industry and society.

Membership

Members have been told many times in this column that the LSD can only accept new corporate members if they have passed the Assessment of Professional Competence (APC). To offer corporate membership to any internationally renowned land surveying scholar or high-calibre government official, the HKIS would need to amend its Constitution. In fact, its administration has tried to do this, but has not yet received sufficient support from its members. It sees the APC as a necessary threshold mechanism for upholding the professional standards for admission.

Under the current settings, it is difficult for the LSD to continue expanding its professional realm by admitting related practitioners, such as utility surveyors, into its ranks. It would be nice to attract scholars or executives from the utility surveying industry as corporate members, but passing the APC is a must!

The LSD proposed a divisional revision of the APC Rules and Guide last September and this was accepted by the Board of Education. The LSD Rules and Guide would be amended to admit candidates who obtained membership in a cognate professional body and accumulated a suitable amount of post-qualification experience (i.e., three years for relevant degree holders, two years for cognate degree holders, etc.). A candidate can undertake the APC Assessments. which include the Part I Written Assessment and Part II Written Assessment (project submission) and Part II Assessment Interview, without undergoing structural training and submission of training records.

Hopefully this can attract experienced practitioners and scholars in related surveying fields to the LSD. The application form, APC-1/LS has been updated so that the option of applying for substitution of training experience by post-qualification experience is now available. Currently, the LSD Education Council has

adopted the RICS's post-qualification criteria. For the post-qualification criteria of other brother institutions, they will be considered on a case-bycase basis.

Hereby I record my heartfelt thanks to our colleagues in the Council and LSDEC, who jointly worked on this task for months and achieved its intended result.

Boundary

Sr Prof Leung Shou Chun will continue to lead the HKIS's Land Boundary Committee (LBC) in 2018. The LSD Chairman is the ex-officio Vice Chairman. The LSD also nominated Sr Joseph Wong and Sr Eric Tang to the LBC. Other HKIS Divisions may elect two members to the LBC, whose chairman may also invite members to join.

The LBC will continue discussions with the Lands Department on the effective procedure for determining lot boundaries. Sr Prof Leung has talked to Mr Thomas Chan, Director of Lands, about the land boundary issue during the HKIS's visit to the Lands Department last month. Mr Chan will formally discuss the issue with Sr Prof SC Leung at a meeting in 2018.

Smart City

The HKIS received a quick reply from the LSD on the Government Smart City Blueprint on 15 December. The LSD was asked to provide advice and comments on common spatial data infrastructure, which is a key part of a smart city. The Institute wants contributions from its practitioners in the fields related to spatial data infrastructure. CPD Events

I recorded my appreciation to Sr Yik Wai-fung, who has organised dozens of CPD events for LSD members this year. For 2018, the LSD has nominated four council members to arrange CPD events in their respective fields:

- 1. Sr Eric Tang Sze-kin: land boundary CPDs
- 2. Sr Tam Yiu-ming: GIS CPDs
- 3. Sr Li Tze-hoi: engineering surveying CPDs
- 4. Dr Zhang Hao-dong: new surveying science CPDs

Intermittently, when surveying specialist speakers are available, the LSD shall run a CPD after giving quick notice to its members.

Meanwhile, PolyU's Department of Land Surveying and Geo-Informatics (LSGI) is conducting a free massive open online course (MOOC) titled, "Introduction to Urban Geo-Informatics," in February 2018. It aims to 'demystify the area of urban geo-informatics' through a mix of animation and video recorded lectures. This course will be offered in English through the edX platform (www.edx.org) and Chinese through the XuetangX platform (www. xuetangx.com). It will cover the four major technologies of geo-informatics: 1) remote sensing; 2) geographic information systems (GIS); 3) navigation systems, which include global navigation satellite systems (GNSS) such as GPS and location-based services; and 4) underground surveying and mapping. It will also introduce students to modern urban environmental issues such as traffic, urban heat islands, and asset management, as well as present the geo-informatics technologies under the umbrella of smart cities, how these technologies retrieve data from the environment, and how they became the information relied on by decision-makers.

LSGI Professors, researchers, and experts in the field (including Prof Michael Batty, Prof Michael Goodchild, Prof Mei-Po Kwan, and many others)

will share their expertise through these videos and students can interact with not only the professors, but also with students outside Hong Kong. Over six weeks, the course will cover the basics of urban geo-informatics and the theories and history behind the technologies. It will include interactive discussions and test students' knowledge in the hope of piquing their interest in investigating further into the field.

While the course itself is free, for a fee of US\$50 students can have their attendance verified with a certificate issued by the course coordinator. For further information, check out its Facebook page (https://goo.gl/FVgU1f) or subscribe to its YouTube Channel (https://goo.gl/rBp67G).






Hong Kong-Guangdong Construction Industry Cooperation Seminar

Experience-Sharing on Land Resumptions in Urban Areas (24 November 2017)

YSG was pleased to invite Sr Edward Au to deliver the final CPD event of 2017. The following course content was discussed:


- 1. What is resumed & why perform resumptions?
- 2. Protection of Property Rights
- 3. Acquisition of Land by the Government
- 4. Resumption under the Ordinance and Lease
- 5. Head of Claims Due to Land Resumption
- 6. Compensation Principles
- 7. Disturbance Compensation
- 8. Ex-gratia Compensation

Sr Au shared his invaluable experience in land resumptions in Hong Kong. He briefed us on the situations in which the government may gazette a resumption notice. For example, it can issue a gazette notice to resume a land parcel due to the construction of the Tseung Kwan O-Lam Tin Tunnel. Any person can make a written claim to the Government. Members learnt that the acquisition of land by the government mainly stems from a resumption of negotiations, a resumption under the terms of a lease, or resumption by statute.

Sr Au added that compensation claims must meet three basic conditions: a loss claimed due to resumption, one claimed that cannot be too remote from the cause, and if a claimant tried to mitigate the loss. The assessment of claim heads must be under Ordinance Caps.124, 370, and 519, as well as common law principles.

During the ensuing Q&A session, audience members shared the difficulties they encountered in their projects and sought Sr Au's advice. He explained the considerations and criteria of the District Land Offices under different situations.
